
Enclosed, please find Matsushita Electric Industrial Co., Ltd.'s application for equipment authorization dated November 26, 1999. This device was originally granted on February 16, 1999 in compliance with Part 15, Subpart B of the FCC Rules.

The subject device was originally reported as bi-directional dot-matrix impact printer with parallel and serial interface ports for single port only connection to host PC. This printer contains switching power supply that operates at 80 kHz and CPU at 16 MHz clock oscillator.

This Class II Change is to report: (1) re-layout of components on secondary printed circuit wiring board with no change to any frequency determining circuitry; (2) delete ferrite core on control panel; and (3) delete two ferrite cores on inlet lead - refer to attached photographs. The FCC label, product marking, block diagram and user information in the Operating Instructions remains unchanged. The attached system test data was system generated in serial and parallel port configurations and in accordance with ANSI C63.4-1992 to show compliance with FCC Part 15 Class B limits.
