The EUT was a Wireless module and LTE.


# 2.2. MEASURING INSTRUMENT CALIBRATION

#### 3.2 RADIATED POWER

### **Test Overview**

Radiated tests are performed in the Fully-anechoic chamber.

The equipment under test is placed on a non-conductive table 3-meters away from the receive antenna in accordance with ANSI/TIA-603-E-2016 Clause 2.2.17.

# **Test Settings**

- 1. Radiated power measurements are performed using the signal analyzer's "channel power" measurement capability for signals with continuous operation.
- 2. RBW = 1 5 % of the expected OBW, not to exceed 1 MHz
- 3. VBW  $\geq$  3 x RBW
- 4. Span = 1.5 times the OBW
- 5. No. of sweep points > 2 x span / RBW
- 6. Detector = RMS
- 7. Trigger is set to "free run" for signals with continuous operation with the sweep times set to "auto".
- 8. The integration bandwidth was roughly set equal to the measured OBW of the signal for signals with continuous operation.
- 9. Trace mode = trace averaging (RMS) over 100 sweeps
- 10. The trace was allowed to stabilize

#### **Test Note**

- 1. The turntable is rotated through 360 degrees, and the receiving antenna scans in order to determine the level of the maximized emission.
- 2. A half wave dipole is then substituted in place of the EUT. For emissions above 1 GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator and the previously recorded signal was duplicated.

The power is calculated by the following formula;

Where: P<sub>d</sub> is the dipole equivalent power and P<sub>g</sub> is the generator output power into the substitution antenna.

3. The maximum value is calculated by adding the forward power to the calibrated source plus its appropriate gain value.

These steps are repeated with the receiving antenna in both vertical and horizontal polarization. the difference between the gain of the horn and an isotropic antenna are taken into consideration

- 4. The EUT was tested in three orthogonal planes(X, Y, Z) and in all possible test configurations and positioning.
- 5. All measurements are performed as RMS average measurements while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies.

#### 3.3 RADIATED SPURIOUS EMISSIONS

#### **Test Overview**

Radiated tests are performed in the Fully-anechoic chamber.

Radiated Spurious Emission Measurements at 3 meters by Substitution Method according to ANSI/TIA-603-E-2016.

### **Test Settings**

- 1. RBW = 100 kHz for emissions below 1 GHz and 1 MHz for emissions above 1 GHz
- 2. VBW  $\geq$  3 x RBW
- 3. Span = 1.5 times the OBW
- 4. No. of sweep points > 2 x span / RBW
- 5. Detector = Peak
- 6. Trace mode = Max Hold
- 7. The trace was allowed to stabilize
- 8. Test channel: Low/ Middle/ High
- 9. Frequency range: We are performed all frequency to 10th harmonics from 9 kHz.

### **Test Note**

- Measurements value show only up to 3 maximum emissions noted, or would be lesser
  if no specific emissions from the EUT are recorded (ie: margin > 20 dB from the applicable limit)
  and considered that's already beyond the background noise floor.
- 2. The EUT was tested in three orthogonal planes(X, Y, Z) and in all possible test configurations and positioning. The worst case emissions are reported with the EUT positioning, modulations, RB sizes and offsets, and channel bandwidth configurations shown in the test data
- 3. For spurious emissions above 1 GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator and the previously recorded signal was duplicated.

The spurious emissions is calculated by the following formula;

Result (dBm) = Pg (dBm) - cable loss (dB) + antenna gain (dBi)

Where: P g is the generator output power into the substitution antenna.

If the fundamental frequency is below 1 GHz, RF output power has been converted to EIRP.


# 5. MEASUREMENT UNCERTAINTY


