






Photograph of the Tissue Simulant Fluid Liquid Depth


















Fig.3 EUT Back side to flat phantom






Fig.4 EUT Top side to flat phantom






Fig.5 EUT Bottom side to flat phantom




Fig.6 EUT Right side to flat phantom






Fig.7 EUT Left side to flat phantom




Fig.10 EUT Bottom side (Landscape scanner) to flat phantom






Fig.11 EUT Bottom side (Portrait scanner) to flat phantom




Fig.12 EUT Left side (Landscape scanner) to flat phantom






Fig.13 EUT Left side (Portrait scanner) to flat phantom




Fig.15 EUT Back side(Hand Strap 12U) to flat phantom






Fig.16 EUT Back side(Hand Strap 13U) to flat phantom




Fig.17 EUT Bottom side(Hand Strap 11U) to flat phantom






Fig.18 EUT Bottom side(Hand Strap 12U) to flat phantom






Fig.19 EUT Bottom side(Hand Strap 13U) to flat phantom




Fig.20 EUT Left side(Hand Strap 11U) to flat phantom






Fig.21 EUT Left side(Hand Strap 12U) to flat phantom




Fig.23 EUT Back side to flat phantom






Fig.24 EUT Top side to flat phantom




Fig.36 Antenna position of EUT
