- 5. The operation of the EUT:
  - When power on, the EUT will scan the whole frequency until a Connection command from the other BT device.
  - b. When receiving the signal from the other BT devices, The EUT transmit are sponse signal.
  - c. The other devices receive the response signal and recognize it, then send a connection command to establish the connection.
  - d. After the connection establish successfully, the data transmission is beginning. At the same time, the both devices will shift frequencies in synchronization per a same pseudo randomly ordered list of hopping frequencies, the hopping rate is 1600 times per second. This device conforms to the criteria in FCC Public Notice DA 00-705.
  - e. The bandwidth of receiver, which is set to fixed width by the software.



4.1.1 Limits of Radiated Emission and Bandedge Measurement

### 4.1.3 Test Procedures

#### For Radiated emission below 30MHz

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. Both X and Y axes of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Quasi-Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.

### NOTE:

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 9kHz at frequency below 30MHz.

## For Radiated emission above 30MHz

- a. The EUT was placed on the top of a rotating table 0.8 meters (for 30MHz ~ 1GHz) / 1.5 meters (for above 1GHz) above the ground at 3 meter chamber room for test. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to quasi-peak detect function and specified bandwidth with maximum hold mode when the test frequency is below 1 GHz.
- f. The test-receiver system was set to peak detect function and specified bandwidth with maximum hold mode when the test frequency is above 1 GHz.

### Note:

- The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Quasi-peak detection (QP) at frequency below 1GHz.
- 2. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 3 MHz for Peak detection (PK) at frequency above 1GHz.
- 3. For Average measurement, due to the DH5 packet was the worse case duty cycle for a transmit dwell time on a channel, based upon bluetooth theory the transmitter is on 0.625 \* 5 per 296.25 ms per channel. Therefore, the duty cycle correlation factor be equal to: 20log(3.125 / 100)= -30.1 dB, therefore Average value = peak reading + 20log(duty cycle).
- 4. All modes of operation were investigated and the worst-case emissions are reported.







# For Radiated emission below 30MHz




# For Radiated emission 30MHz to 1GHz


- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
