1. When we ship the handset, battery pack and battery cover are not attached to the handset, and our customer will see the FCC ID label at the time of purchase. The attached file is an example of label.
7. EUT will not be connected to a pc in the States, though the USB connector is provided, which will be used only in Japan, where PAM, or phone as modem, is supported by KDDI.

Thank you for your response to the referenced application. Please see below follow-up question pertaining to your submittal.

Follow-Up RT:

1. We note, however, that you did not respond to questions 1 and 7 (copied below). Please respond to these questions. All that the FCC requires for the first is a statement from the manufacturer that, since the EUT will be marketed without the battery and battery compartment door installed, the FCC ID label will be clearly visible at the time of purchase. For question 7, if the EUT cannot connect to a pc, please state that. If it can, please inform us if that portion of the EUT (pc peripheral) will be authorized under DoC, and submit the new FCC ID label showing the FCC DoC logo. Or, if you prefer to authorize it under Certification, please inform PCTEST, so that they can generate the required test report.

1. Please verify that the FCC ID label will be visible at the time of purchase, as required.

7. Does the EUT connect to a pc? We note that the user's manual references an External Connector, and the block diagram shows USB function. If it does, then it is also a pc peripheral, subject to either DoC or Certification. Please address.

The items indicated above must be submitted before processing can continue on the above referenced application.
