In order to ensure this distance is met, the installation of the antenna must be mounted at least 41 centimeters (17 inches) away from the nearest edge of the vehicle in order to protect against exposure to bystanders.

 Transmit only when people outside the vehicle are at least the recommended minimum distance of 136 centimeters (54 inches) away from the properly installed antenna. This separation distance will ensure that there is sufficient distance from a properly installed externally-mounted antenna to satisfy the RF exposure requirements in the applicable RF exposure

 3. IC-F6330D:
 Transmit only when people outside the vehicle are at least the recommended minimum distance of 117 centimeters (47 inches) away from the properly installed antenna.
