3.2 TEST PROCEDURE

1. The EUT was operating in Tx mode.
2. The EUT uses an Printed Antenna, the antenna gain of 2 dBi is declared by the manufacturer.

$$S = PG / 4 \pi R^2$$

Where: S = power density

P = power input to antenna

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna

3.3 EUT OPERATING CONDITION

1. Setup the EUT and all peripheral devices .
2. Turn on the power of all equipment and EUT.
3. Set the EUT under continuous transmission condition mode.
4. The EUT was set to the highest available power level.
