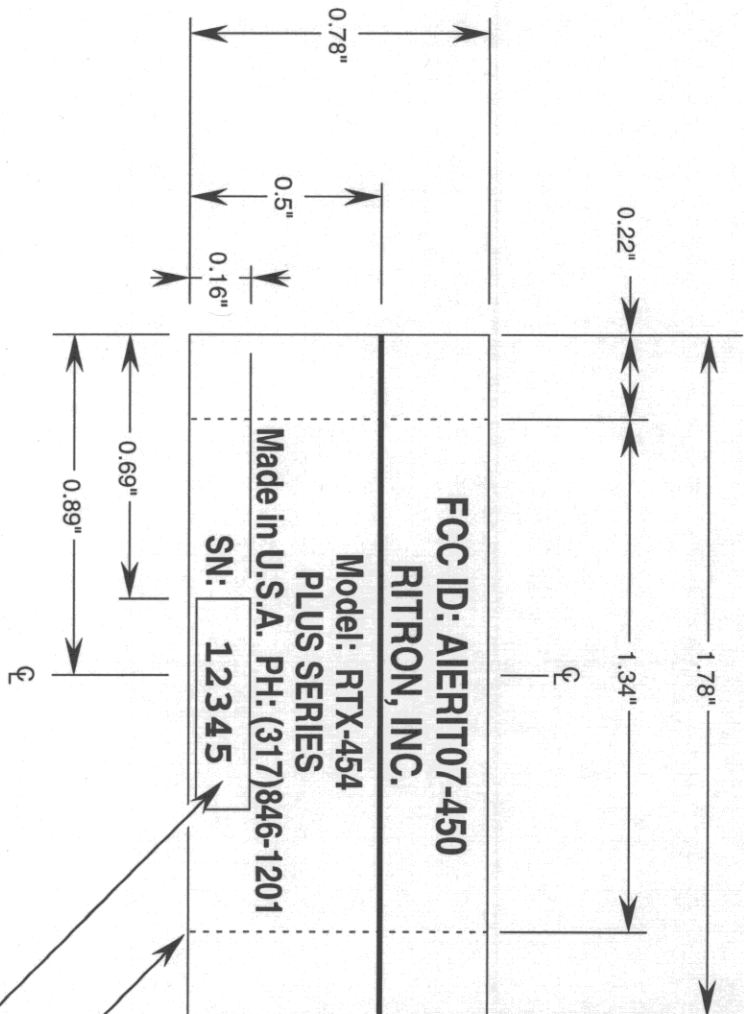
The label is made of "Tamper Proof" destructive mylar material or equivalent, backed with a "High Tack" adhesive. A melamine overcoat will be used for durability.

The label will have silver graphics on a black background. The Serial Number area will be silver with black numbers. The Serial Numbers will start at 12345.

The finished size of the label will be 1.78" X 0.78".
