

A photograph is included to indicate the position of the label on the case back. Each serial number is recorded along with the date of manufacture and is kept on file at RITRON, Inc.

The FCC data label will be made of a "tamper proof" destructive, .002" thick silver mylar material laminated to .003" Lexan film with Hi-Tack adhesive backing. The label background will be black with all graphics in silver. The area containing the FCC ID designator will be silver with black graphics. A 2nd small label of the same material will contain the manufacture date.

Serialization will begin with the serial number A1234. The combined size of the serial label and manufacturing date label is 2.979" x 0.980".


