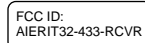

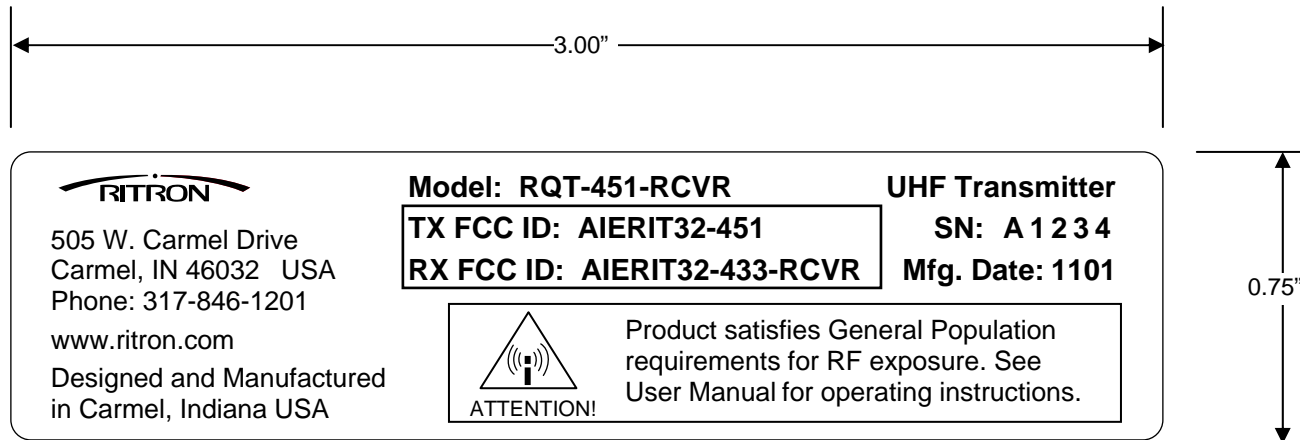


FCC LABEL DRAWING

Photographs indicating label locations are submitted as a separate exhibit.

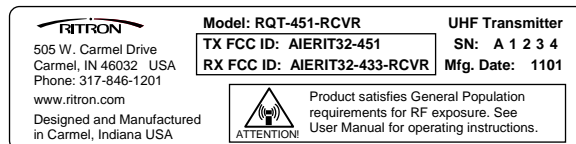

NOTES:

1. The FCC serial label will be made in house per this specification drawing for all models listed in the table at right.
2. A Brady IP300 thermal transfer printer will be used with glossy white polyester labels (RTN# 14290011). Identco Z-TT700 CUSTOM, a 3 inch by 0.75 inch label, is the approved material. The approved thermal transfer ribbon is Brady 4300 Series.
3. Labels will be numbered sequentially, with an initial 5-digit number of A1234. Records are maintained to track the next available serial number. All models listed share the same serial sequence, and are identical except for model identification.
4. Each label will contain an updated Manufacturing Date using the Ritron 4-digit Date Code (YEAR/MONTH).
