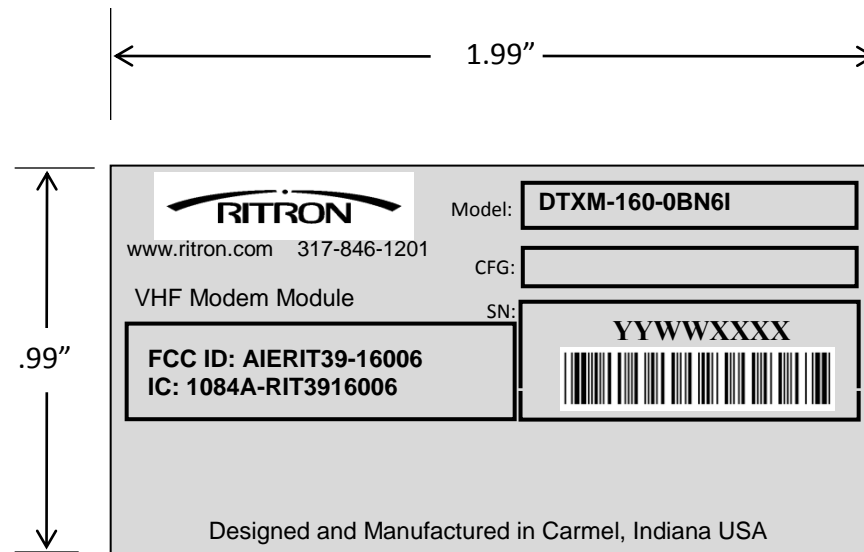

1. MATERIAL MATTE SILVER POLYESTER WITH PERMANENT ADHESIVE.
2. SERIAL NUMBER FORMAT: TWO DIGIT YEAR(Y) PLUS TWO DIGIT WEEK(WW) OF MANUFACTURE PLUS A FOUR DIGIT NUMBER (XXXX) THAT IS UNIQUE TO THE YYWW PREFIX.
3. MODEL SHOULD BE POPULATED WITH THE MODEL OF THE PRODUCT BEING ASSEMBLED.
4. CFG SHOULD BE POPULATED FOR PRODUCTS THAT VARY FROM THE BASE MODEL.
5. ALL TYPE FONTS ARE TO BE HELVETICA TYPE STYLE.
6. THE FCC ID: AND IC: NUMBERS WILL BE PRINTED WITH THE APPROPRIATE NUMBERS FOR THE SELECTED MODEL.
