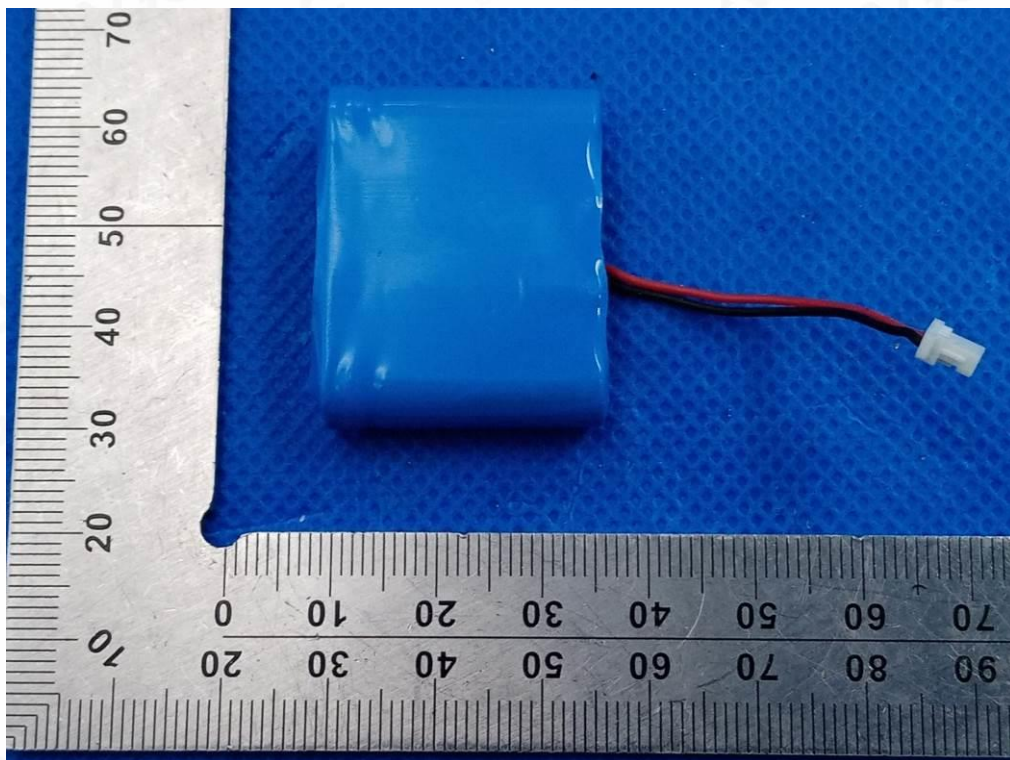

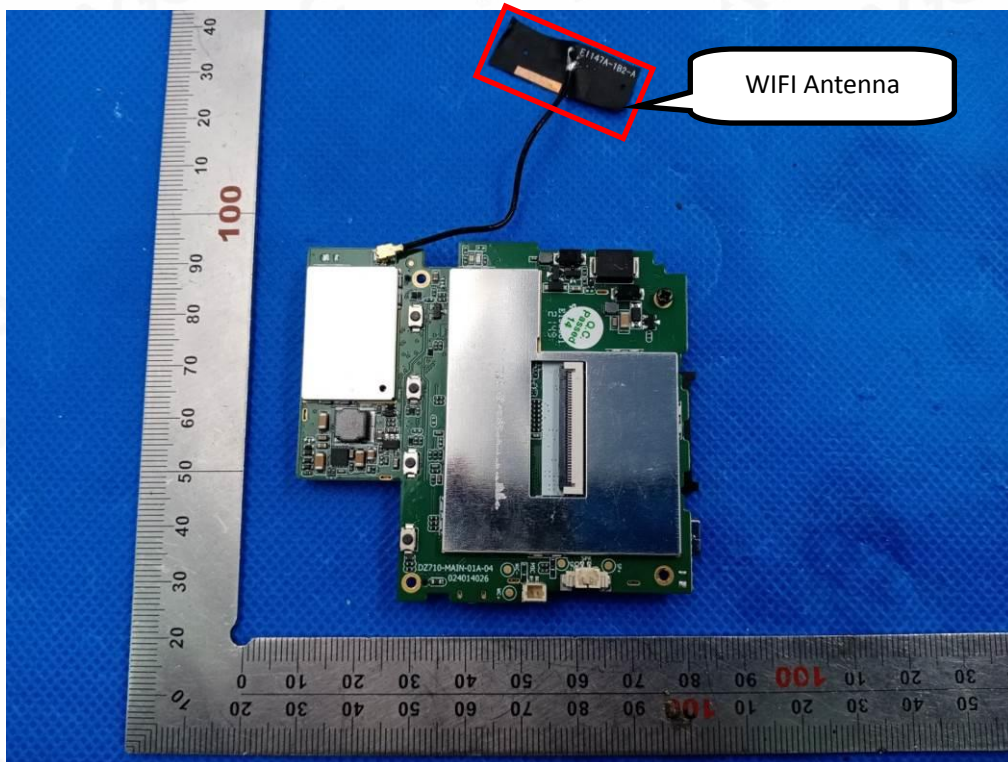

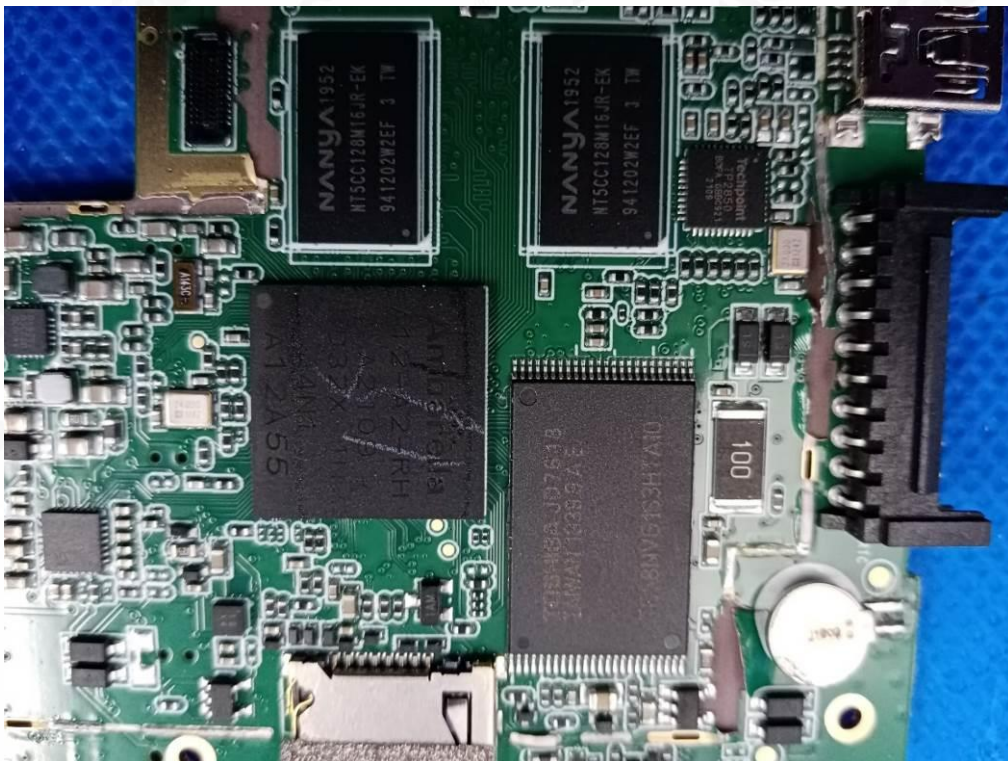

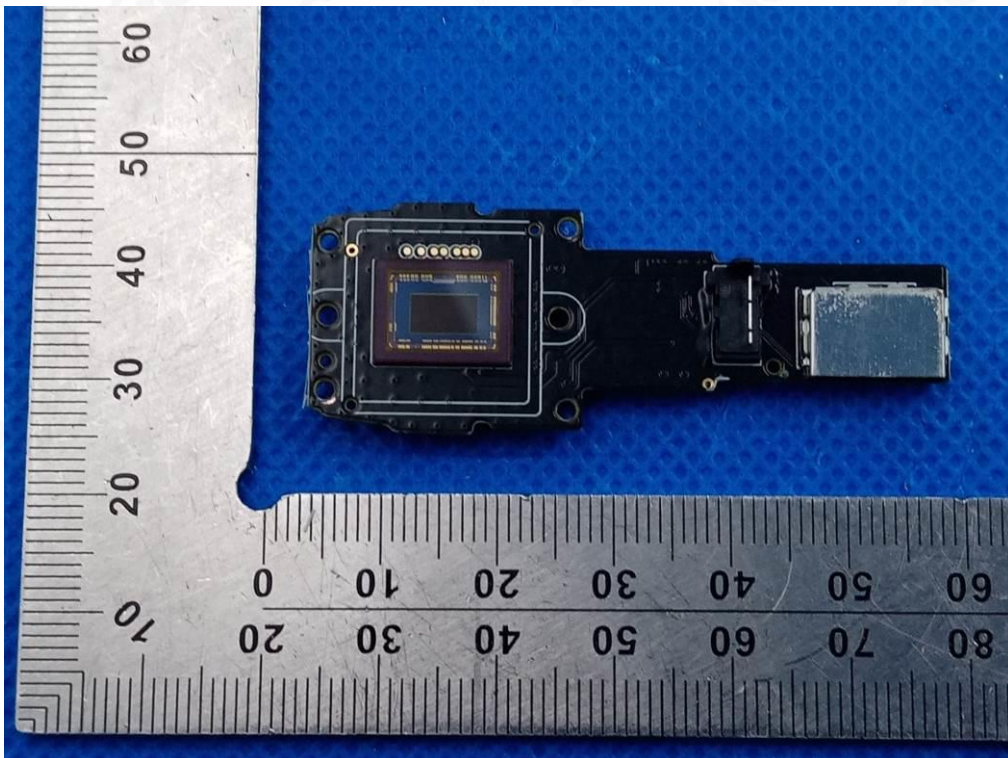

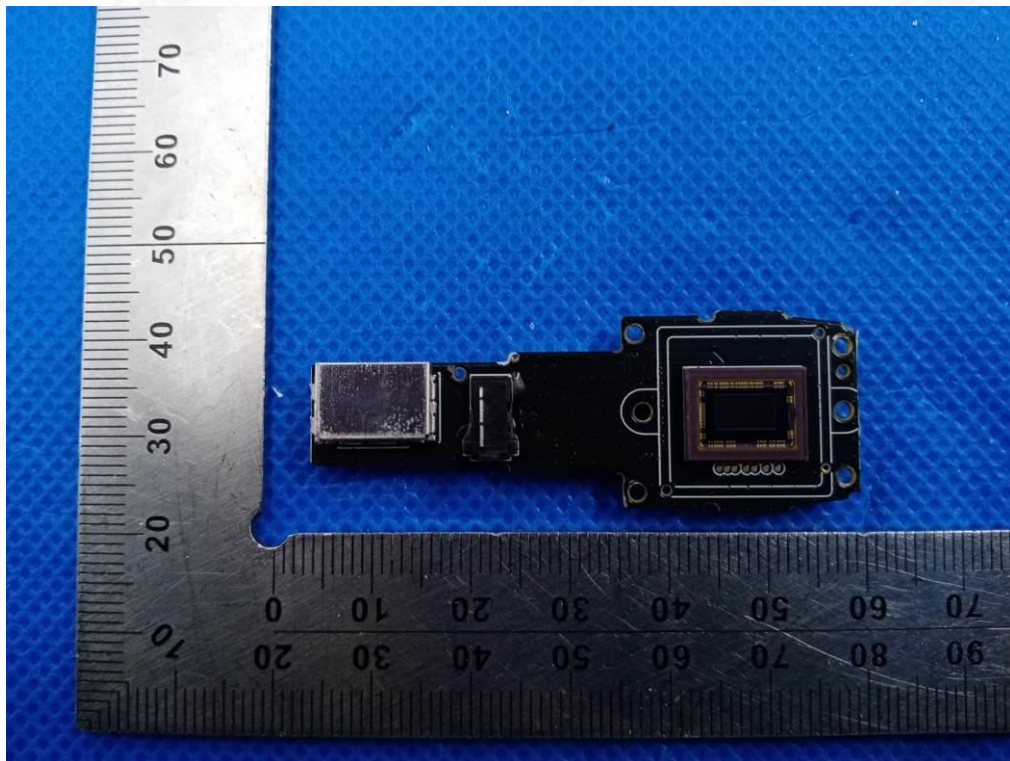




INTERNAL VIEW OF EUT (FIGURE 10)

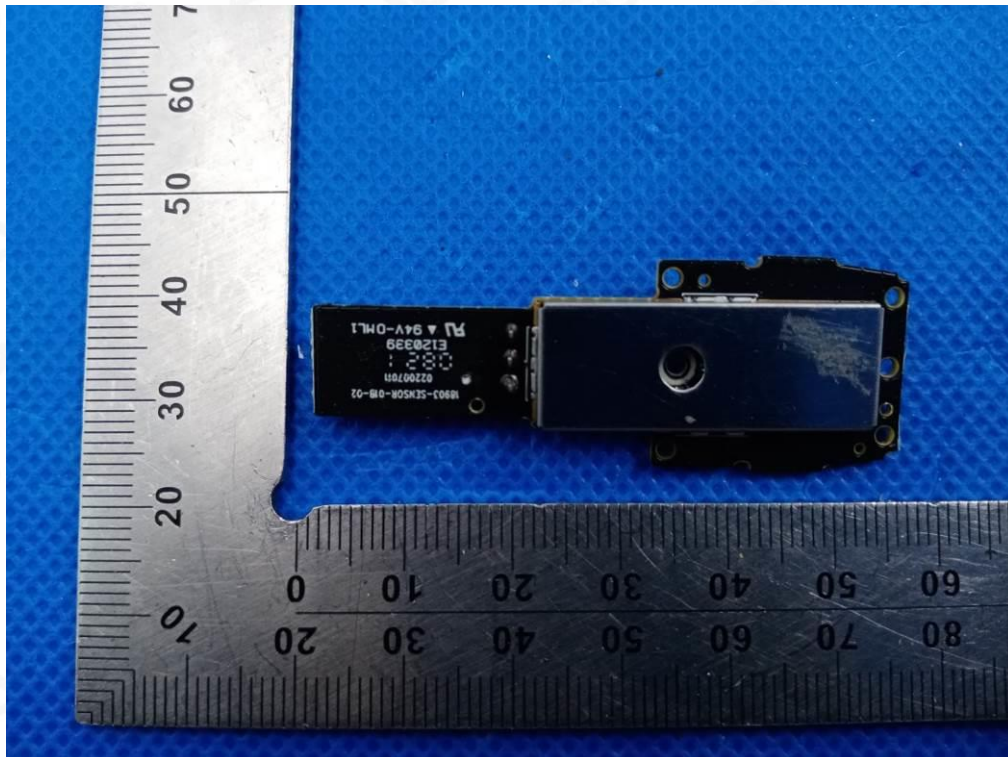

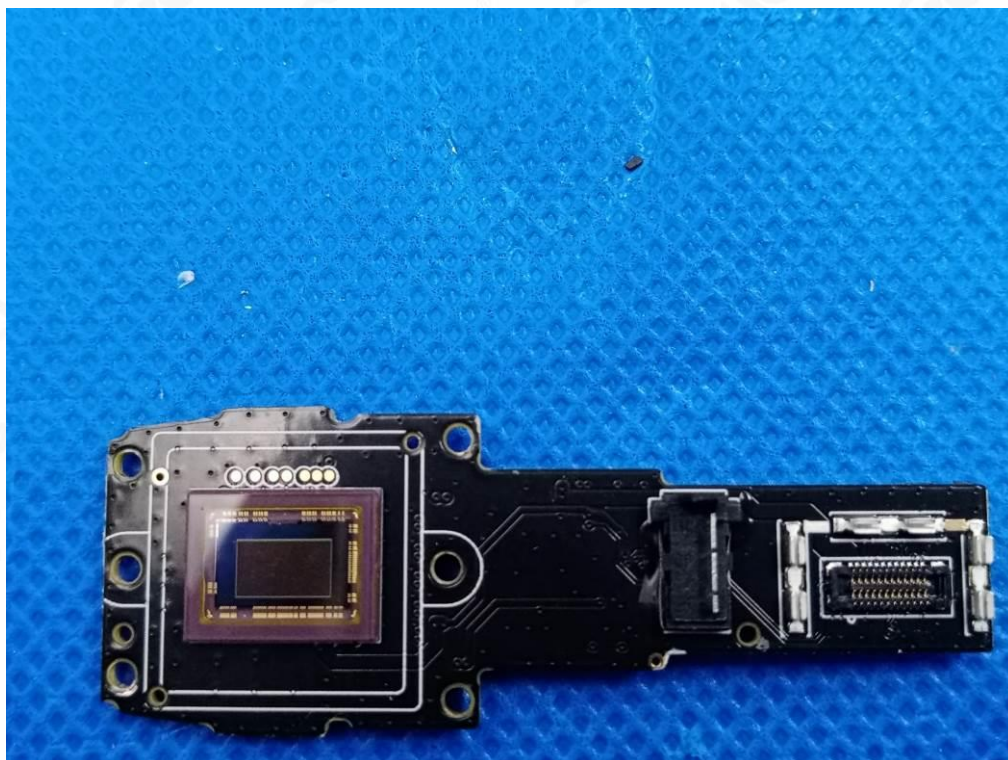




INTERNAL VIEW OF EUT (FIGURE 12)

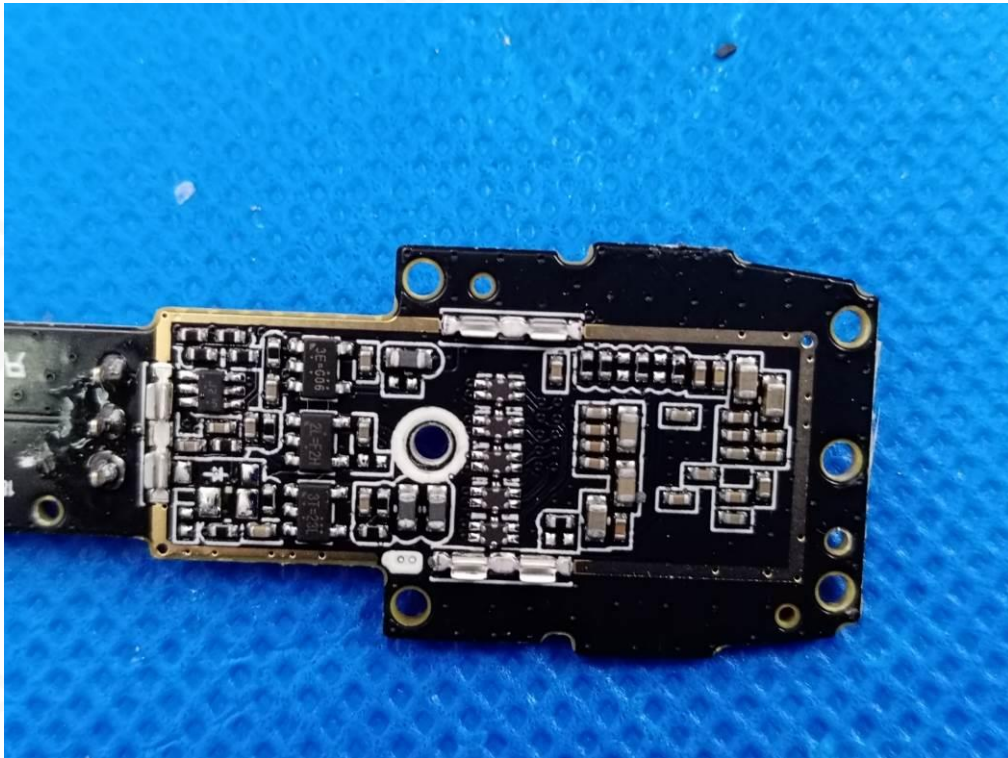

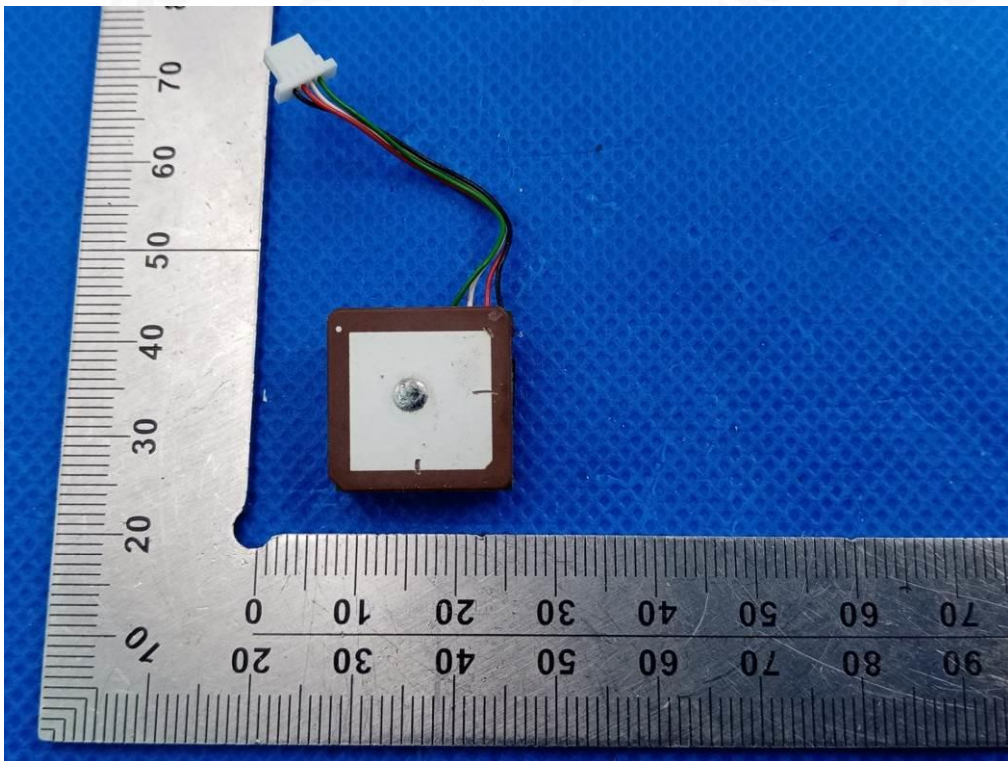




INTERNAL VIEW OF EUT (FIGURE 14)

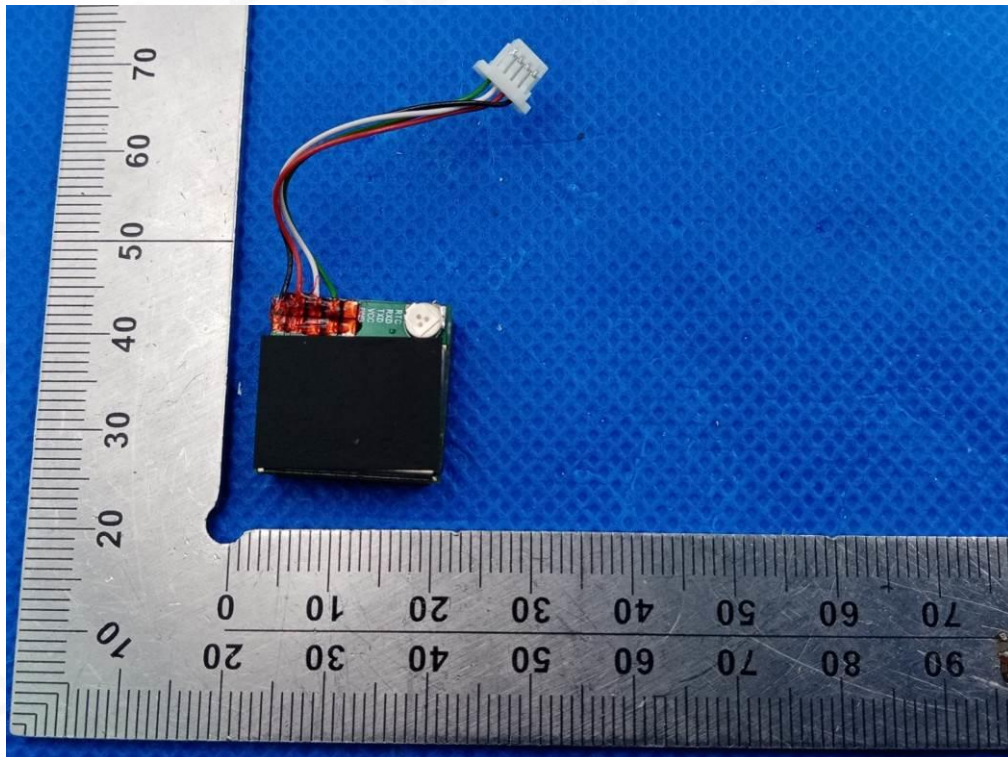

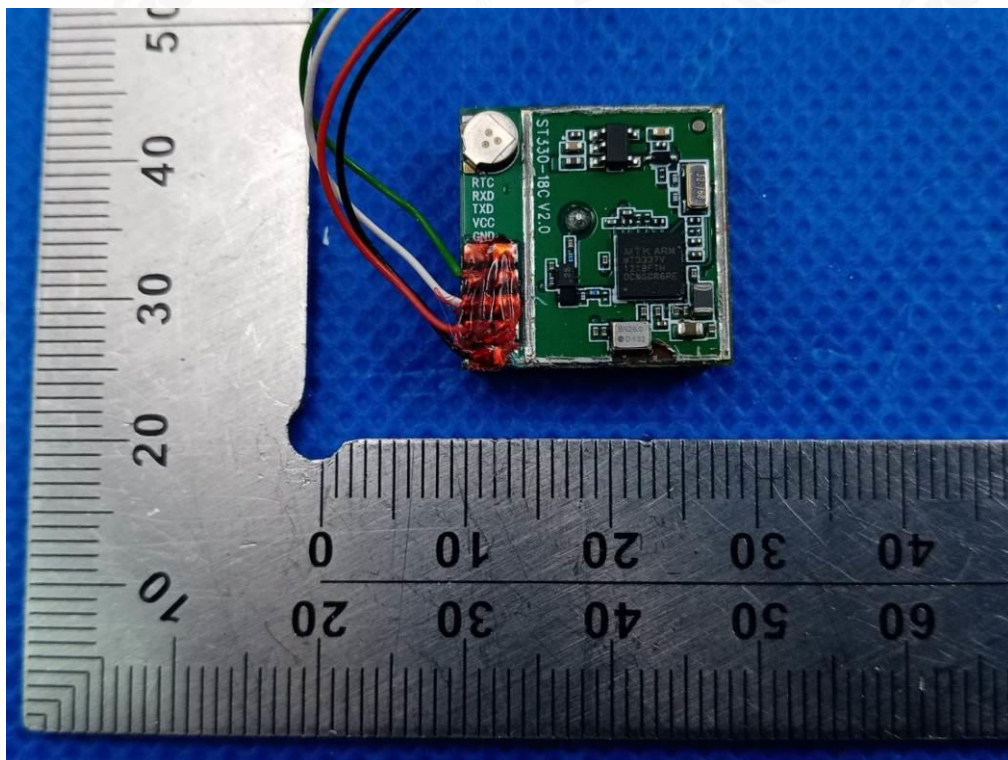




INTERNAL VIEW OF EUT (FIGURE 16)

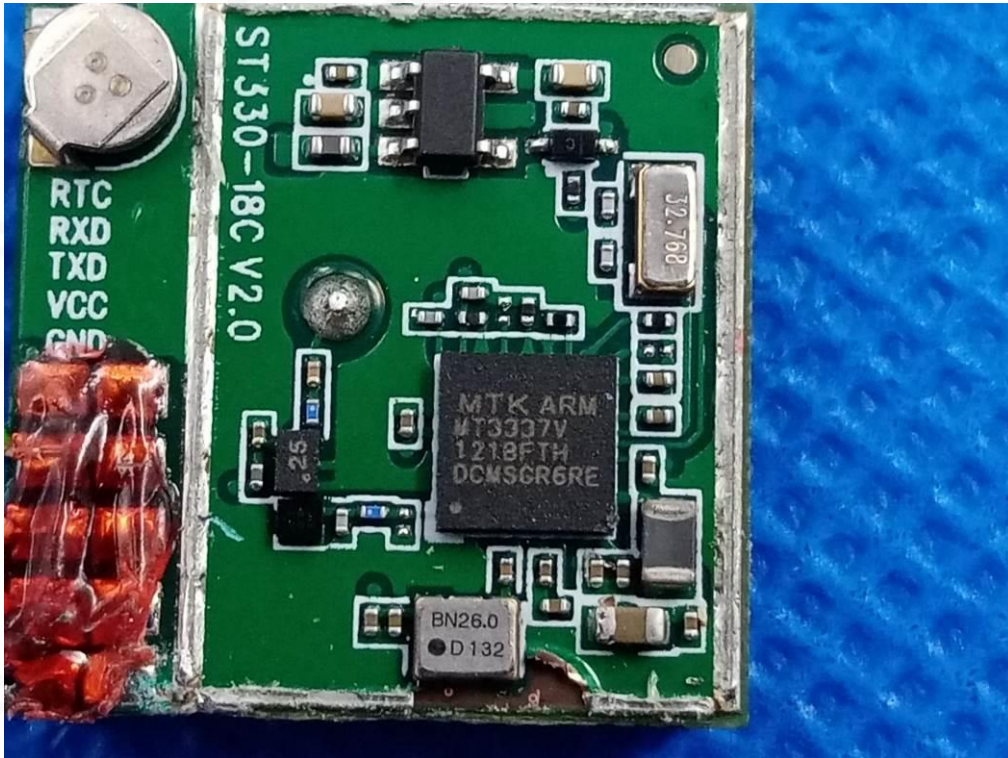

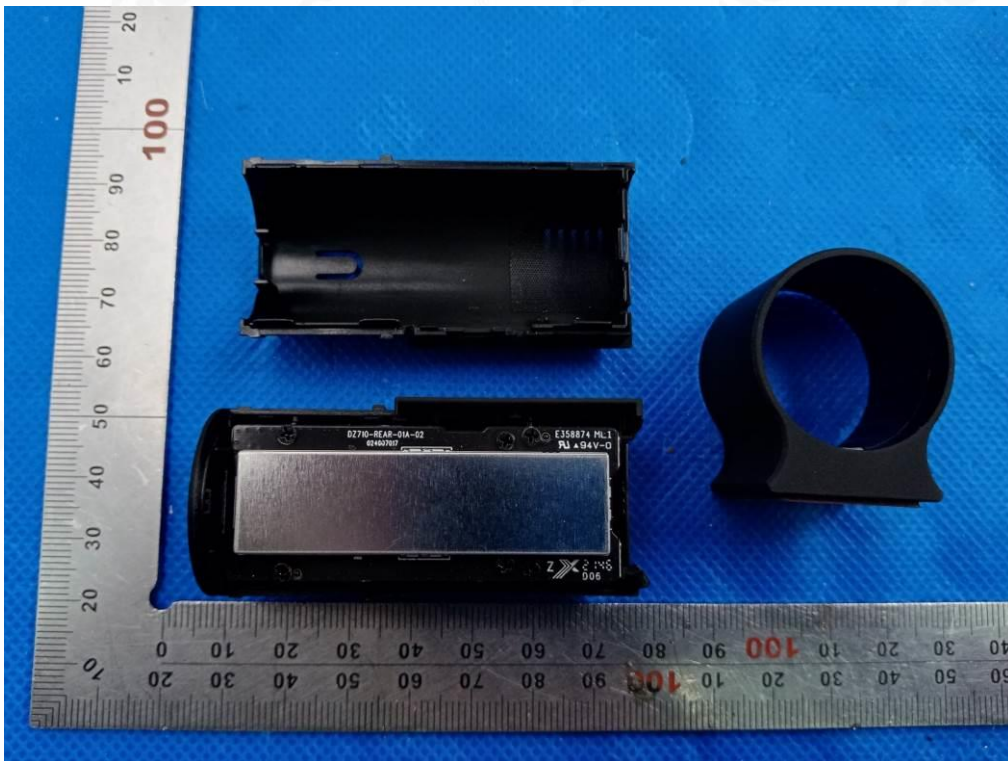




INTERNAL VIEW OF EUT (FIGURE 18)

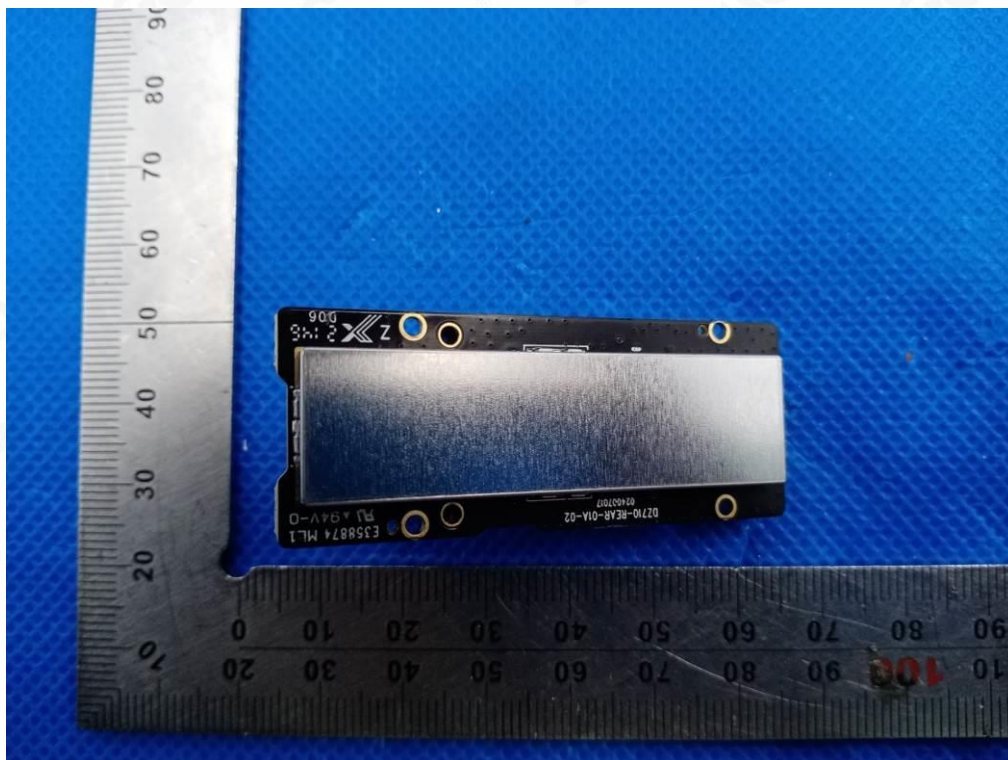

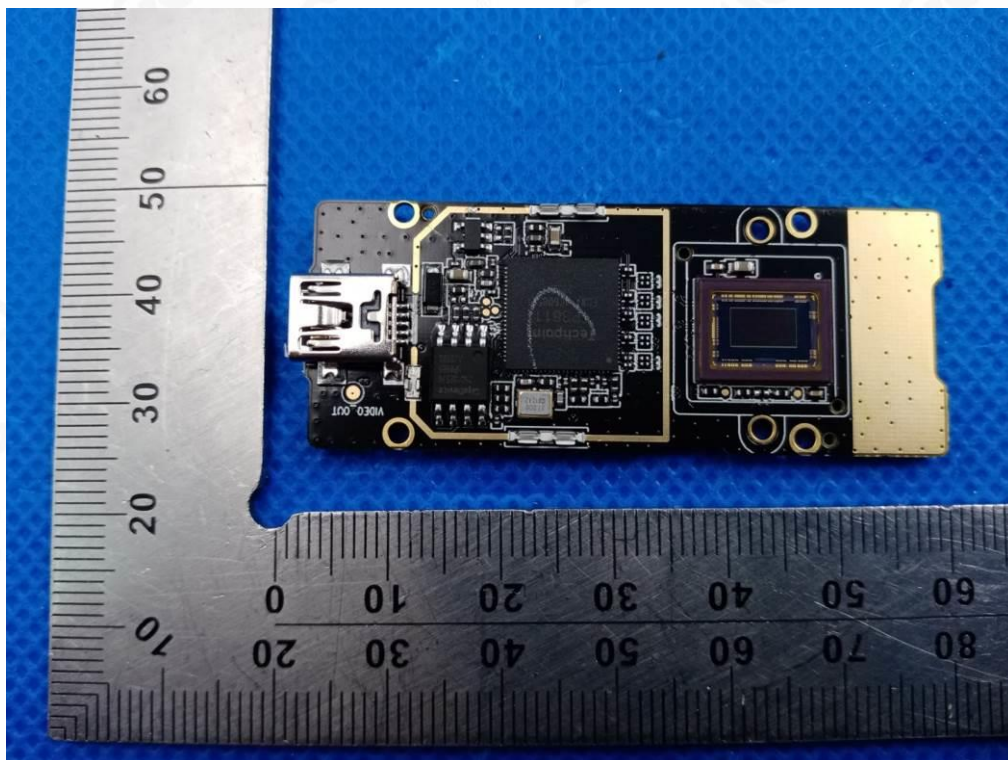

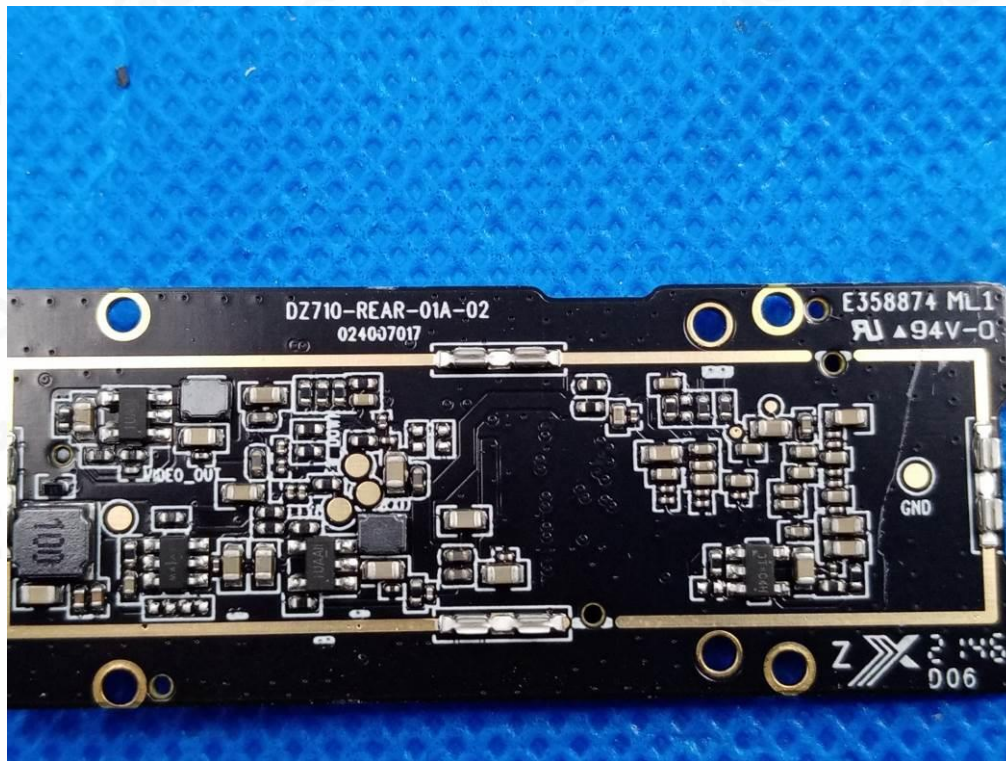
