2.2. Calculation method

 Power Density: $S(mW/cm^2) = \frac{E^2}{377}$

E = Electric field (V/m)

P = Peak RF output power (mW)

G = EUT Antenna numeric gain (numeric)=

d = Separation distance between radiator and human body (m)

The formula can be changed to

We can change the formula to:

$$S = \frac{30 \times P \times G}{377 \times d^2}$$
 or, $d = \sqrt{\frac{30 \times P \times G}{377 \times S}}$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2 m, as well as the gain of the used antenna, the RF power density can be obtained.
