

### FCC ID: AK8M20DAL1

To whom it may concern,

We, UL Japan, Inc, hereby declare that Wireless communication module, model: AW-XM501 (FCC ID: AK8M20DAL1) of Sony Interactive Entertainment Inc. is exempt from RF exposure SAR evaluation because the available maximum time-averaged power or effective radiated power (ERP), whichever is greater, is less than or equal to the threshold  $P_{th}$  (mW) described in the following formula according to the Code of Federal Regulation title 47 section 1.1307(b)(3)(i)(B). This method is used at separation distances *d* (cm) from 0.5 centimeters to 40 centimeters and at frequencies from 0.3 GHz to 6 GHz (inclusive) for single RF sources.  $P_{th}$  is given by:

$$P_{th} (\text{mW}) = \begin{cases} ERP_{20 \text{ cm}} (d / 20 \text{ cm})^x & d \le 20 \text{ cm} \\ ERP_{20 \text{ cm}} & 20 \text{ cm} < d \le 40 \text{ cm} \end{cases}$$

Where

$$x = -\log_{10}\left(\frac{60}{ERP_{20} \operatorname{cm}\sqrt{f}}\right) \text{ and } f \text{ is in GHz}$$

 $ERP_{20 \text{ cm}} \text{ (mW)} = \begin{cases} 2040f & 0.3 \text{ GHz} \le f < 1.5 \text{ GHz} \\ 3060 & 1.5 \text{ GHz} \le f \le 6 \text{ GHz} \end{cases}$ 

When the minimum separation distance is shorter than 0.5 cm, 0.5 cm is applied.

The SAR evaluation exemption threshold is calculated as below.
