

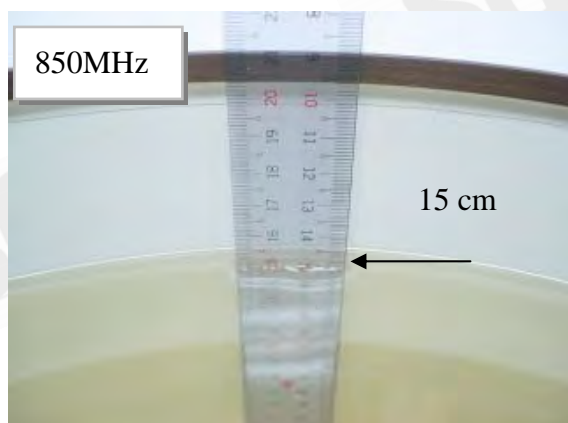

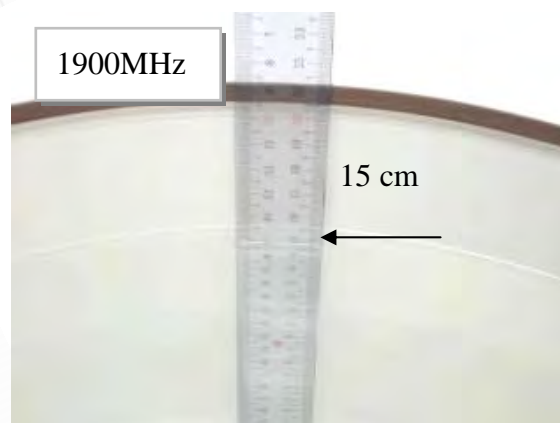


**Fig.1 Photograph of the SAR measurement System**

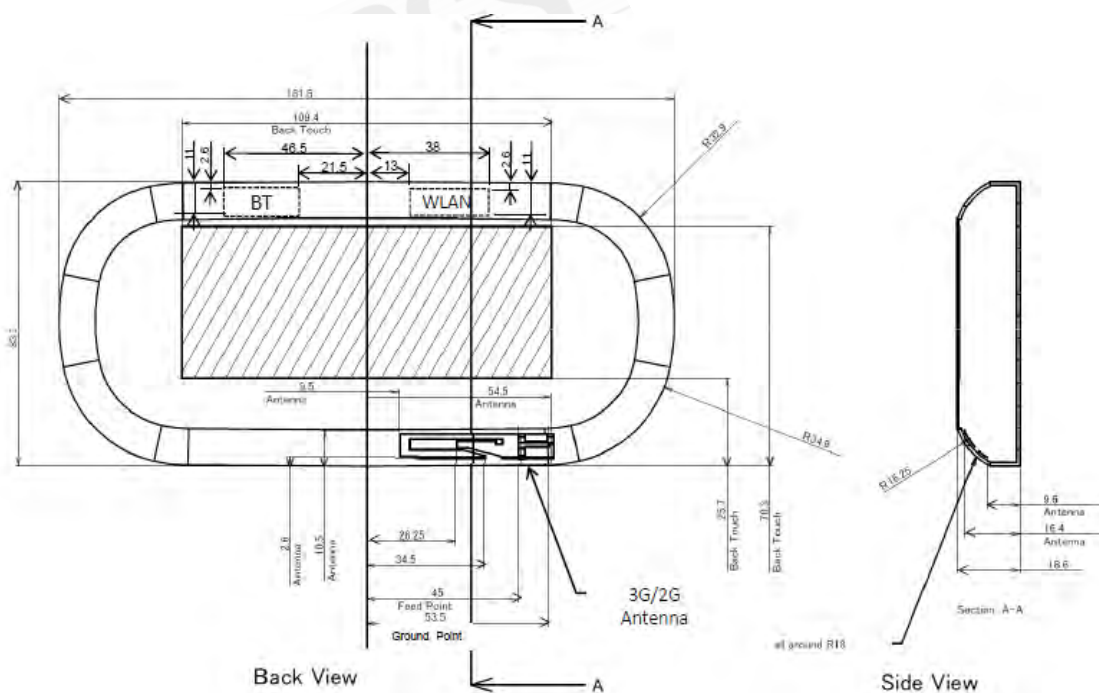
Fig.9 Front view of device
