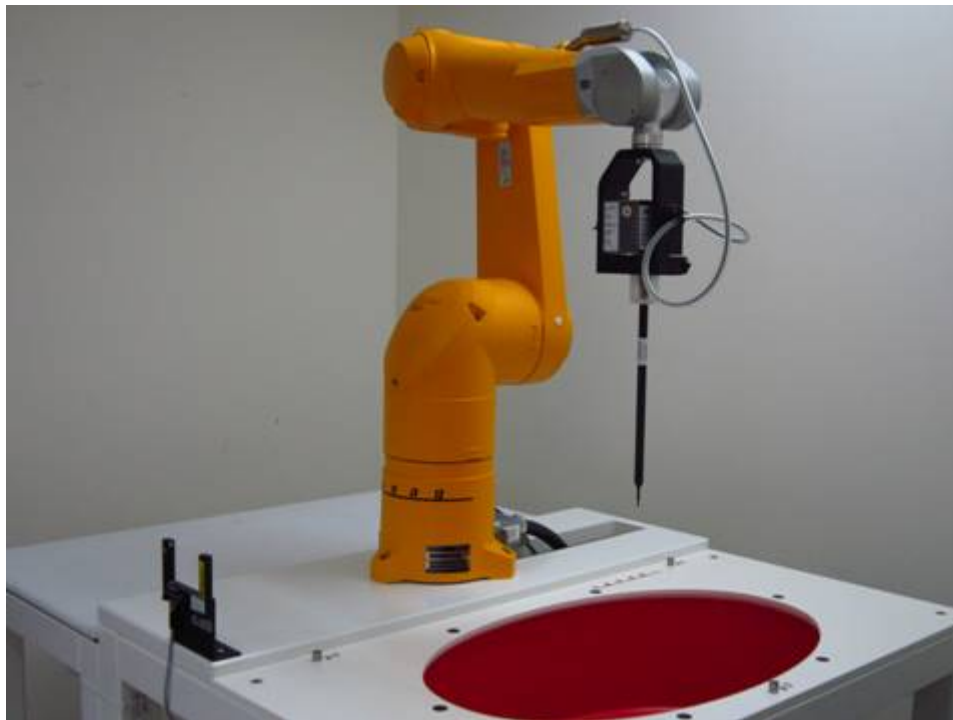


Fig.1 Photograph of the SAR measurement system

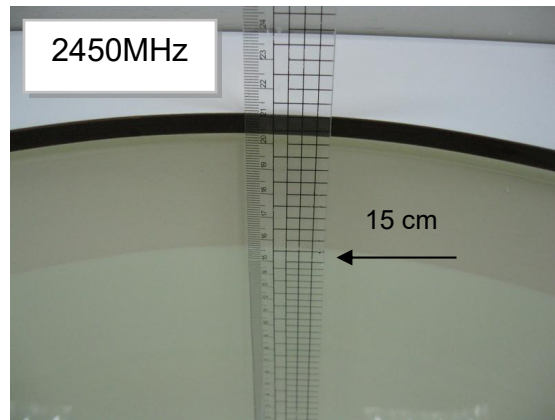
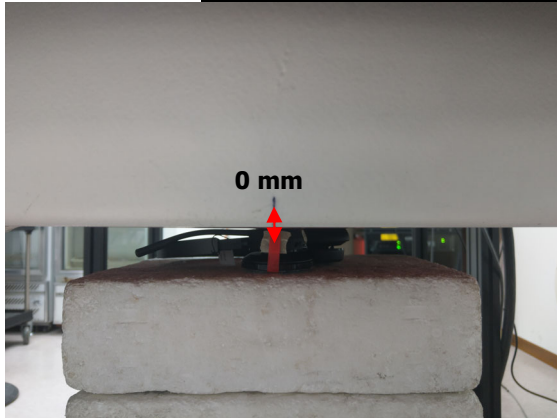

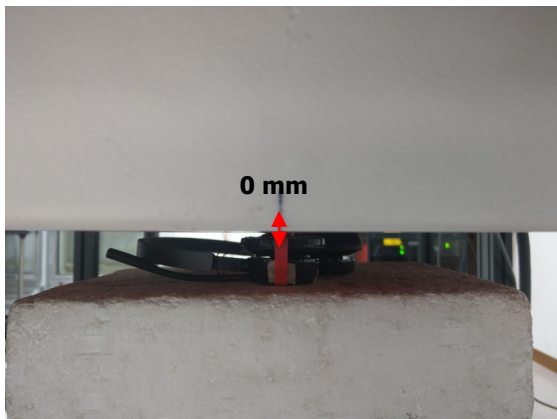

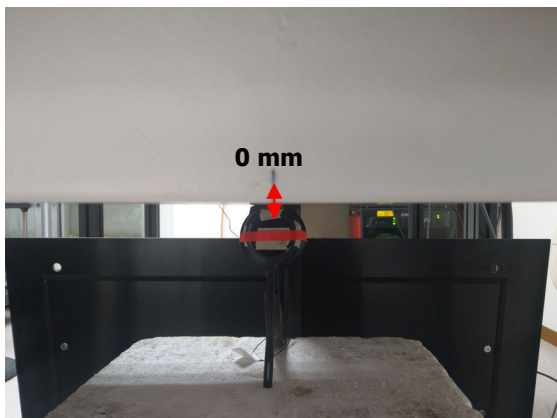

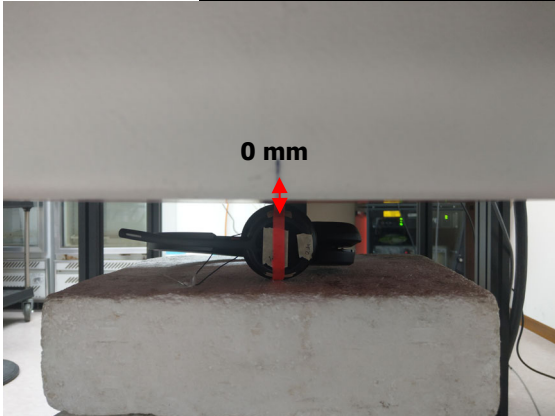

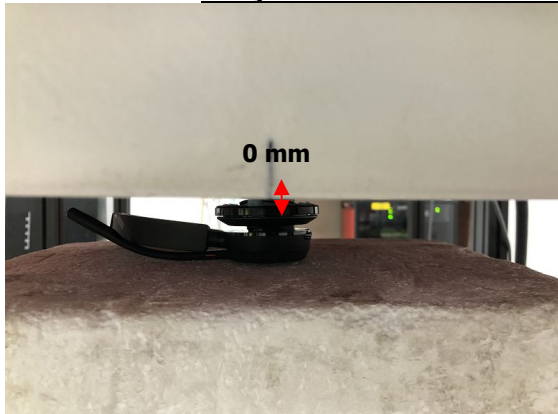

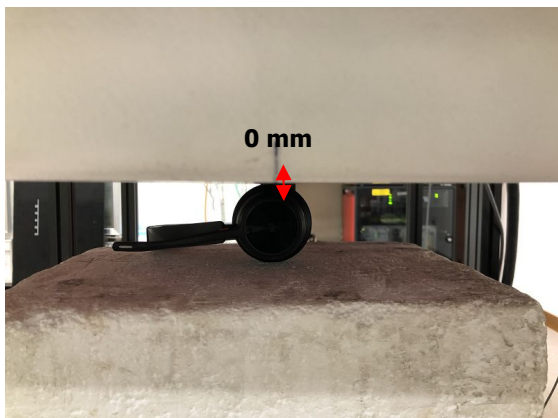

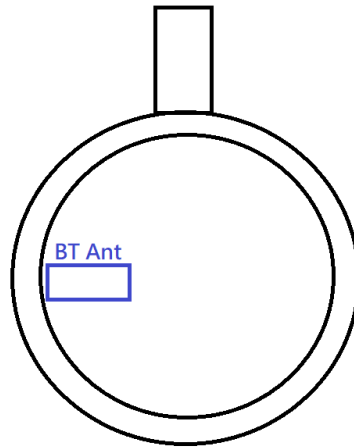
Photograph 17. Front view of EUT (V4310)
