### 2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4-2003, FCC CFR 47 Part 2 and FCC CFR 47 Part 15.

### 3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 Benicia Street, Fremont, California, USA. The sites are constructed in conformance with the requirements of ANSI C63.4, ANSI C63.7 and CISPR Publication 22. All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

### 4. CALIBRATION AND UNCERTAINTY

#### 4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

### 4.2. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

## 5. EQUIPMENT UNDER TEST

### 5.1. DESCRIPTION OF EUT

The EUT is a Bluetooth Headset.

The radio module is manufactured by CSR.

### 5.2. MAXIMUM OUTPUT POWER

The transmitter has a maximum peak conducted output power as follows:

### 5.3. DESCRIPTION OF AVAILABLE ANTENNAS

The radio utilizes a ceramic chip antenna, with a maximum gain of 2 dBi.

### 5.4. SOFTWARE AND FIRMWARE

The firmware installed in the EUT during testing was rev. 10.17.

The EUT driver software installed in the host support equipment during testing was CSRBlueCoreUSB.

The test utility software used during testing was CSR Bluesuite, rev. 1.24.

## 5.5. WORST-CASE CONFIGURATION AND MODE

The worst-case channel is determined as the channel with the highest output power. The highest measured output power was at 2441 MHz.

The X, Y, and Z orientations were investigated. The X orientation was determined as the worst-case.

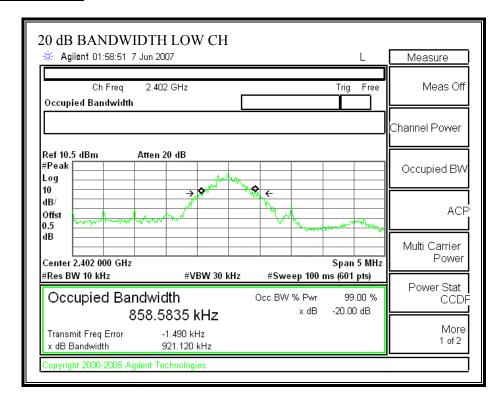

§15.247 (a) (1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hoping channel, whichever is greater.

## 7.1.4. AVERAGE TIME OF OCCUPANCY

#### **LIMIT**

§15.247 (a) (1) (iii) Frequency hopping systems in the 2400 – 2483.5 MHz band shall use at least 15 non-overlapping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

### **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan. The number of pulses is measured in a 3.16 second scan, to enable resolution of each occurrence.

The average time of occupancy in the specified 31.6 second period (79 channels \* 0.4 s) is equal to 10 \* (# of pulses in 3.16 s) \* pulse width.

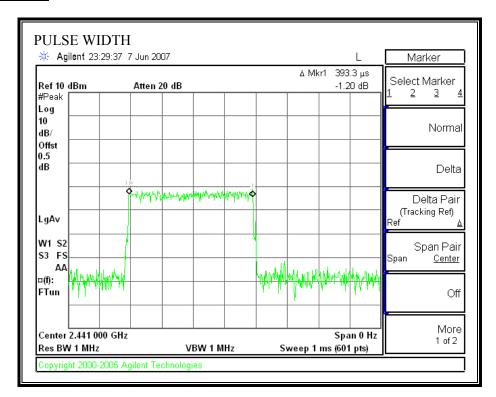

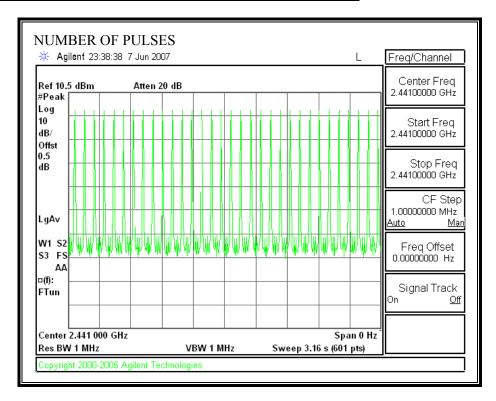

### 7.1.5. PEAK OUTPUT POWER

#### **PEAK POWER LIMIT**

§15.247 (b) The maximum peak output power of the intentional radiator shall not exceed the following:

§15.247 (b) (1) For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 hopping channels: 1 watt.

§15.247 (b) (4) Except as shown in paragraphs (b)(3) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

The maximum antenna gain is 2 dBi, therefore the limit is 30 dBm.

### **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer and the analyzer bandwidth is set to a value greater than the 20 dB bandwidth of the EUT.

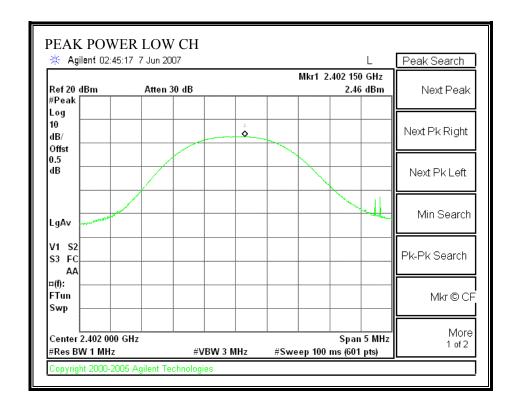

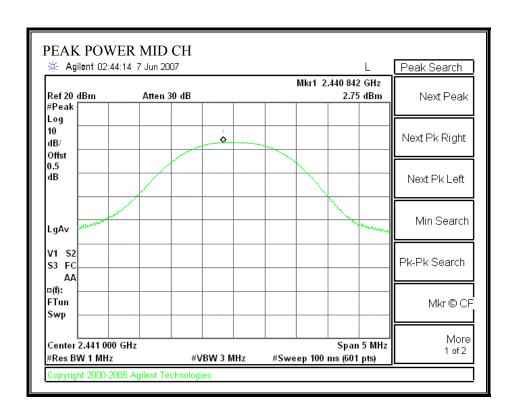

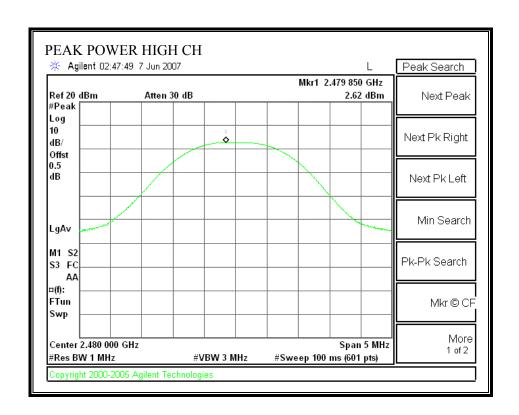

§1.1310 The criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of §2.1093 of this chapter.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

Rearranging terms to calculate the power density at a specific distance yields

$$S = 0.0795 * 10 ^ ((P + G) / 10) / (d^2)$$

### 7.1.8. CONDUCTED SPURIOUS EMISSIONS

#### LIMITS

§15.247 (c) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in§15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

#### **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer. The resolution bandwidth is set to 100 kHz. The video bandwidth is set to 300 kHz.

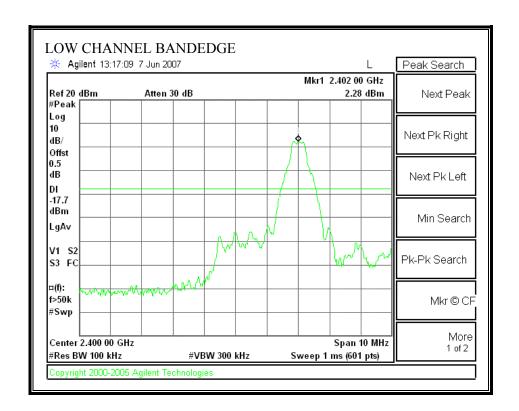

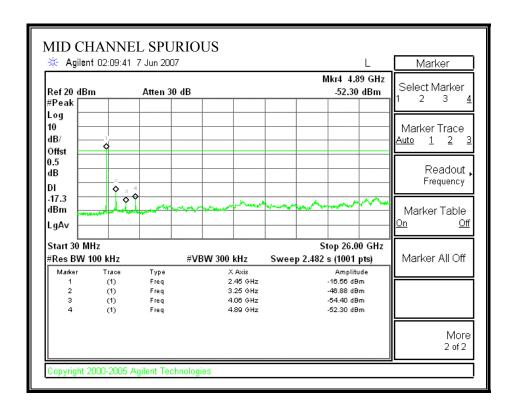
### **SPURIOUS EMISSIONS, LOW CHANNEL**



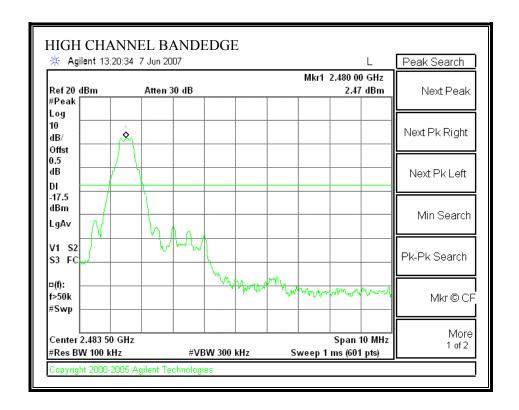


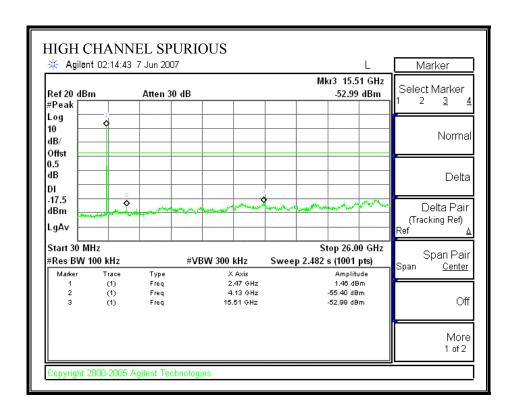
### SPURIOUS EMISSIONS, MID CHANNEL



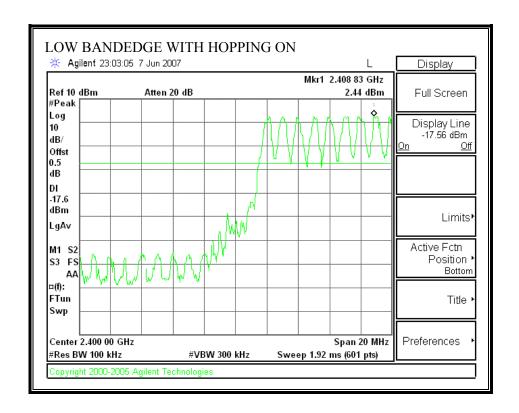


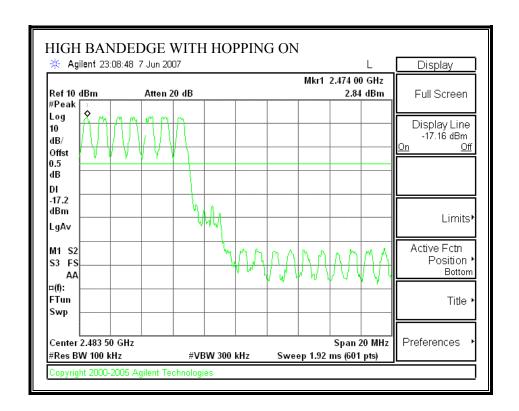
# **SPURIOUS EMISSIONS, HIGH CHANNEL**

At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.

# **TEST PROCEDURE**

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters. The EUT is configured in accordance with ANSI C63.4. The EUT is set to transmit in a continuous mode.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz, then the video bandwidth is set to 1 MHz for peak measurements and 10 Hz for average measurements.

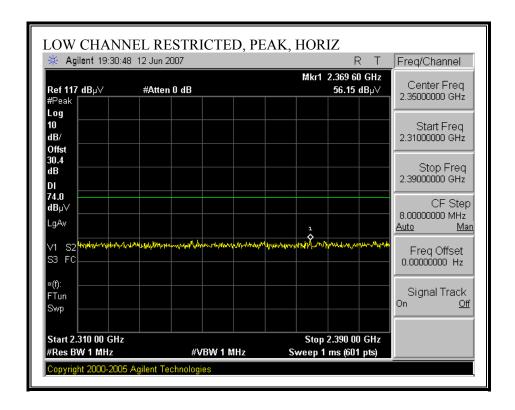
The spectrum from 30 MHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in the 2.4 GHz band.

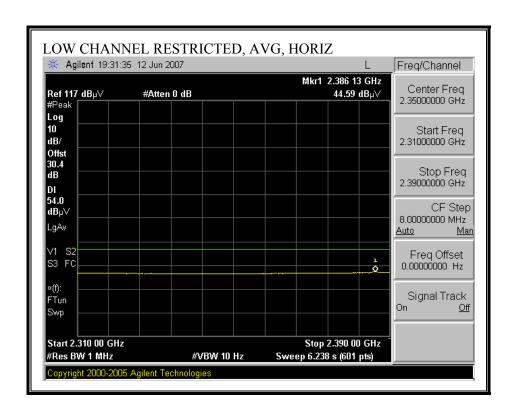
The spectrum from 30 MHz to 40 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in each 5 GHz band.

The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.

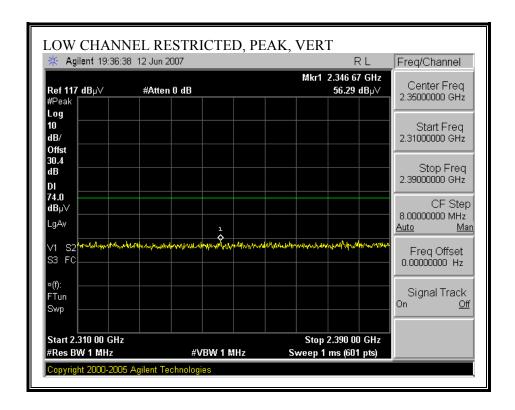

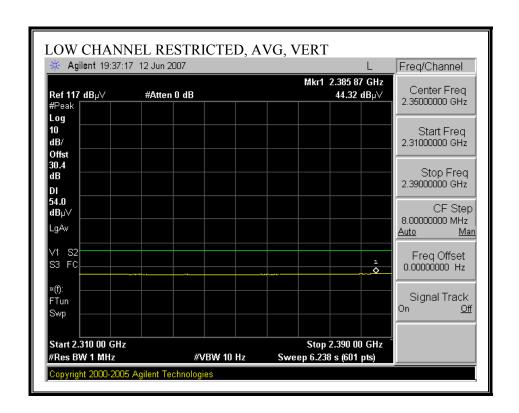
### RESTRICTED BANDEDGE (LOW CHANNEL, HORIZONTAL)



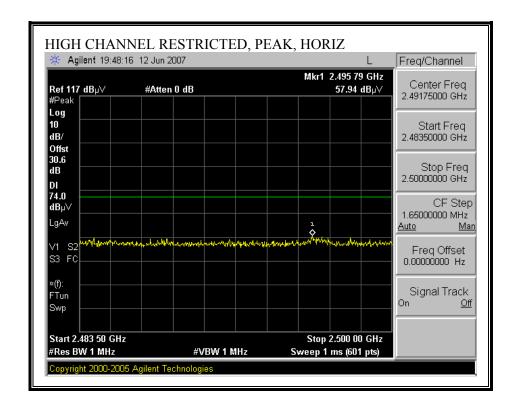


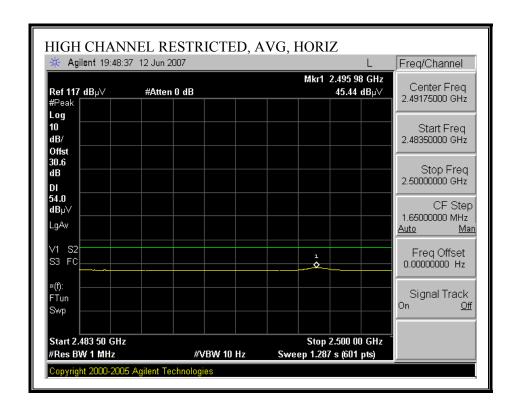
# RESTRICTED BANDEDGE (LOW CHANNEL, VERTICAL)



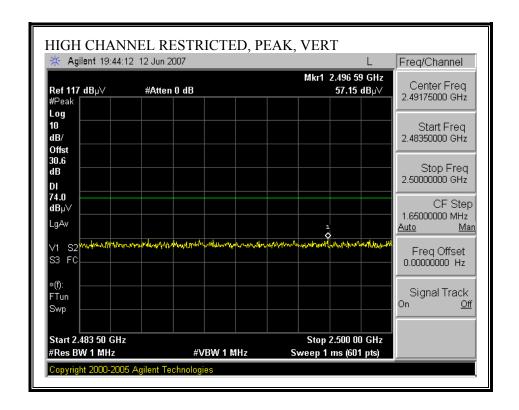


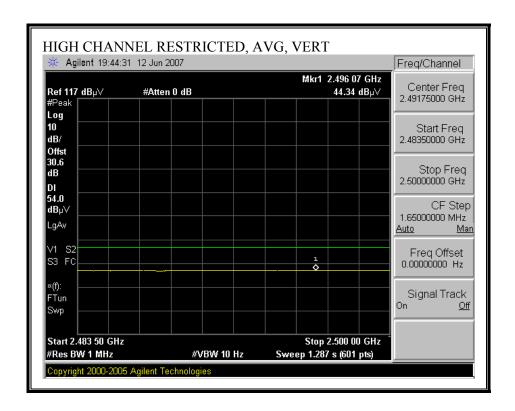
# RESTRICTED BANDEDGE (HIGH CHANNEL, HORIZONTAL)



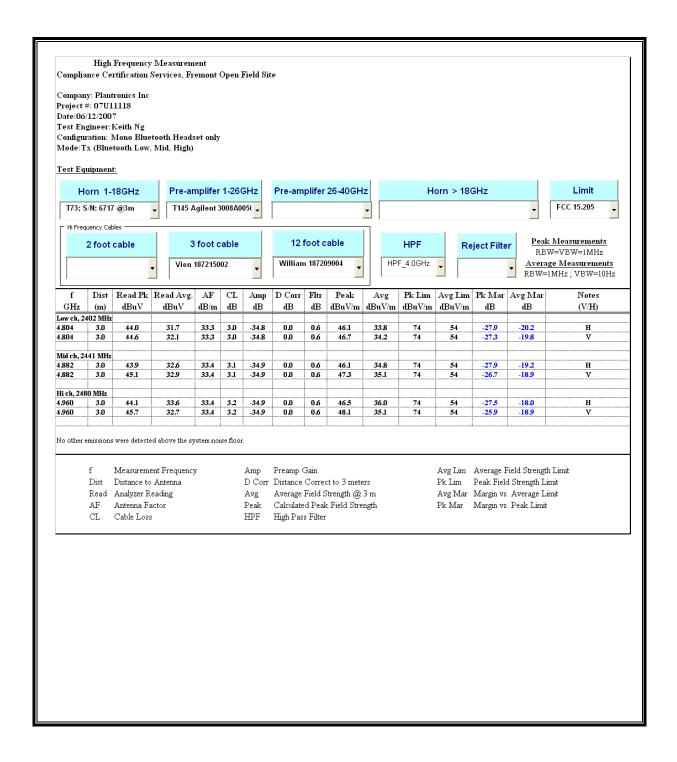


# RESTRICTED BANDEDGE (HIGH CHANNEL, VERTICAL)



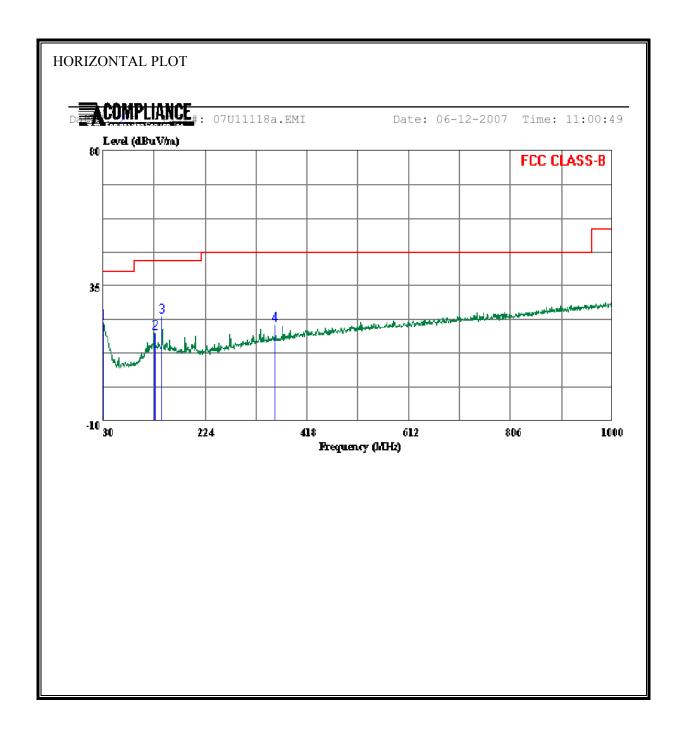

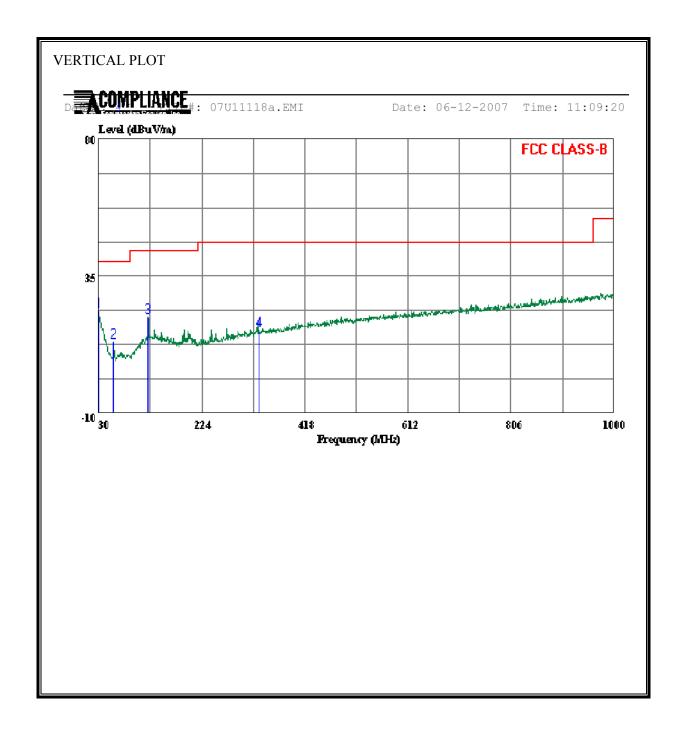

#### 7.3. POWERLINE CONDUCTED EMISSIONS

#### **LIMIT**

 $\S15.207$  (a) Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal.

The lower limit applies at the boundary between the frequency ranges.

The EUT is placed on a non-conducting table 40 cm from the vertical ground plane and 80 cm above the horizontal ground plane. The EUT is configured in accordance with ANSI C63.4.

The resolution bandwidth is set to 9 kHz for both peak detection and quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

Line conducted data is recorded for both NEUTRAL and HOT lines.

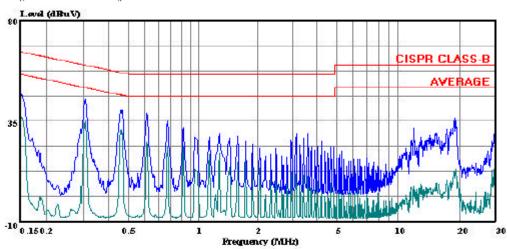
