The wireless headset does not need to be tested against CS-03 part V. However, the base connects to the handset port of a telephone unit shall be tested against CS-03 part 1 as per CS-03 part 1 section 1.1.4: ``component devices intended for connection between the network interface and TE (e.g. stuttered dial tone detectors), for connection between telephone terminal handsets and terminal base units (e.g. receiver amplifiers), for replacement of handsets or connection to handsets themselves.``
