

Measurement Procedure

The Equipment Under Test (EUT) was connected to a spectrum analyzer through a 30 dB Power attenuator. All cable and attenuator losses were input into the spectrum analyzer as a reference level offset to ensure accurate readings were obtained.

Test Procedure


The EUT was connected directly to a spectrum analyzer to verify that the UUT met the requirements for spurious emissions. A tunable notch filter was utilized to ensure the fundamental did not put the spectrum analyzer into compression. The resolution bandwidth set for 100 kHz and the reference level was adjusted to ensure the system had sufficient dynamic range to measure spurious emissions. The frequency range from 30 MHz to the 10th harmonic of the fundamental transmitter was observed and plotted. Only the worst case plots are included.






470.05 MHz 30 - 1000 MHz




481.05 MHz 30 - 1000 MHz








Occupied Bandwidth Plots


Mask D 450.05 MHz




Mask D 450.05 MHz




Mask B 470.05 MHz




Mask D 481.05 MHz






Mask B 491.05 MHz












25 kHz Bandwidth


Test Results On Time






12.5 kHz Bandwidth






