





5.2. Limits

For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.





In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.








8.1. Block diagram of test setup

8.2.3 Limit for this EUT

All the emissions appearing within 15.205 restricted frequency bands shall not exceed the limits shown in 15.209, all the other emissions shall be at least 20dB below the fundamental emissions, or comply with 15.209 limits.

8.3. Test Procedure

- (1) EUT was placed on a non-metallic table, 80 cm above the ground plane inside a semi-anechoic chamber for below 1G and 150 cm above the ground plane inside a semi-anechoic chamber for above 1G.
- (2) Test antenna was located 3m from the EUT on an adjustable mast, and the antenna used as below table.

According ANSI C63.10:2013 clause 6.4.4.2 and 6,5.3, for measurements below 30 MHz, the loop antenna was positioned with its plane vertical from the EUT and rotated about its vertical

axis for maximum response at each azimuth position around the EUT. And the loop antenna also be positioned with its plane horizontal at the specified distance from the EUT. The center of the loop is 1 m above the ground. for measurement above 30MHz, the Trilog Broadband Antenna or Horn Antenna was located 3m from EUT, Measurements were made with the antenna positioned in both the horizontal and vertical planes of

Polarization, and the measurement antenna was varied from 1 m to 4 m. in height above the reference ground plane to obtain the maximum signal strength.

- (3) Below pre-scan procedure was first performed in order to find prominent frequency spectrum radiated emissions from 9kHz to 25GHz:
 - (a) Scanning the peak frequency spectrum with the antenna specified in step (3), and the EUT was rotated 360 degree, the antenna height was varied from 1m to 4m (Except loop antenna, it's fixed 1m above ground.)
 - (b) Change work frequency or channel of device if practicable.
 - (c) Change modulation type of device if practicable.
 - (d) Change power supply range from 85% to 115% of the rated supply voltage
 - (e) Rotated EUT though three orthogonal axes to determine the attitude of EUT arrangement produces highest emissions.
 - Spectrum frequency from 9kHz to 25GHz (tenth harmonic of fundamental frequency) was investigated, and no any obvious emission were detected from 9kHz to 30MHz and 18GHz to 25GHz, so below final test was performed with frequency range from 30MHz to 18GHz.



- 3. Test setup: RBW: 200 Hz (9 kHz—150 kHz), 9 kHz (150 kHz—30 MHz).
- 4. Step size: 80Hz (0.009MHz-0.15MHz), 4 kHz (0.15MHz-30MHz), Scan time: auto.

12. Antenna Requirements

12.1. Limit

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

12.2. Result

The antennas used for this product is integrated antenna and that no antenna other than that furnished by the responsible party shall be used with the device, the maximum peak gain of the transmit antenna is only 3.51dBi.
