Radar Type 0 (80MHz / 5290MHz)



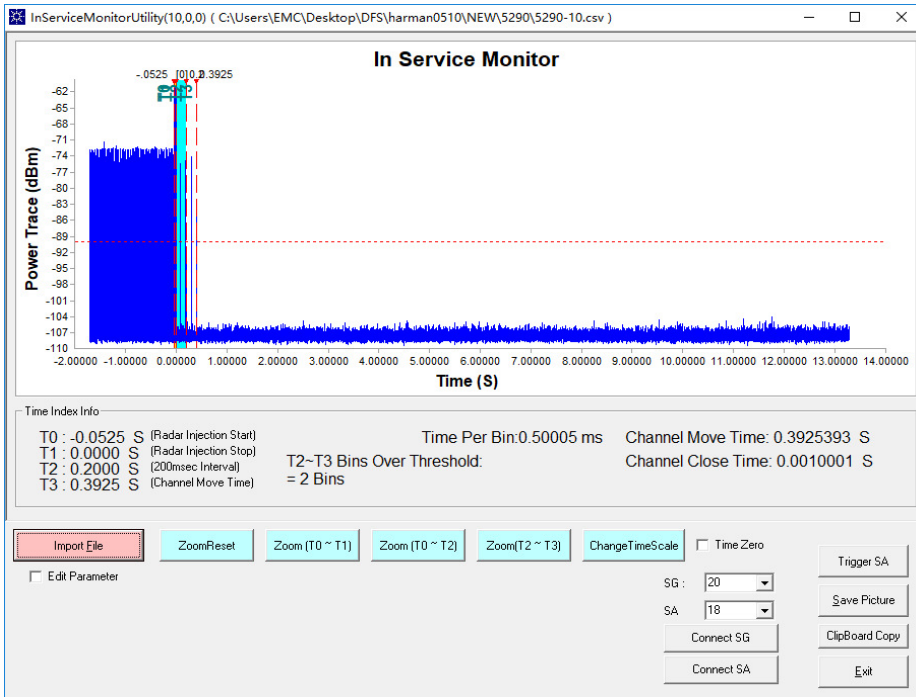
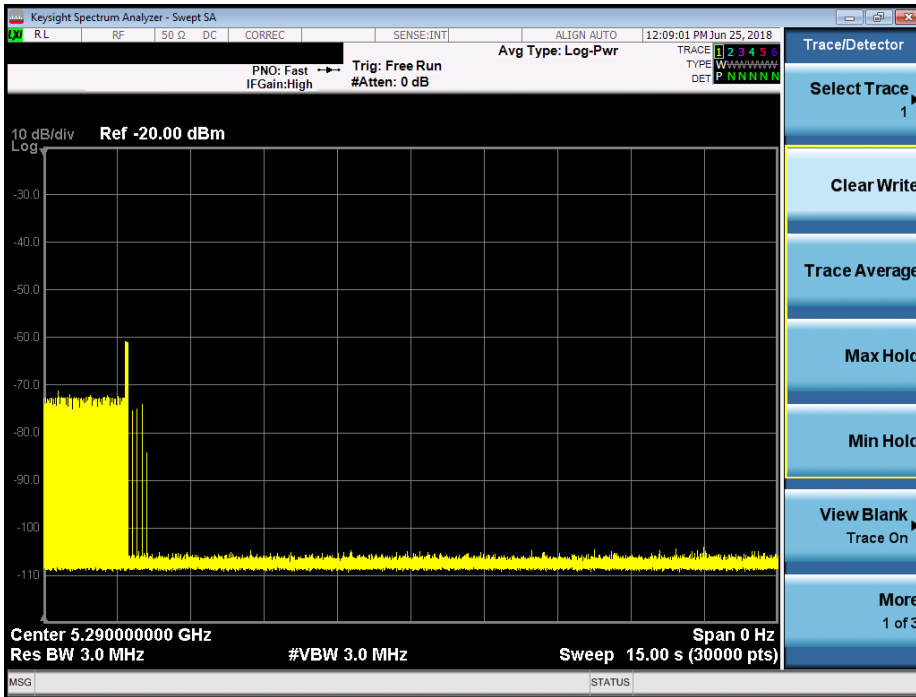
