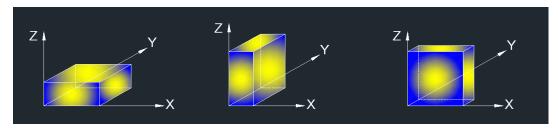

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.
