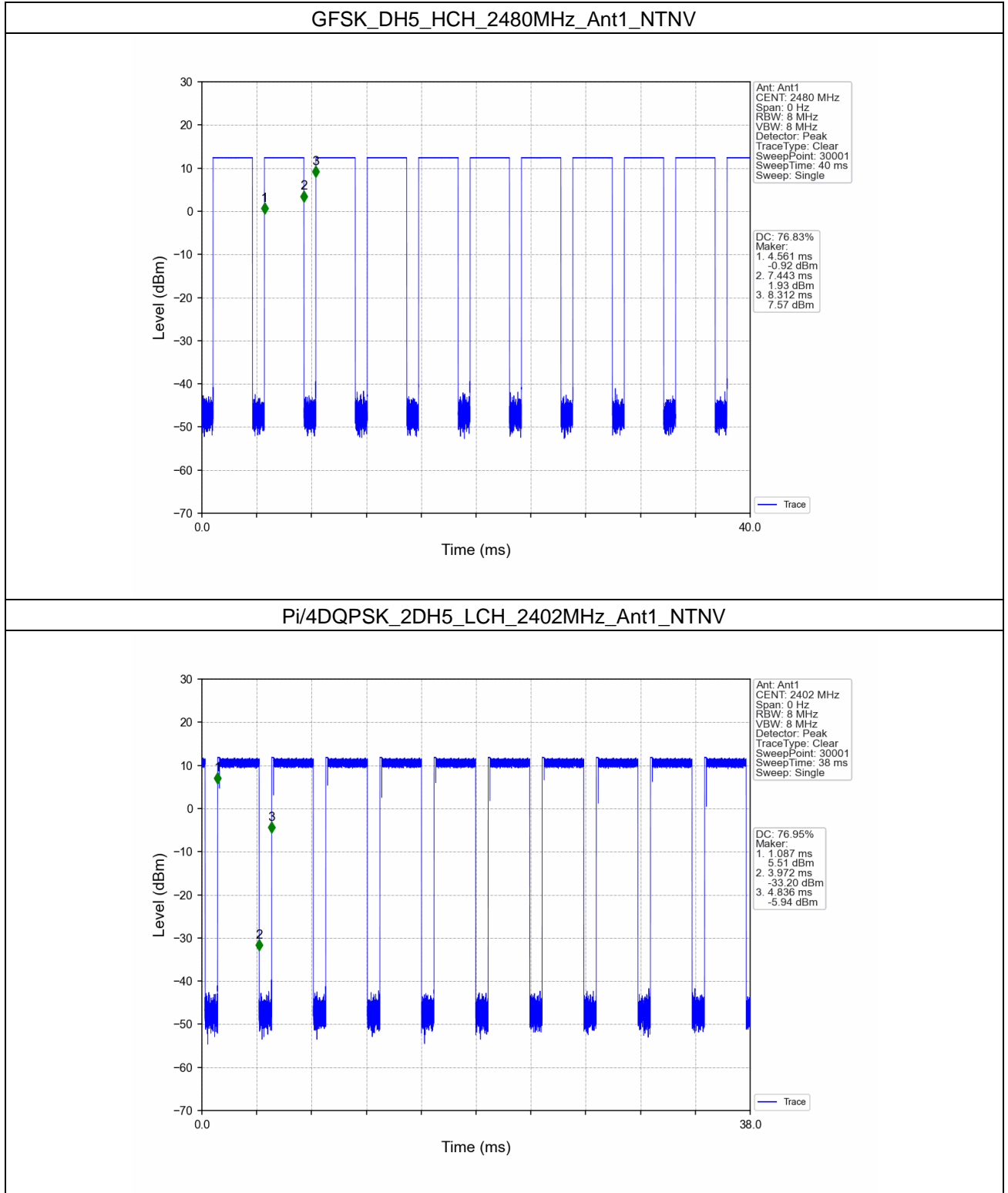
### 1.1.2 Test Graph



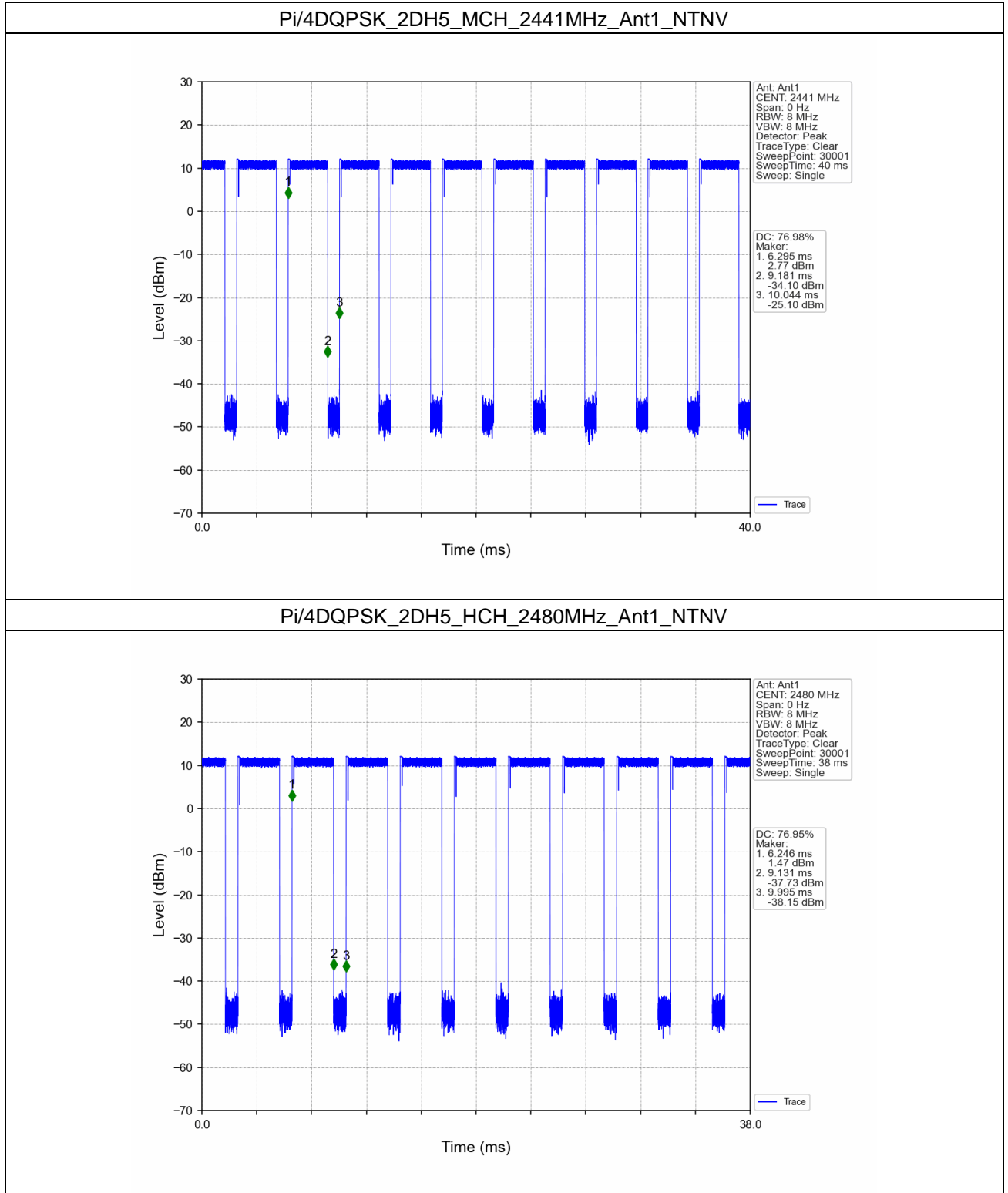

### 7.1.2 Test Graph

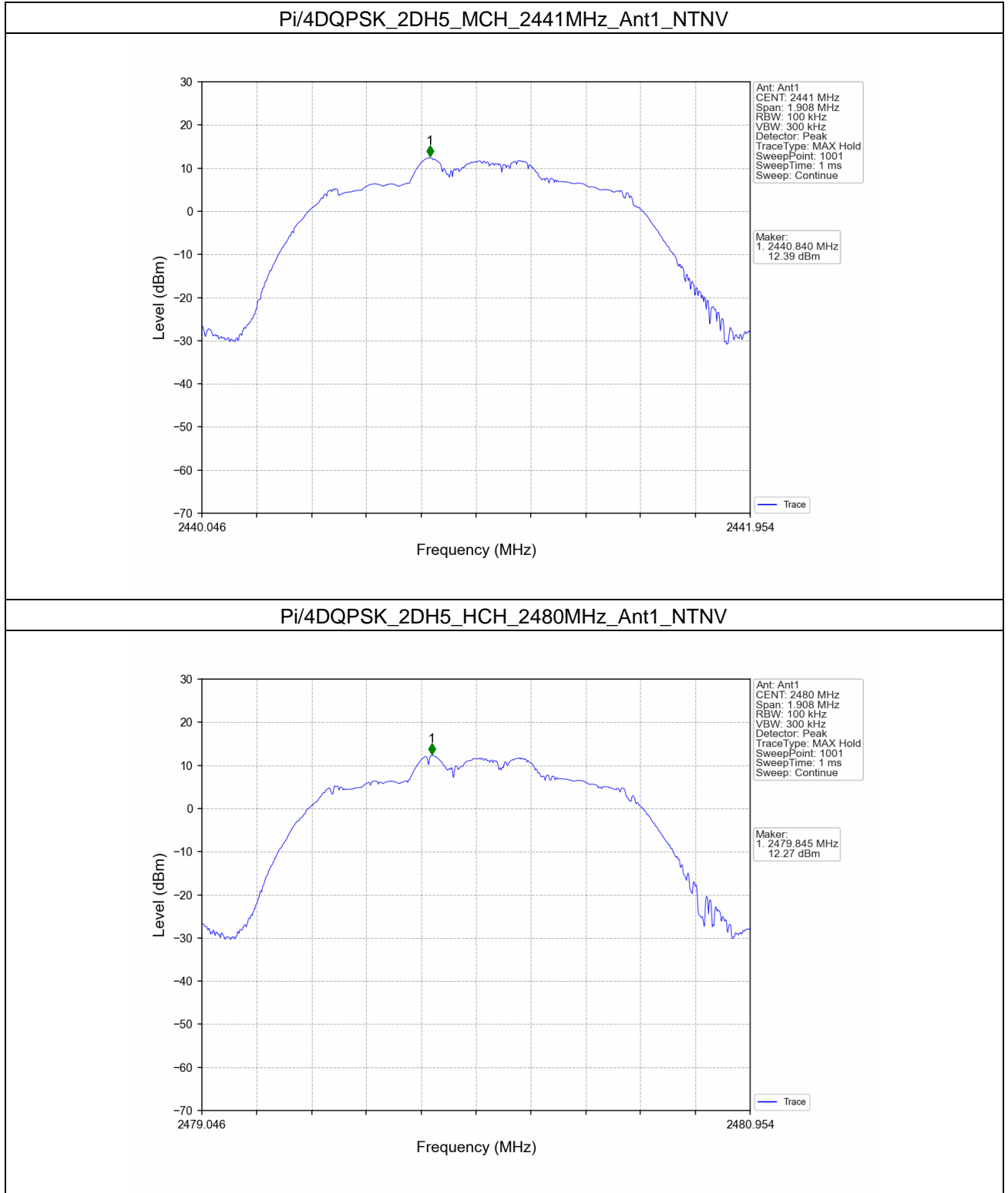
