9. OUT OF BAND EMISSION AT ANTENNA TERMINALS

9.1. Standard Applicable

FCC §22.917(a), §24.238(a), §27.53(h),Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB.

FCC §27.53(g)



FCC §27.53(m) (4)

For mobile digital stations, the attenuation factor shall be not less than 40 + 10 log (P) dB on all frequencies between the channel edge and 5 megahertz from the channel edge, 43 + 10 log (P) dB on all frequencies between 5 megahertz and X megahertz from the channel edge, and 55 + 10 log (P) dB on all frequencies more than X megahertz from the channel edge, where X is the greater of 6 megahertz or the actual emission bandwidth as defined in paragraph (m)(6) of this section. In addition, the attenuation factor shall not be less that 43 + 10 log (P) dB on all freguencies between 2490.5 MHz and 2496 MHz and 55 + 10 log (P) dB at or below 2490.5 MHz. Mobile Satellite Service licensees operating on frequencies below 2495 MHz may also submit a documented interference complaint against BRS licensees operating on channel BRS Channel 1 on the same terms and conditions as adjacent channel BRS or EBS licensees.

Measurement procedure. Compliance with these rules is based on the use of measurement nstrumentation employing a resolution bandwidth of 1 megahertz or greater. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed; for mobile digital stations, in the 1 megahertz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least two percent may be employed, except when the 1 megahertz band is 2495-2496 MHz, in which case a resolution bandwidth of at least one percent may be employed. 9.3. Measurement Procedure

Conducted Emission

The RF output of the transceiver was connected to a spectrum analyzer through appropriate attenuation The resolution bandwidth of the spectrum analyzer was set at 1MHz, sufficient scans were taken to show the out of band Emissions if any up to 10th harmonic.

- 1. To connect Antenna Port of EUT to Spectrum.
- Set RBW = 1MHz & VBW = 1MHz on Spectrum.
- Allow trace to fully stabilize
- 4. Repeat above procedures until all default test channel measured were complete.

Band Edge

- To connect Antenna Port of EUT to Spectrum.
- 2. The band edge of low and high channels for the highest RF powers was measured. Setting RBW ≥ 1% EBW.
- 3. Allow trace to fully stabilize
- 4. Repeat above procedures until all default test channel measured were complete.
