









Fig.3 Right Head Section / Cheek-Touch Position





Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position




Fig.9 EUT Back side (headset) to flat phantom




Fig.11 EUT Back side to flat phantom




Fig.13 EUT Right side to flat phantom


