
Fig.1 Photograph of the SAR measurement system



## Photograph of the Tissue Simulant Fluid Liquid (Head & Body)




















Fig.3 Right Head Section / Cheek-Touch Position





Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position




Fig.8 EUT Back side to flat phantom




Fig.13 EUT Right side to flat phantom






Fig.18 Antenna position of EUT (WLAN)
