2.2 Test Mode

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and find X plane as worst plane, and the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.

1. The EUT is placed on a turntable with 0.8 meter for frequency below 1 GHz and 1.5 meter for frequency above 1 GHz respectively above ground.





For radiated test below 30MHz




Emission below 1GHz 2.4GHz BT (LF)

In AFH mode, the minimum hopping frequencies are 20, to get the longest dwell time DH5 packet is observed; the on time period to have DH5 packet completing one hopping sequence is

$$2.89 \text{ ms x } 20 \text{ channels} = 57.8 \text{ ms}$$

There cannot be 2 complete hopping sequences within 100ms period, considering the random hopping behavior, maximum 2 hops can be possibly observed within the period. [100 ms / 57.8 ms] = 2 hops Thus, the maximum possible ON time:

$$2.89 \text{ ms } x 2 = 5.78 \text{ ms}$$
