

I. Executive Summary

A. Purpose of Test

An EMC Wireless evaluation was performed to determine compliance of the Enlighted, Inc SU-5i, with the requirements of Part 15, §15.247. All references are to the most current version of Title 47 of the Code of Federal Regulations in effect. In accordance with §2.1033, the following data is presented in support of the Certification of the SU-5i. Enlighted, Inc should retain a copy of this document which should be kept on file for at least two years after the manufacturing of the SU-5i, has been **permanently** discontinued.

B. Executive Summary

The following tests were conducted on a sample of the equipment for the purpose of demonstrating compliance with Part 15, §15.247, in accordance with Enlighted, Inc, purchase order number 0006277. All tests were conducted using measurement procedure ANSI C63.4-2014.

E. Description of Test Sample

The Enlighted, Inc SU-5i, Equipment Under Test (EUT), is a desk occupancy sensor placed under each open-office workspace detects when the desk is in use, providing real-time desk availability information. It has an embedded BLE radio that transmits and receives beacons. It has an 802.15.4 radio that works with secured Enlighted wireless network with AES-128 encryption delivering secure, reliable communication by sensing low-traffic channels and transmitting in bursts. It has a digital Passive Infrared (PIR) sensor that supports precise motion identification while minimizing false detection events

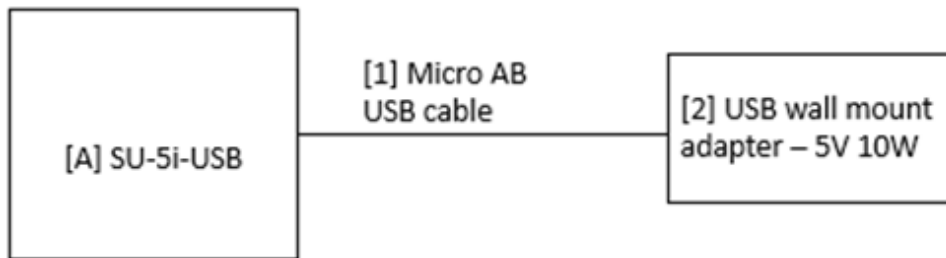


Figure 1: Block Diagram of Test Configuration

I. Mode of Operation During Testing


Continuous transmit mode – Specific commands can be sent to the device using which we select the radio to transmit (BLE or 802.15.4), select the channel and power level at which the radio transmits. This will be the worst case condition.

Modulated signal mode – For specific test cases that involves to set the device to transmit in modulated signal, test commands have been provided that can be sent to put the radio (BLE or 15.4) in the respective modulated signal mode.

Normal operating mode – In normal circumstances the device will detect motion and transmit the information to other Enlighted sensors and Enlighted Gateway through 802.15.4. It will send BLE beaconing to other Enlighted sensors and Enlighted Room Control (wall switch) to listen for commands. The 15.4 and BLE beaconing transmissions lasts for not more than 50ms for every burst.

NOTE: The device worst case mode for emissions will be in continuous transmit mode. Modulated signal mode commands are expected to be used only for specific test cases that requests to test the modulated signal

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.203 Antenna Requirement

Test Requirement: § 15.203: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

The structure and application of the EUT were analyzed to determine compliance with Section 15.203 of the Rules. Section 15.203 states that the subject device must meet at least one of the following criteria:

- a.) Antenna must be permanently attached to the unit.
- b.) Antenna must use a unique type of connector to attach to the EUT.
- c.) Unit must be professionally installed. Installer shall be responsible for verifying that the correct antenna is employed with the unit.

Results: The EUT **completed testing** to the criteria of §15.203.

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.207(a) Conducted Emissions Limits

Test Requirement(s): § 15.207 (a): For an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30MHz, shall not exceed the limits in the following table, as measured using a 50 μ H/50 Σ line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

Test Procedure: The EUT was placed on a 0.8 m-high wooden table inside a screen room. The EUT was situated such that the back of the EUT was 0.4 m from one wall of the vertical ground plane, and the remaining sides of the EUT were no closer than 0.8 m from any other conductive surface. The EUT was powered from a 50 Ω /50 μ H Line Impedance Stabilization Network (LISN). The EMC receiver scanned the frequency range from 150 kHz to 30 MHz. Conducted Emissions measurements were made in accordance with *ANSI C63.4-2014 "Methods and Measurements of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the Range of 9kHz to 40 GHz"*. The measurements were performed over the frequency range of 0.15 MHz to 30 MHz using a 50 Ω /50 μ H LISN as the input transducer to an EMC/field intensity meter. For the purpose of this testing, the transmitter was turned on. Scans were performed with the transmitter on.

Test Results: The EUT **completed testing** to this requirement. Measured emissions were below applicable limits.

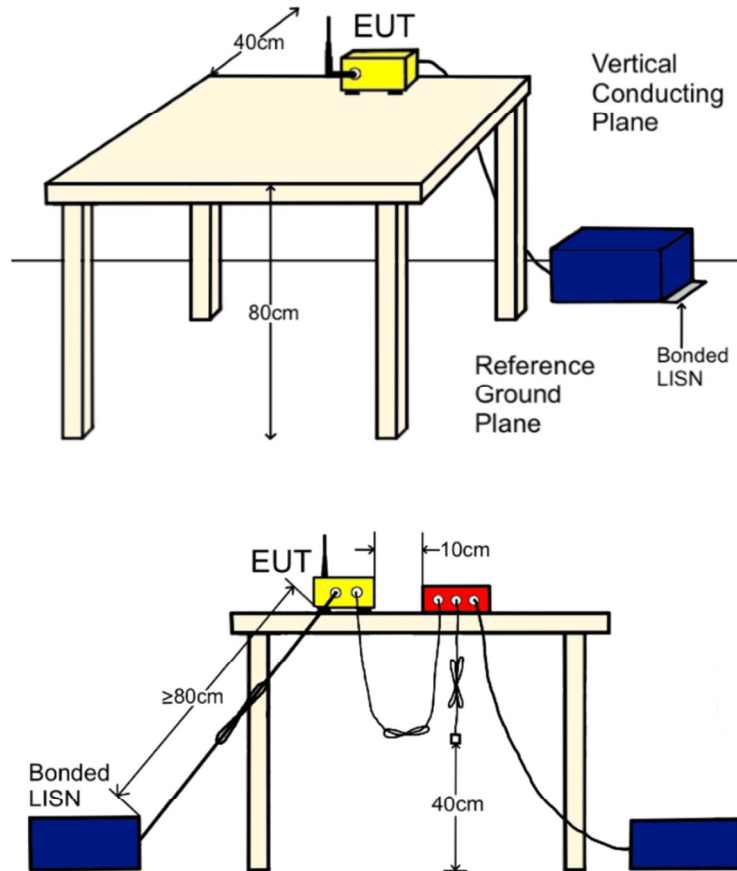
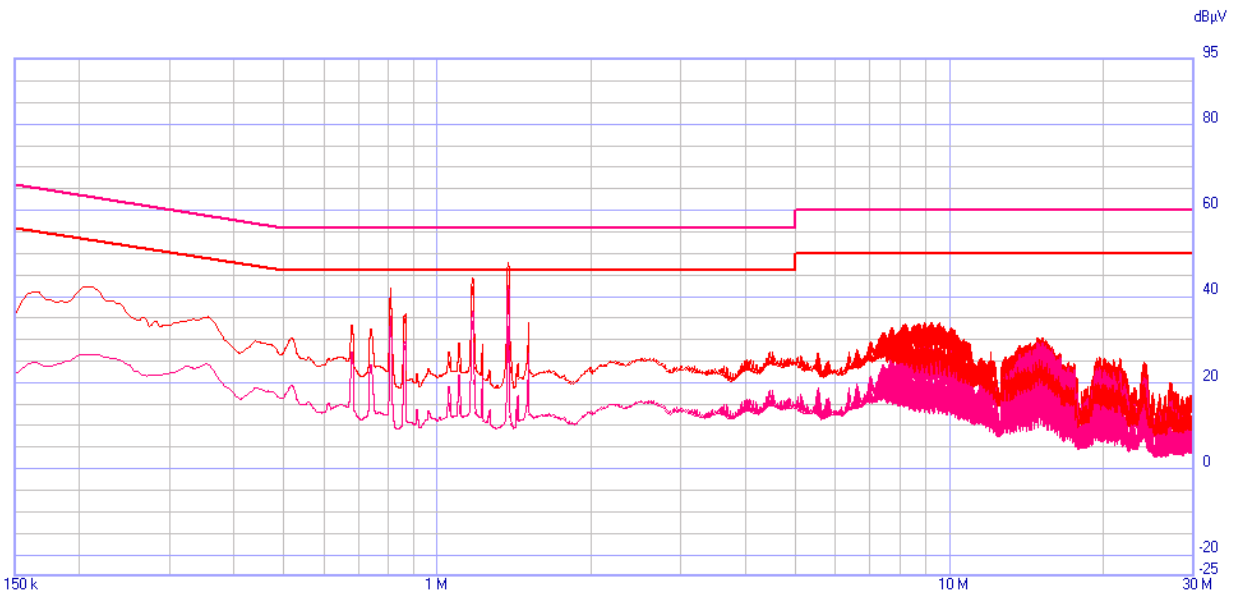


Figure 2: Conducted Emissions Voltage, Test Setup

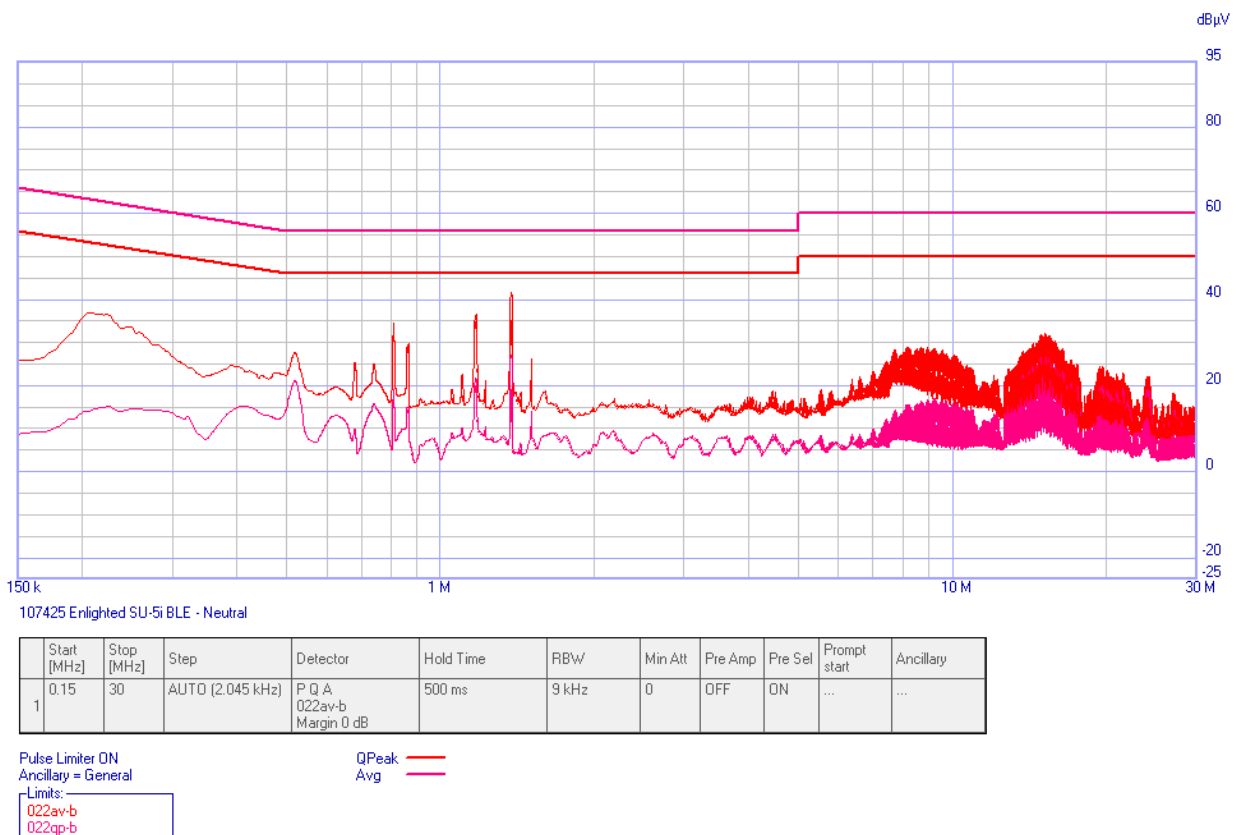

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(a)(2) 6 dB Bandwidth

Test Requirements: § 15.247(a)(2): Operation under the provisions of this section is limited to frequency hopping and digitally modulated intentional radiators that comply with the following provisions:

For systems using digital modulation techniques, the EUT may operate in the 902-928 MHz, 2400-2483.5 MHz and 5725-5850 MHz bands. The minimum 6dB bandwidth shall be at least 500 kHz.

Test Procedure: The transmitter was on and transmitting at the highest output power. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using an RBW approximately 1% of the total emission bandwidth, VBW > RBW. The 6 dB Bandwidth was measured and recorded. The measurements were performed on the low, mid and high channels.

Test Results The EUT **completed testing** to the requirements of § 15.247 (a)(2). No anomalies noted.

The 6 dB Bandwidth was determined from the plots on the following pages.

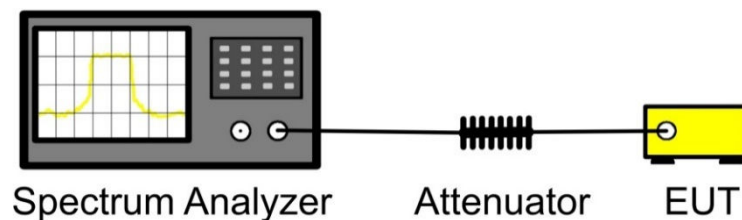
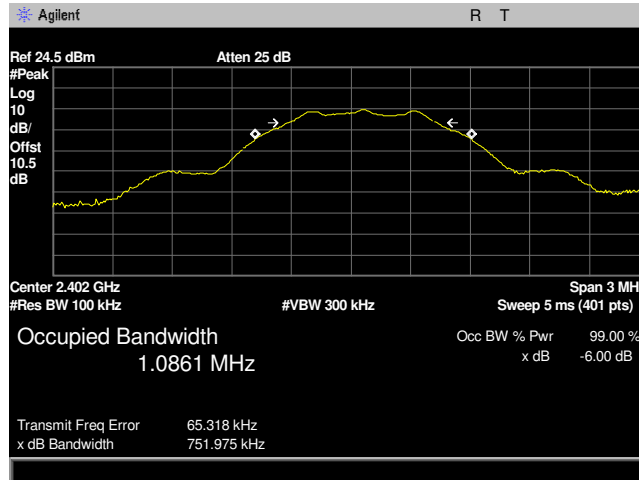


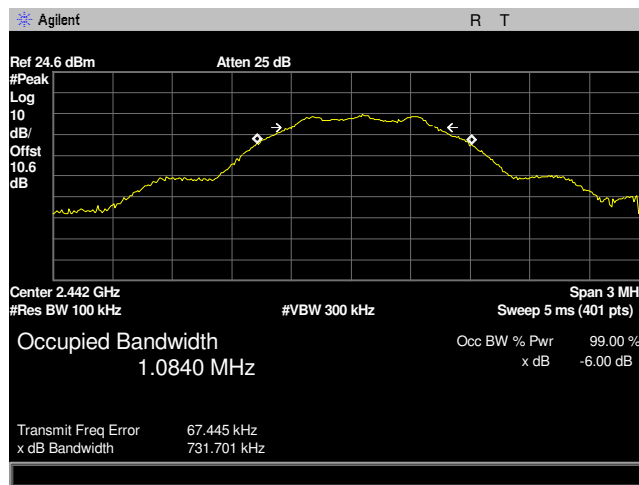
Figure 3: Block Diagram, Occupied Bandwidth Test Setup

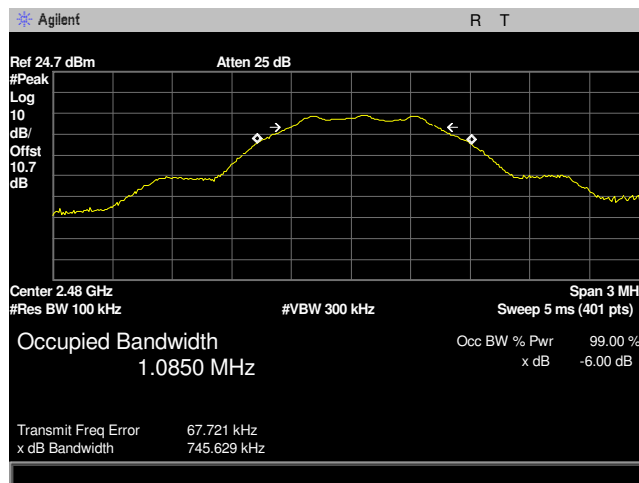

§ 15.247(b) Peak Power Output

Test Requirements: §15.247(b): The maximum peak output power of the intentional radiator shall not exceed the following:

§15.247(c): if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in the Figure 21, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Systems operating in the 2400 – 2483.5 MHz band and using a point to point application may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

Systems operating in the 5725 – 5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter peak output power.

Fixed, point-to-point operation excludes the use of point-to-multipoint systems, Omni-directional applications, and multiple co-located intentional radiators transmitting the same information. The operator of the spread spectrum intentional radiator or, if the equipment is professionally installed, the installer is responsible for ensuring that the system is used exclusively for fixed, point-to-point operations. The instruction manual furnished with the intentional radiator shall contain language in the installation instructions informing the operator and the installer of this responsibility.

Test Procedure: The transmitter was connected to a calibrated spectrum analyzer. The EUT was measured at the low, mid and high channels of each band at the maximum power level.

Test Results: The EUT **completed testing** to the requirements of §15.247(b). No anomalies noted.

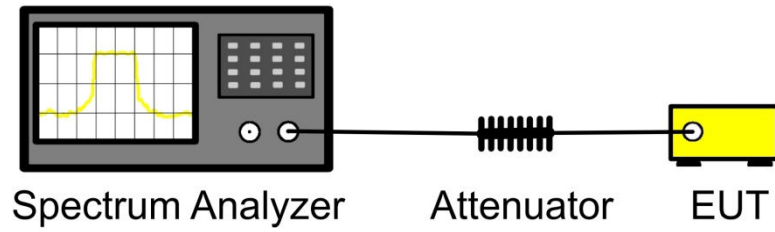
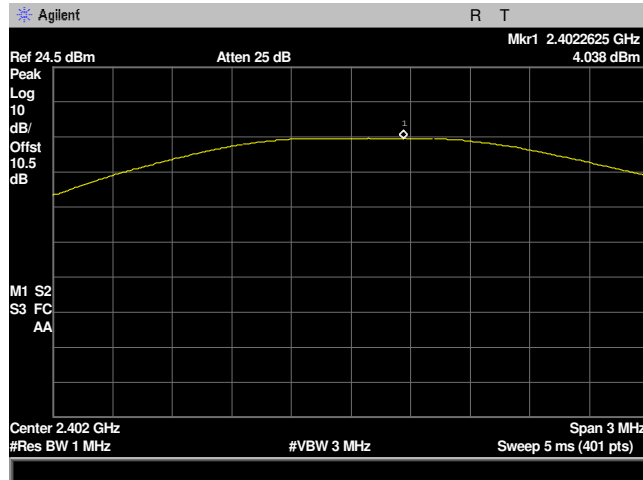


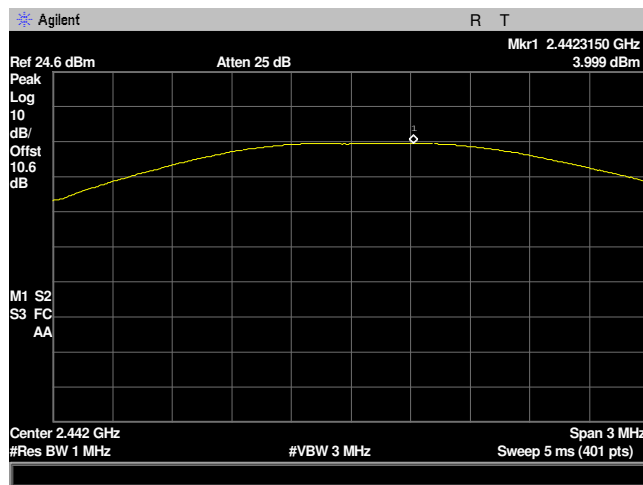
Figure 4: Peak Power Output Test Setup

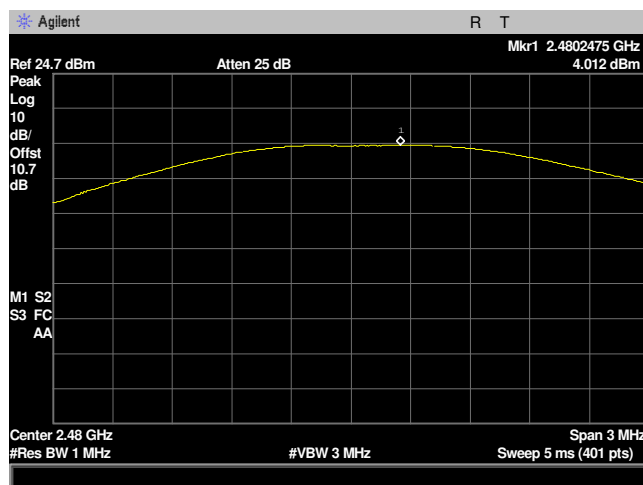

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(d) Radiated Spurious Emissions Requirements and Band Edge

Test Requirements: §15.247(d); §15.205: Emissions outside the frequency band.

§15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a).

§15.205(a): Except as shown in paragraph (d) of this section, only spurious emissions are permitted in any of the frequency bands listed below:

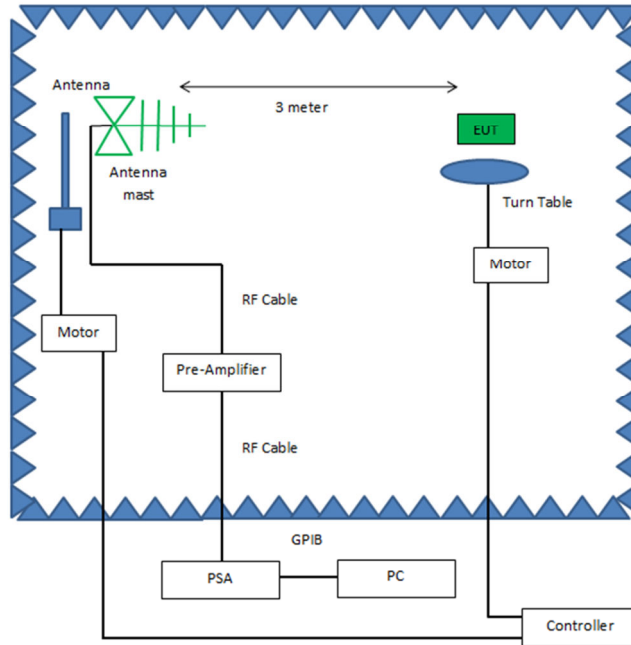


Figure 5: Radiated Emissions, Below 1GHz, Test Setup

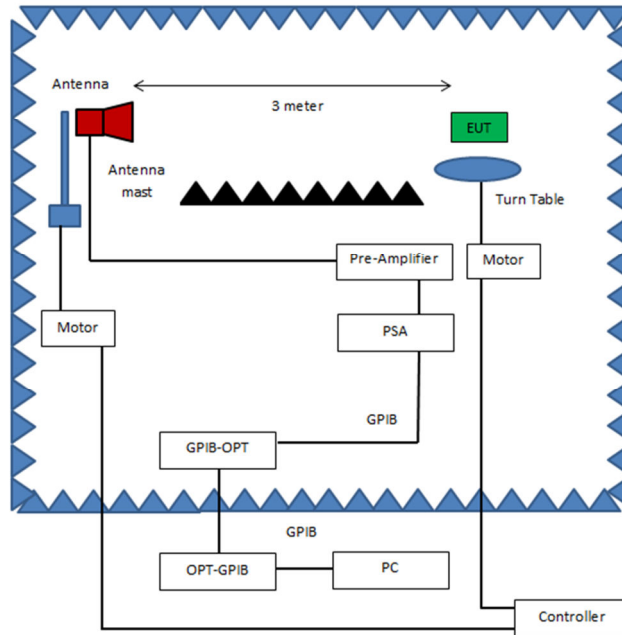
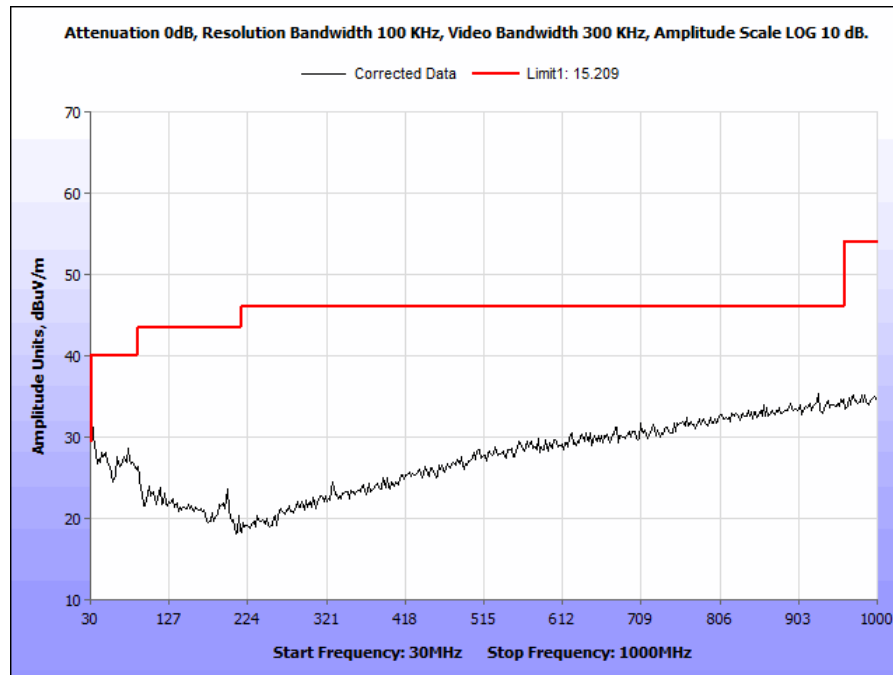


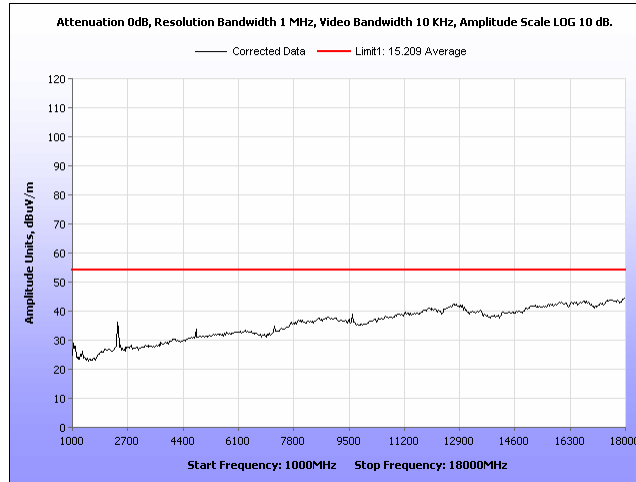
Figure 6: Radiated Emissions, Above 1GHz, Test Setup

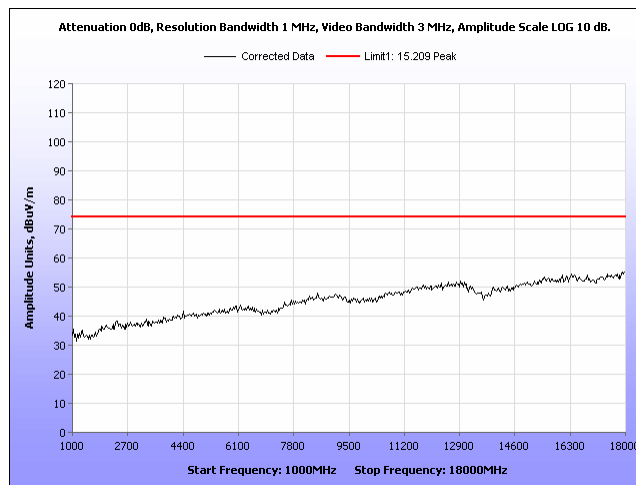

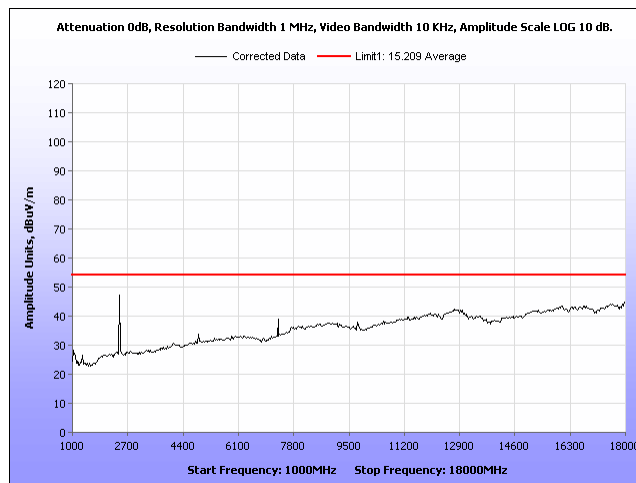
Plot 7: Radiated Emissions, BLE, 30 MHz - 1 GHz, (worst case)



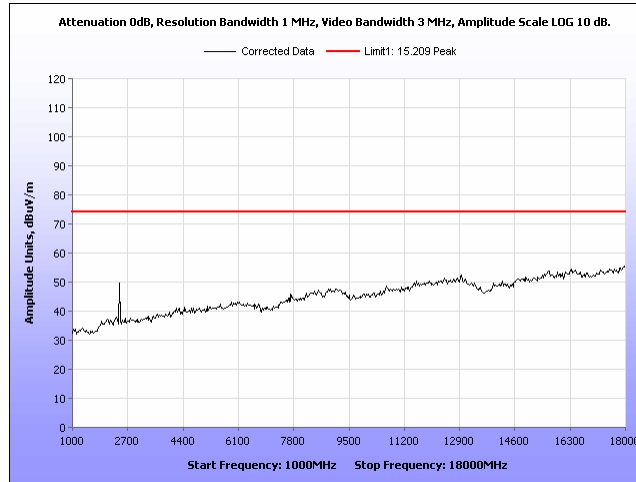
Plot 9: Radiated Spurious Emissions Requirements, Low Channel 2402MHz, Average



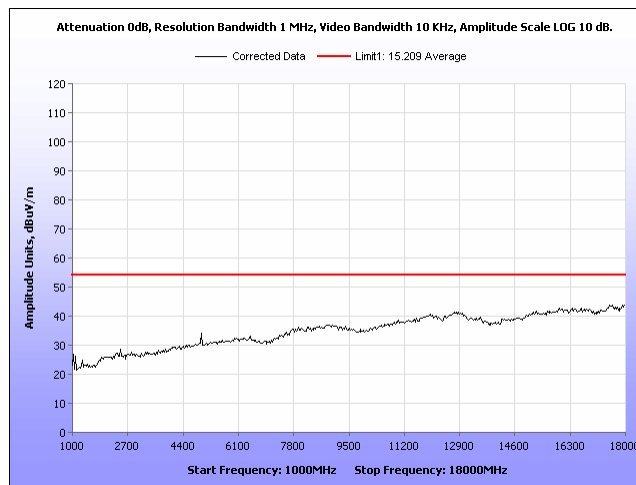
Plot 10: Radiated Spurious Emissions Requirements, Low Channel 2402MHz, Peak



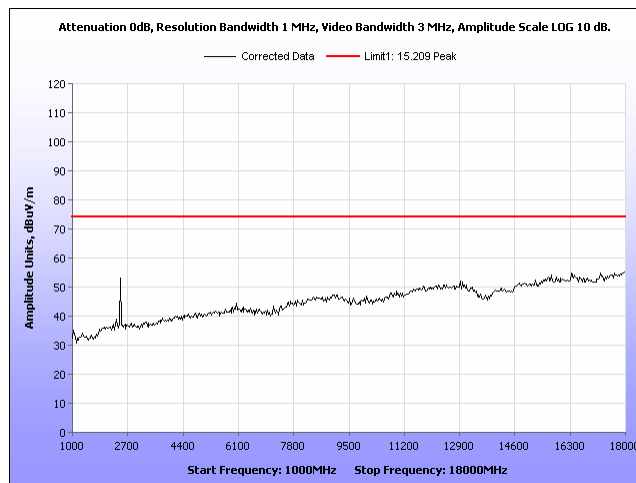
Plot 11: Radiated Spurious Emissions Requirements, Mid Channel 2442MHz, Average



Plot 12: Radiated Spurious Emissions Requirements, Mid Channel 2442MHz, Peak



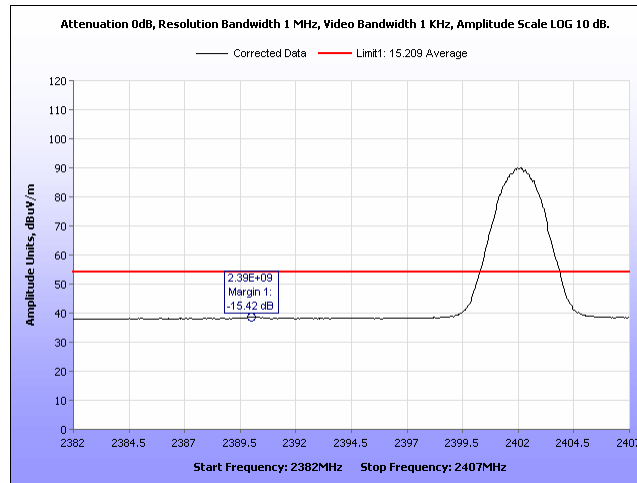
Plot 13: Radiated Spurious Emissions Requirements, High Channel 2480MHz, Average



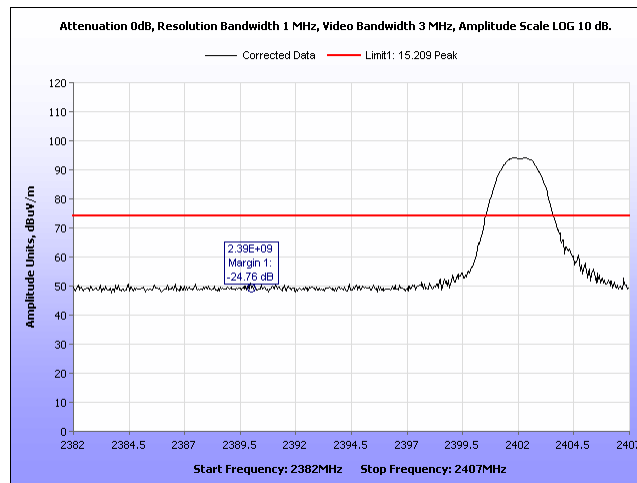
Plot 14: Radiated Spurious Emissions Requirements, High Channel 2480MHz, Peak

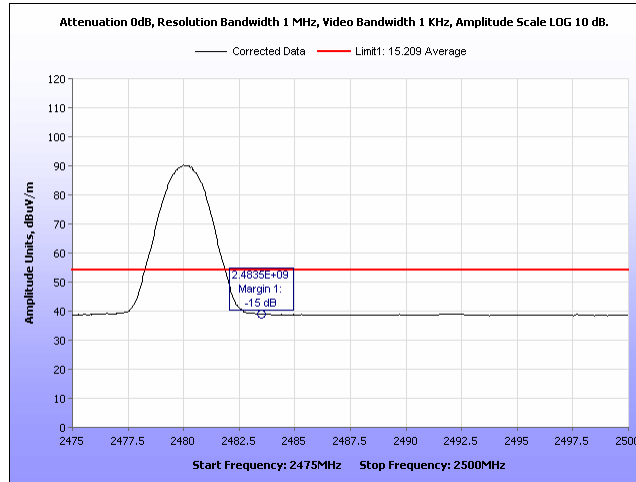

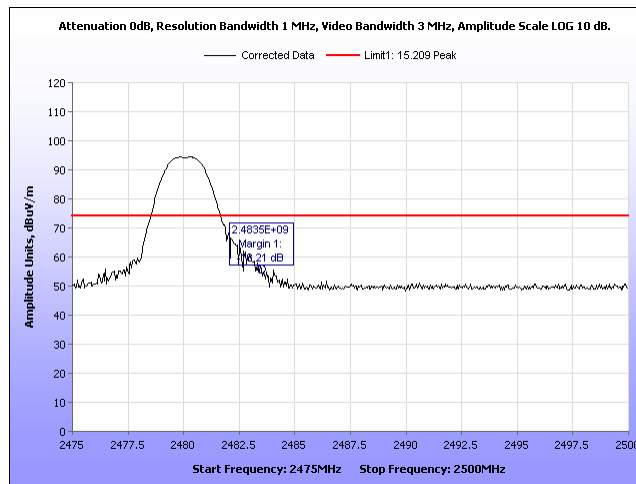
Plot 15: Radiated Band Edge, Low Channel 2402MHz, Average

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(d) RF Conducted Spurious Emissions Requirements and Band Edge

Test Requirement: **15.247(d)** In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

Test Procedure: For intentional radiators with a digital device portion which operates below 10 GHz, the spectrum was investigated as per §15.33(a)(1) and §15.33(a)(4); i.e., the lowest RF signal generated or used in the device up to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

Since the EUT had an integral antenna, conducted measurements could not be performed. Measurements needed to be taken radiated. An antenna was located 3 m away from the EUT and plots were taken. The EUT was rotated through all three orthogonal axes. The plots were corrected for both antenna correction factor and cable loss.

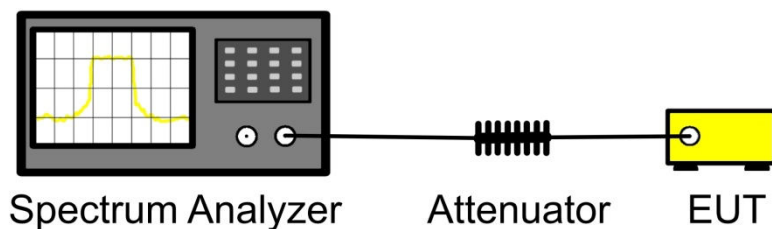
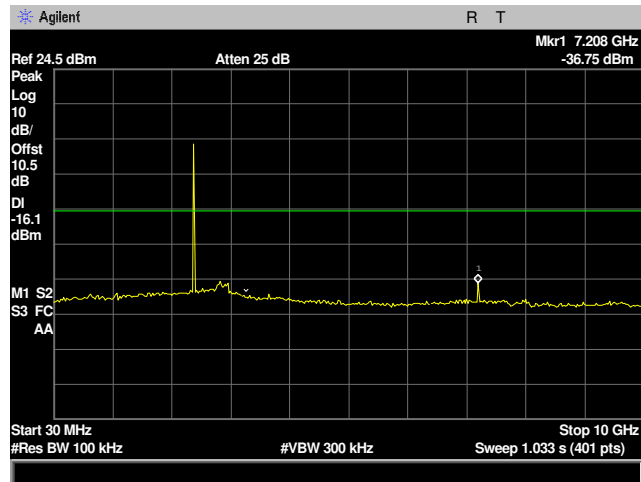
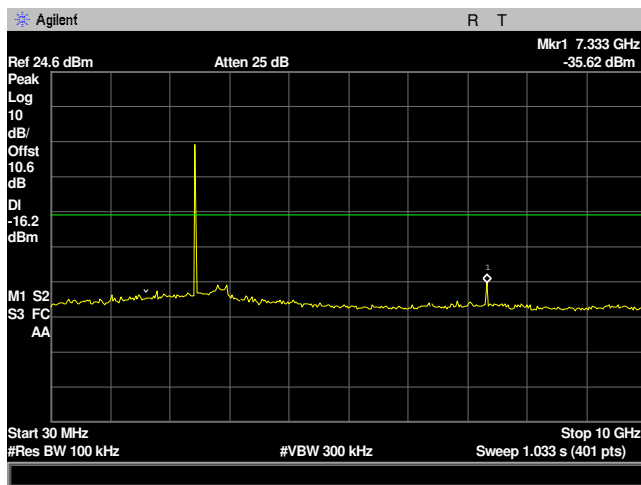


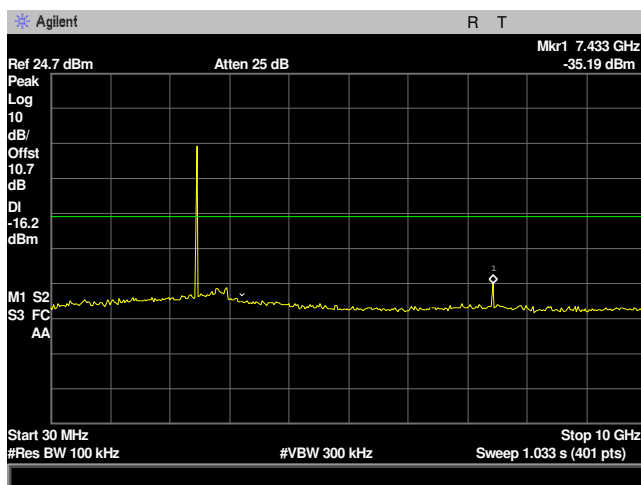
Figure 7: Block Diagram, Conducted Spurious Emissions Test Setup



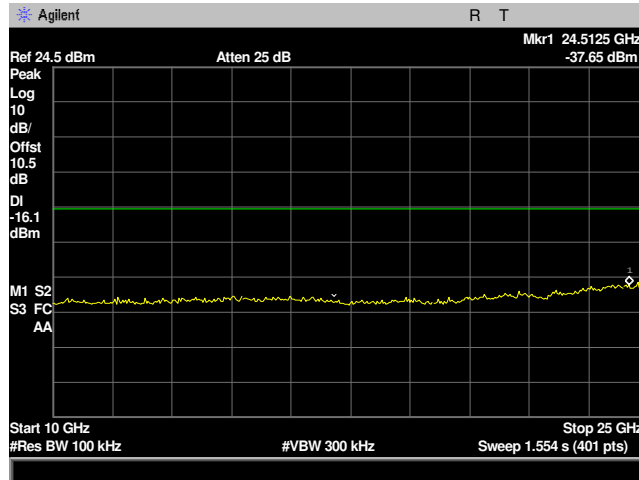
Plot 19: RF Conducted Spurious Emissions Requirements, 30MHz-10GHz 2402MHz Low Channel



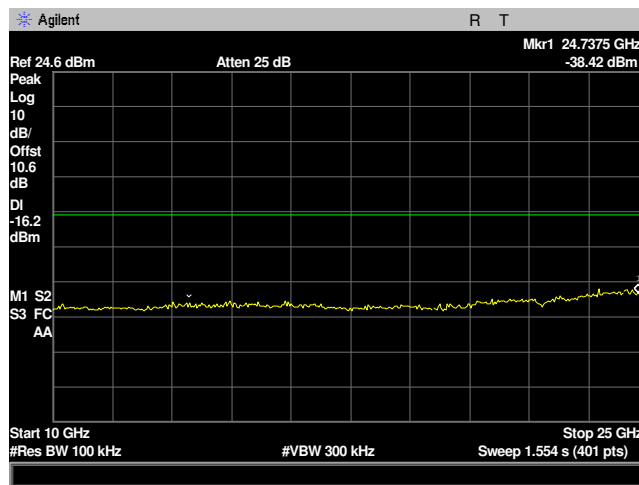
Plot 20: RF Conducted Spurious Emissions Requirements, 30MHz-10GHz 2442MHz Mid Channel



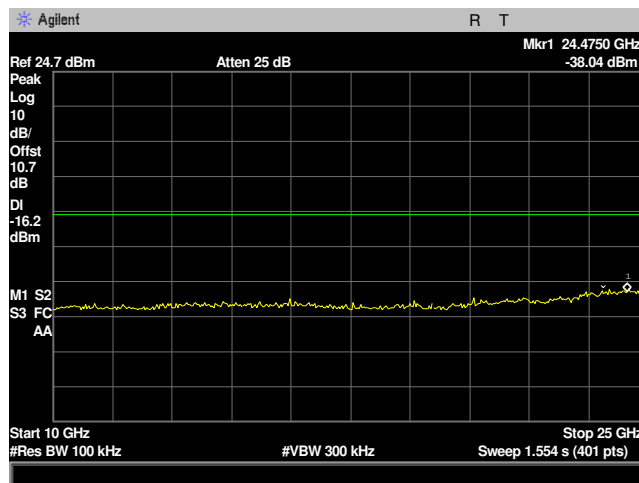
Plot 21: RF Conducted Spurious Emissions Requirements, 30MHz-10GHz 2480MHz High Channel



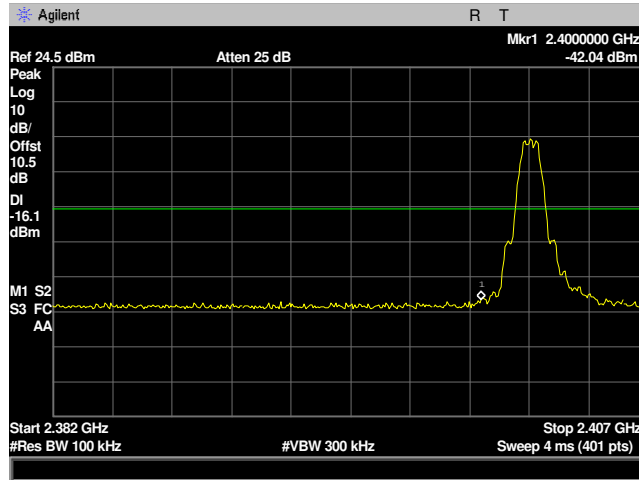
Plot 22: RF Conducted Spurious Emissions Requirements, 10GHz-25GHz 2402MHz Low Channel



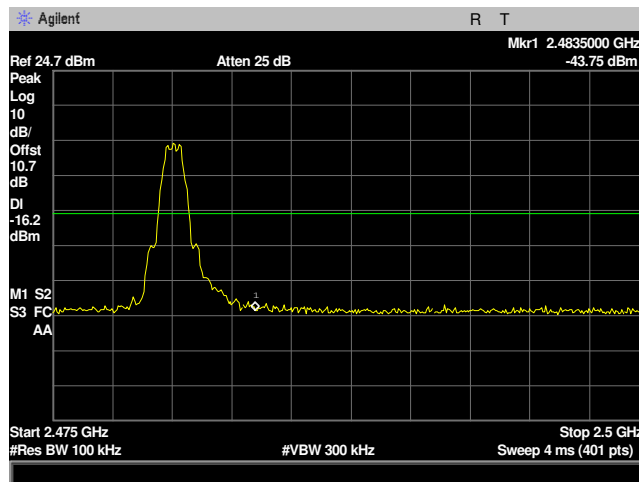
Plot 23: RF Conducted Spurious Emissions Requirements, 10GHz-25GHz 2442MHz Mid Channel



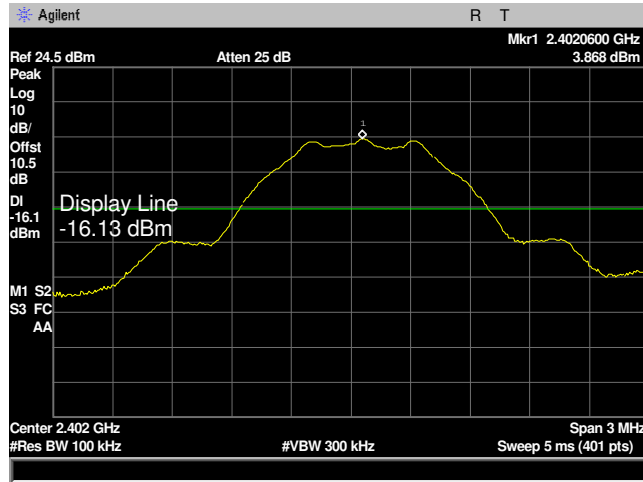
Plot 24: RF Conducted Spurious Emissions Requirements, 10GHz-25GHz 2480MHz High Channel



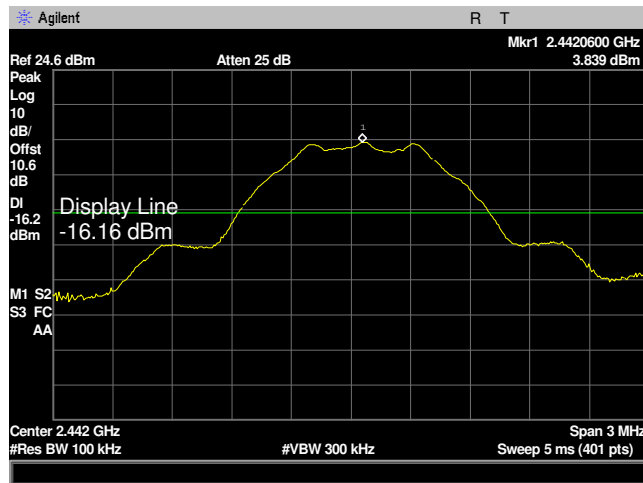
Plot 25: RF Conducted Band Edge, 2402MHz Low Channel



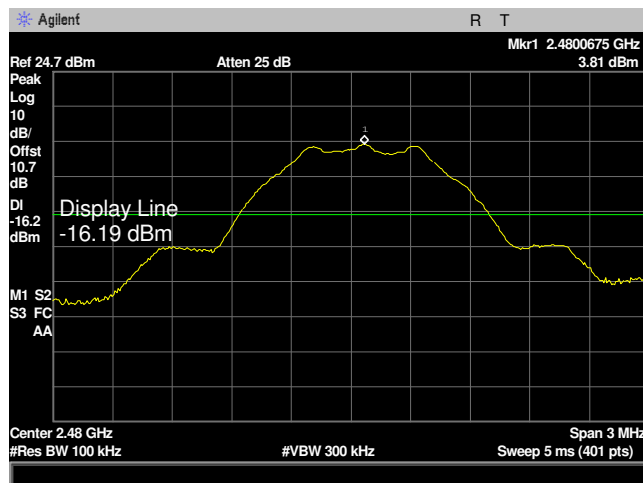
Plot 26: RF Conducted Band Edge, 2480MHz High Channel

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(e) Peak Power Spectral Density

Test Requirements: §15.247(e): For digitally modulated systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission.

Test Procedure: The transmitter was connected directly to a Spectrum Analyzer through an attenuator. The power level was set to the maximum level throughout each of the 100 sweeps of power averaging. The RBW was set to 3 kHz and a VBW set to 9 kHz or greater. The spectrum analyzer was set to an auto sweep time and a peak detector was used. Measurements were carried out at the low, mid and high channels.

Test Results: The EUT **completed testing** to the requirements of § 15.247 (e). No anomalies noted.

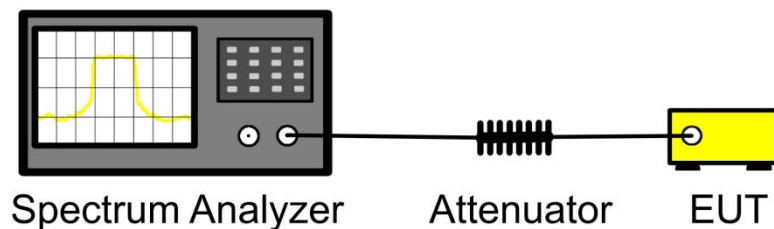
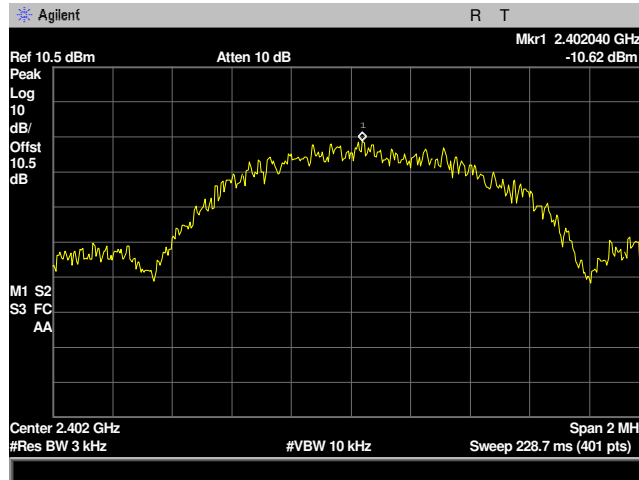


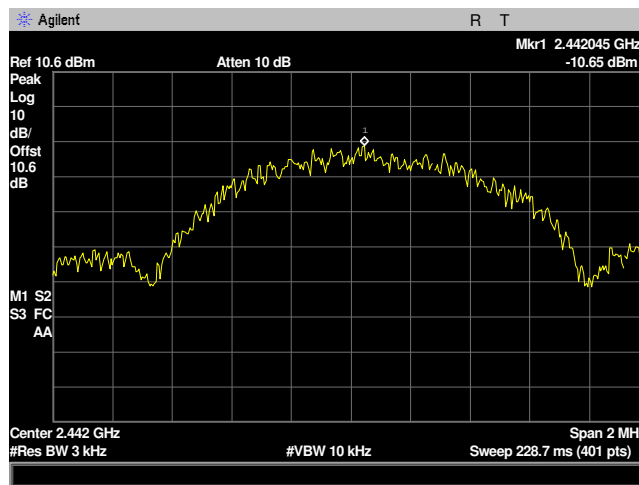
Figure 8: Block Diagram, Peak Power Spectral Density Test Setup

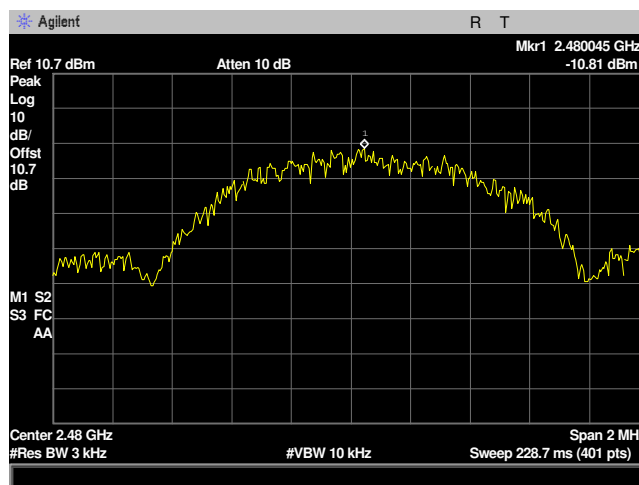
