

1. The modular transmitter must have its own RF shielding.	NA
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in BlueCore5-Multimedia External Chipset. Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the D410XX. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The D410XX meets the FCC antenna requirements. It uses PCB antenna.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The D410XX was tested in a stand-alone configuration. Please see conducted set-up photo.pdf and spurious set-up photo.pdf
