2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in BC57E687C. Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the iBT-05. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The iBT-05 meets the FCC antenna requirements. It uses a PCB type meander line antenna.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The iBT-05 was tested in special host. Please see the description of the host in the test report.pdf and the setup photo.pdf.
