Dear Examiner:

The Nokia **PCS RRH 4x30W** was previously authorized for single carrier LTE-TDD operation over the PCS spectrum 1930 – 1995 MHz. The purpose of this Class II Permissive Change application, under AS5BBTRX-22, is to obtain FCC authorization to add 5G-NR operation for 5 MHz, 10 MHz, 15 MHz and 20 MHz bandwidths with corresponding emission designators 5M00G7W, 10M0G7W, 15M0G7W and 20M0G7W, respectively. The PCS RRH 4x30W also supports Concurrent 5G-NR and LTE operation with two and three carriers (contiguous and non-contiguous) for BW of 5 MHz, 10 MHz, 15 MHz and 20 MHz. This change is by software only.

The **PCS RRH 4x30W** operates as 4x30W MIMO (4T4R), with a total composite RF power of 120 W (50.79 dBm). Four modulation schemes are also supported: QPSK (Quadrature Phase-Shift Keying), 16QAM, 64QAM and 256QAM (Quadrature Amplitude Modulation).

This authorization request is for PCS RRH 4x30W Concurrent operation with 5G-NR and LTE utilizing the bandwidths (BW), modulations and emission designators previously cited, and over the PCS spectrum 1930 – 1995 MHz, subject to PART 24— PERSONAL COMMUNICATIONS SERVICES, Subpart E— BROADBAND PCS. The measurement exhibits attached to this application demonstrate full compliance with FCC Part 24, Subpart E, following the procedural requirements specified in FCC Part 2, Subpart J – Equipment Authorization Procedures. The data, summarized below, is in the form presently used by the Commission's Radio Equipment List.
