1.2 Characteristics of Device:

The EUT is a 5-channel FM transmitter designed to transmit audio signals over the FM frequency band to enable users to listen to audio from an independent video system over the existing car audio system via the radio. The frequencies are 88.3, 88.7, 89.1, 89.5 and 89.9MHz.

1.3 Test Methodology

Both conducted and radiated testing was performed according to the procedures in chapter 13 of ANSI C63.4 (2003)

The equipment under test was operated in its normal operating mode for the purpose of the measurements. The test signal is 1kHz standard test audio signal.

The receiving antenna polarized horizontally was varied from 1 to 4 meters and the wooden turntable was rotated through 360 degrees to obtain the highest reading on the field strength meter or on the display of the spectrum analyzer. And also, each emission was to be maximized by changing the orientation of the equipment under test.

1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located on the roof top of Building at No.34, Lin 5, Ding Fu Tsun, Linkou Hsiang, Taipei Hsien, Taiwan, R.O.C.

This site has been fully described in a report submitted to your office, and accepted in a letter dated Oct. 20, 2005.

2. DEFINITION AND LIMITS

2.1 Definition

Intentional radiator:

A device that intentionally generates and emits radio frequency energy by radiation or induction.

2.3 Limitation

(1) Conducted Emission Limits :

Except for Class A digital devices, for equpment that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150kHz to 30MHz shall not exceed the limits in the following table, as measured using a 50μ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the band edges.

Field strength limits are at the distance of 3 meters, emissions radiated outside of the specified bands, shall be according to the general radiated limits in 15.209, as following table:

As shown in 15.35(b), for frequencies above 1000MHz, the field strength limits are based on average detector, however, the peak field strength of any emission shall not exceed the maximum permitted average limits, specified above by more than 20 dB under any condition of modulation.

(3) Antenna Requirement :

For intentional device, according to \S 5.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

(4) Emissions Band Limits :

According to 15.239(a), emissions from the intentional radiator shall be confined within a band 200kHz wide centered on the operating frequency. The 200 kHz band shall lie wholly within the frequency range of 88-108 MHz.

2.4 Labeling Requirement

The device shall bear the following statement in a conspicuous location on the device :

This device complies with part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

2.5 User Information

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.

3. SYSTEM TEST CONFIGURATION

3.1 Justification

For both radiated and conducted emissions, the system was tested in a stand-alone configuration. The peripherals other than EUT were connected in normally standing by situation.

All measurement were intentional to maximum the emissions from EUT by varying the connection cables, therefore, the test result is sure to meet the applicable requirement.

4 RADIATED EMISSION MEASUREMENT

4.1 Applicable Standard

For intentional radiators operation in the band 88 - 108 MHz, the radiated emission shall comply with §(5.239(b) & 15.239(c)).

4.2 Measurement Procedure

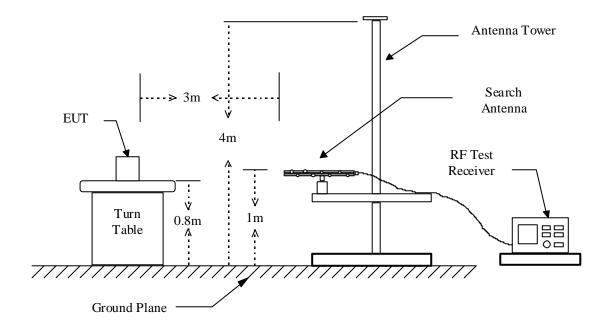
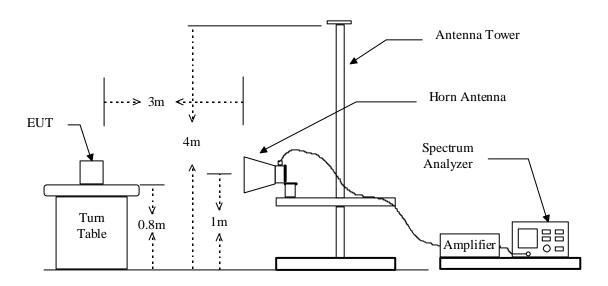


Figure 1 : Frequencies measured at 30MHz to 1 GHz configuration

- 1. Setup the configuration per figure 1 and 2 for frequencies measured below and above 1 GHz respectively.
- 2. For emission frequencies measured below 1 GHz, a pre-scan is performed in a shielded chamber to determine the accurate frequencies of higher emissions will be checked on a open test site. As the same purpose, for emission frequencies measured above 1 GHz, a pre-scan also be performed with a 1 meter measuring distance before final test.
- 3. For emission frequencies measured below and above 1 GHz, set the spectrum analyzer on a 100 kHz and 1 MHz resolution bandwidth respectively for each frequency measured in step 2.
- 4. The search antenna is to be raised and lowered over a range from 1 to 4 meters in horizontally polarized orientation. Position the highness when the highest value is indicated on spectrum analyzer, then change the orientation of EUT on test table over a range from 0° to 360° with a speed as slow as possible, and keep the azimuth that highest emission is indicated on the spectrum analyzer. Vary the antenna position again and record the highest value as a final reading. A RF test receiver is also used to confirm emissions measured.
- 5. Repeat step 4 until all frequencies need to be measured were complete.
- 6. Repeat step 5 with search antenna in vertical polarized orientations.
- 7. Check the three frequencies of highest emission with varying the placement of cables associated with EUT to obtain the worse case and record the result.

4.5 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. For the limit is employed average value, therefore the peak value can be transferred to average value by subtracting the duty factor. The basic equation with a sample calculation is as follows:

Peak = Reading + Corrected Factor

where

Corr. Factor = Antenna Factor + Cable Factor - Amplifier Gain (if any)

5 CONDUCTED EMISSION MEASUREMENT

5.1 Standard Applicable

This EUT is excused from investigation of conducted emission, for it is powered by DC 12V. According to § 5.207 (c), measurements to demonstrate compliance with the conducted limits are not required for devices which only employ battery power for operation and which do not operate from the AC power lines or contain provisions for operation while connected to the AC power lines.

For intentional device, Line Conducted Emission Limits are in accordance to § 5.207(a)

6 ANTENNA REQUIREMENT

6.1 Standard Applicable

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

6.2 Antenna Construction

The antenna is permanently mounted on EUT, no consideration of replacement.

7 EMISSION BAND MEASUREMENT

7.1 Standard Applicable

According to 15.239(a), emissions from the intentional radiator shall be confined within a band 200kHz wide centered on the operating frequency. The 200 kHz band shall lie wholly within the frequency range of 88-108 MHz.

7.2 Measurement Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT as shown in figure 1 and measurement the turn on the EUT. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
- 3. Set both RBW and VBW of spectrum analyzer to 10 kHz and 100kHz respectively with a convenient frequency span including 200kHz bandwidth of the emission.
- 4. Mark the bandwidth of 200kHz points and plot the graph on spectrum analyzer.
- 5. Repeat above procedures until all measured frequencies were complete.

Test result:

The 26 dB bandwidth of 88.3 MHz = 155 kHz < 200 kHz. The 26 dB bandwidth of 89.9 MHz = 158 kHz < 200 kHz. The 200 Khz band lie wholly within the frequency range of 88-108 MHz.

- **1.** Bandwidth test was done with 1 kHz audio modulation input signal and the input level was adjusted to the maximum modulation. There is no user-controlled function.
