Re-Linking:
If the shutter is inactive for 5 minutes, it will go into "Power off" mode. To use the shutter again, press and hold the button for 4 seconds to power it on and it will automatically re-link to your iPhone.

Rétablissement de la connexion: Si la télécommande est inactive pendant 5 minutes, elle passera en mode « hors tension ». Pour utiliser à nouveau la télécommande, appuyez sur le bouton et maintenez-le enfoncé pendant 4 secondes pour l'allumer et la liaison sera automatiquement rétablie avec votre iPhone.

Revinculación:
Si el obturador permanece inactivo 5 minutos, entrará en modo "Apagado". Para usar el obturador de nuevo, presione y mantenga el botón 4 segundos para encenderlo y se revinculará a su iPhone automáticamente.

Neuverbinden:
Wenn der Shutter fünf Minuten lang inaktiv ist, fährt er herunter. Um den Shutter wieder zu verwenden, drücken und halten Sie den Knopf vier Sekunden lang, um ihn hochzufahren. Der Shutter verbindet sich automatisch mit Ihrem iPhone.

Troubleshooting: If you are experiencing issues with the shutter operating properly, use a paper clip or pen tip to press and hold the RESET button located on the side of the unit for 2 seconds. If it still malfunctions, it may be due to a weak battery. Install a new CR2032 battery into the remote and try again.

Résolution des problèmes: Si la télécommande ne fonctionne pas correctement, utilisez un trombone ou la pointe d'un stylo pour appuyer sur le bouton RESET (réinitialisation) situé sur le côté de l'appareil pendant 2 secondes et maintenez-le enfoncé. Si'il ne fonctionne toujours pas, la pile est peut-être déchargée. Installez une nouvelle pile CR2032 dans la télécommande et essayez à nouveau.

Solución de problemas: Si está experimentando problemas con el correcto funcionamiento del obturador, use un clip o la punta de un bolígrafo para presionar y mantener el botón RESET situado en el lateral de la unidad durante 2 segundos. Si aun así no funciona correctamente, puede ser debido a la baja batería. Instale una pila CR2032 nueva en el mando e inténtelo de nuevo.

Problemlösung: Wenn Sie Problemen bei dem Betrieb Ihres Shutters begegnen, drücken Sie den Reset-Knopf an der Seite des Geräts zwei Sekunden lang mit einer Büroklammer oder einer Bleistiftspitze herunter. Wenn immer noch Funktionsstörungen auftreten, kann dies an einer nachlassender Batterieleistung liegen. Bitte legen Sie zwei neue CR2032 in die Fernbedienung ein und versuchen Sie es erneut.
