## 2. System Test Configuration

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. the Tx frequency was fixed which was for the purpose of the measurements.

### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2009. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and average detector mode.

#### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2009.

### 2.4 Limitation

#### (1) Channel Separation test

**Fig. 2-1 Configuration of Tested System**

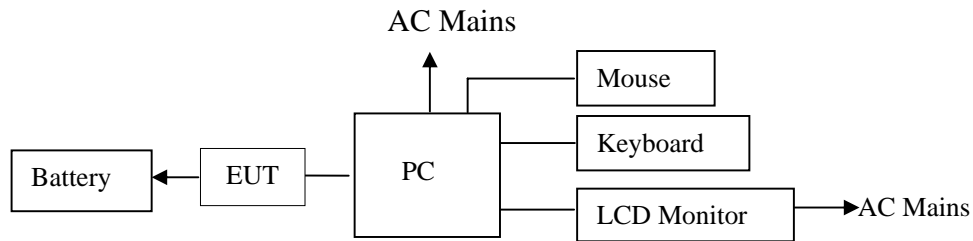

### 4. Description of test modes

The EUT (CAR AUDIO) has been tested under normal operating condition.

This EUT is a FHSS system, we use blue test to control the EUT with parallel port, Let EUT hopping on and transmit at every channel with highest power, Only output power use conducted method, others are using radiated method. After sirfdemo330R1 send the command to EUT, it can be removed, and the EUT keep hopping. 79 Channels are provided by EUT. The 3 channels of lower, medium and higher were chosen for test.

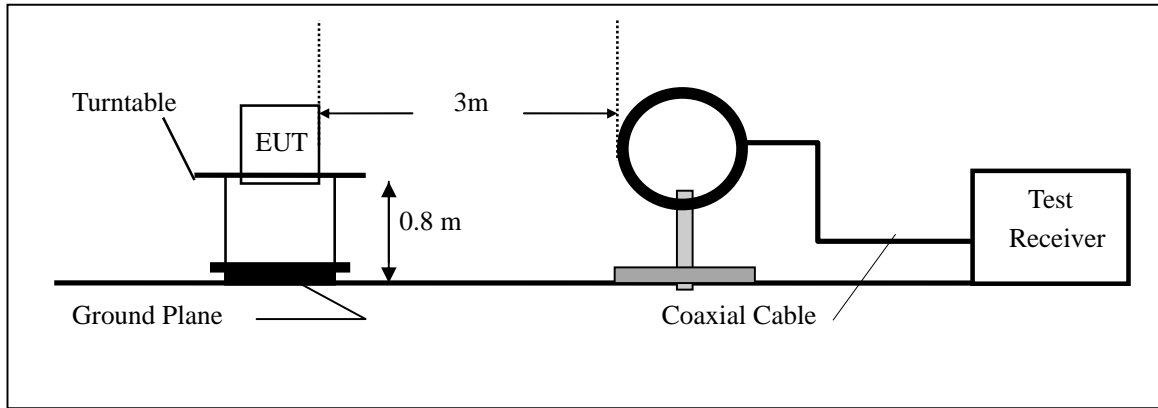
## **5. Radiated Emission Test**

### **5.1 Measurement Procedure**

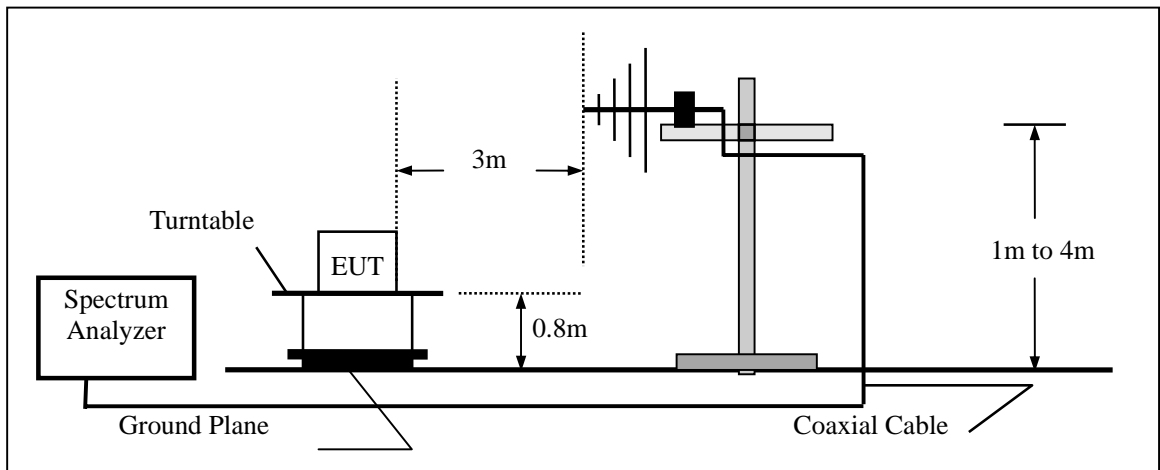
1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
4. Repeat above procedures until all frequency measured were complete.

### 5.2 Test SET-UP (Block Diagram of Configuration)

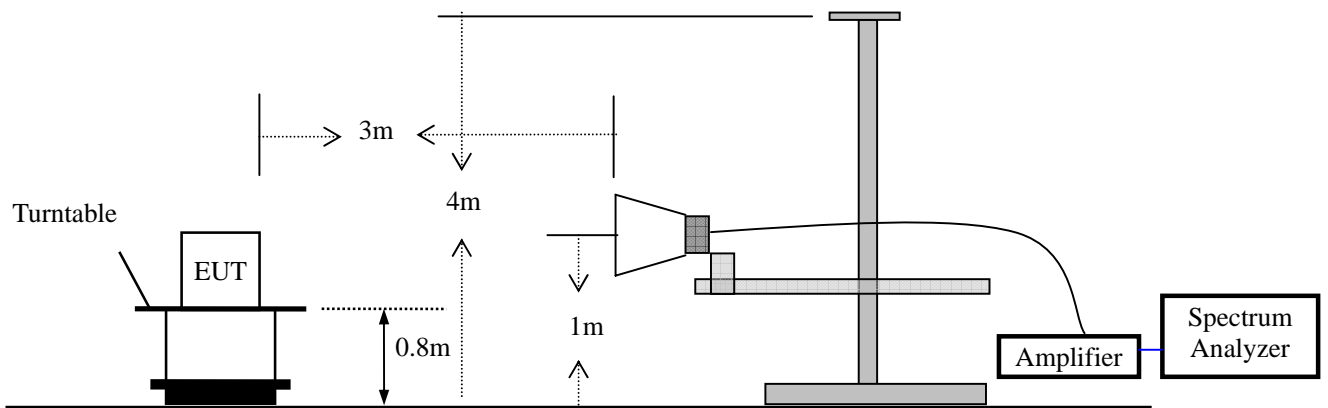
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

## 9. Time of Occupancy (Dwell Time) test

### 9.1 Test Description

The Equipment Under Test (EUT) was set up to perform the dwell time measurements. The EUT was connected to the spectrum analyzer via a short coax cable. The dwell time is calculated by:

$$\text{Dwell time} = \text{time slot length} * \text{hop rate} / \text{number of hopping channels} * 31.6\text{s}$$

with:

- hop rate =  $1600 * 2/\text{s}$  for DH1 packets =  $800 \text{ s}^{-1}$
- hop rate =  $1600/4 * 1/\text{s}$  for DH3 packets =  $400 \text{ s}^{-1}$
- hop rate =  $1600/6 * 1/\text{s}$  for DH5 packets =  $266.67 \text{ s}^{-1}$
- number of hopping channels = 79
- $31.6 \text{ s} = 0.4 \text{ seconds multiplied by the number of hopping channels} = 0.4 \text{ s} * 79$

The highest value of the dwell time is reported.

### 9.2 Test Requirements / Limits

FCC Part 15, Subpart C, §15.247 (a) (1) (iii)

Frequency hopping systems in the 2400-2483.5 MHz band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Since the Bluetooth technology uses 79 channels this period is calculated to be 31.6seconds. Refer to attached data chart.

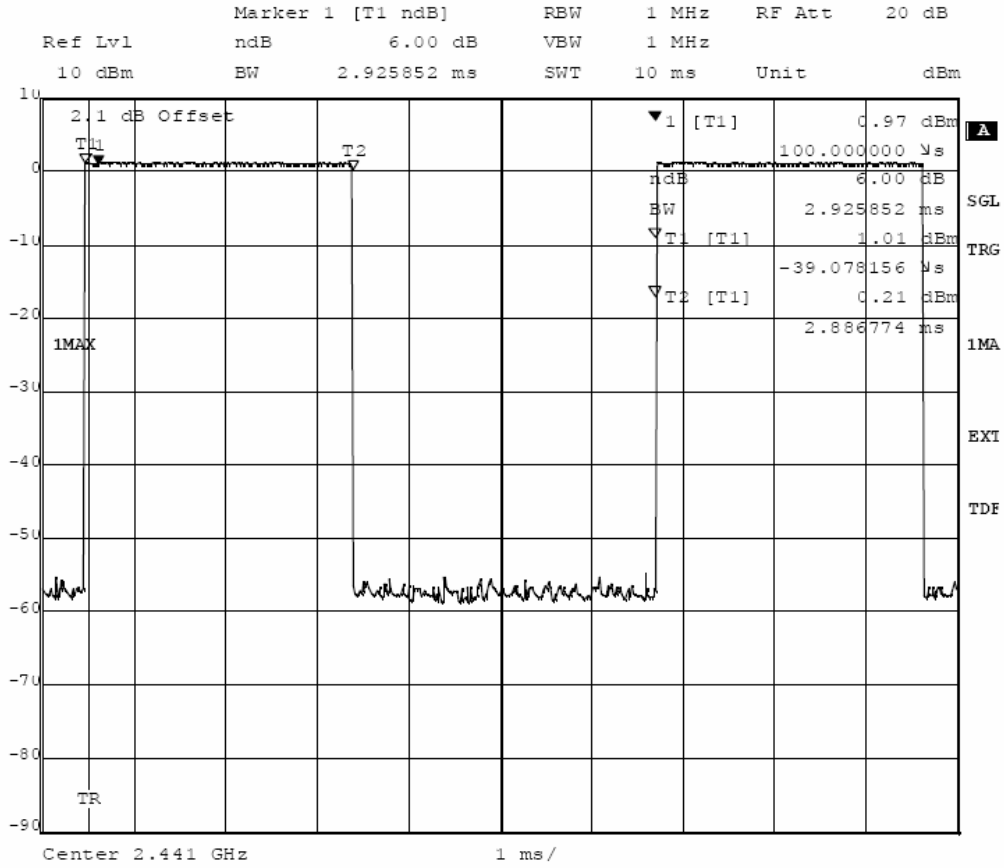

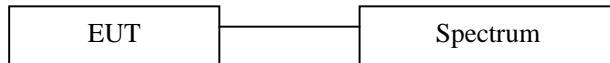

## 10. MAXIMUM PEAK OUTPUT POWER TEST

### 10.1 Measurement Procedure

- a. Check the calibration of the measuring instrument(SA) using either an internal calibrator or a known signal from an external generator.
- b. Turn on the EUT and connect it to measurement instrument. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- c. The center frequency of the spectrum analyzer is set to the fundamental frequency and using proper RBW and VBW setting.
- d. Measure the captured power within the band and recording the plot.
- e. Repeat above procedures until all frequencies required were complete.

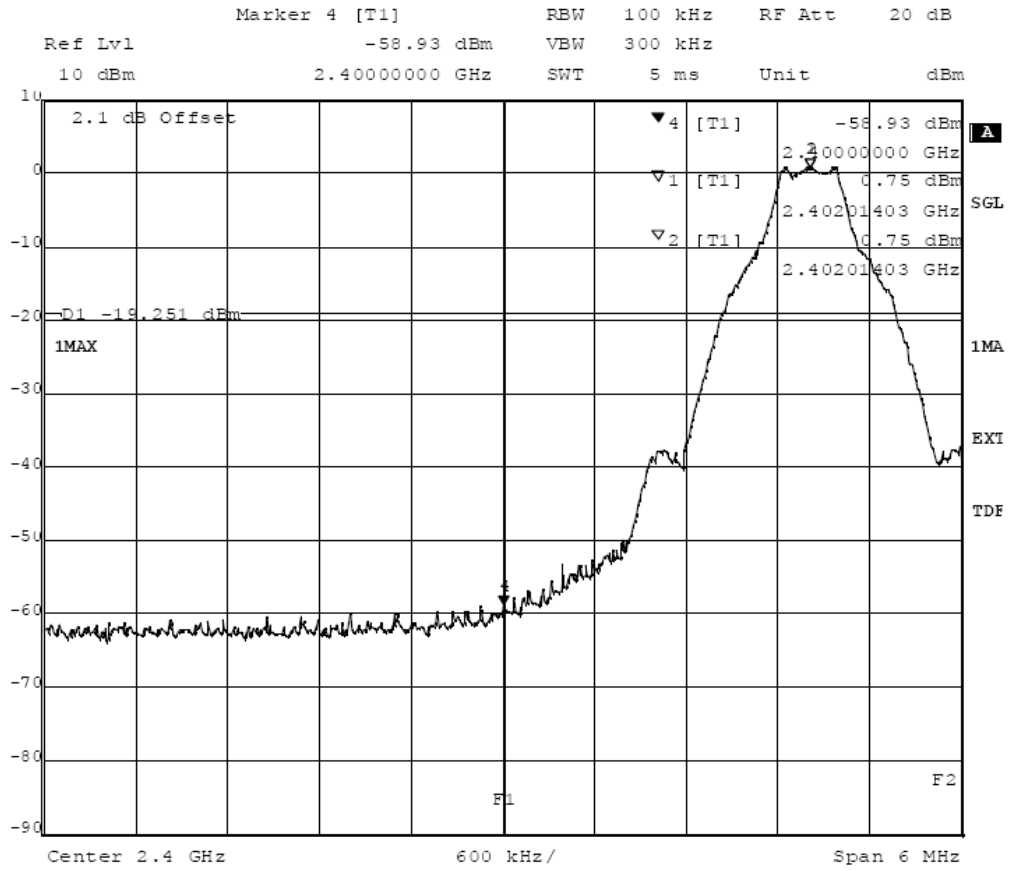

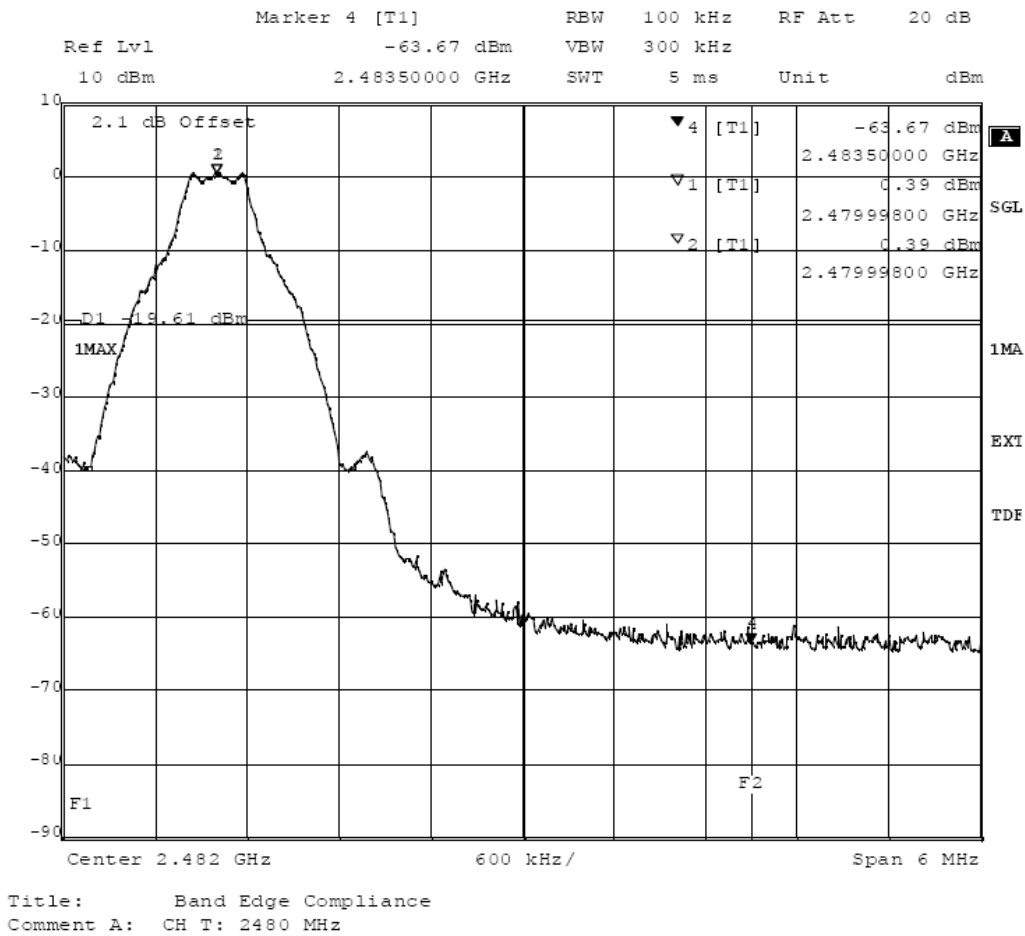

## 12. Antenna Application

### 12.1 Antenna requirement

The EUT'S antenna is met the requirement of FCC part 15C section 15.203 and 15.240.

FCC part 15C section 15.247 requirements:

Systems operating in the 2402-2480MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

### 12.2 Result

The EUT's antenna used a chip antenna and integrated on PCB, The antenna's gain is -2.34dBi and meets the requirement.
