Welcome

Welcome to the world of Motorola digital wireless communications! We are pleased that you have chosen the Motorola HC700-L wireless Handheld Computer.

The HC700-L unique functionality and features make this state-of-the-art device, superior for use in a wide range of data collection and management applications.

This manual covers the basic operations and use of the HC700-L. However, evaluation of the HC700-L performance can be fully achieved by referring to Microsoft[®] Pocket PC[®] documentation and using the demo software applications provided with the HC700-L.

What is the HC700-L Handheld Computer?

The HC700 is a rugged handheld computer. The HC700 is designed for field applications where fast data acquisition and exchange is required.

The HC700-L serves as a Personal Digital Assistant (PDA) that enables portable access to Microsoft Pocket PC 2003 applications. It contains a built-in imager (camera) capable of reading 1D and 2D barcode (optional) labels. The imager can also capture handwritten images such as signatures and correlate the signature to an adjacent barcode.

Wireless communication enables access to the outside world through 802.11b/g Wireless Local Area Network (WLAN, WiFi).

Data exchange with peripheral wireless equipment can be established through Wireless Personal Area Network (WPAN) using Bluetooth[®] radio. Personal wireless equipment may include printers and body-worn devices such as the Hands Free Imager HFI200 - a small size imager/barcode reader, worn on two fingers.

When docked in a cradle, the HC700-L supports RS232 and USB (1.1) serial communication with a host computer (USB

via Microsoft ActiveSync[®]) or a dial-up modem. Ethernet connection can be established through 10/100 base T interface via multi-slot communication cradles. The HC700-L can also communicate through a built-in IrDA port.

The HC700-L is equipped with a QVGA 3.5 inch transflective TFT display, built to withstand high impact. Display backlight is designed to enable clear screen visibility under varied light conditions.

A touch-screen enables easy on-screen menu navigation, in addition to using keypad navigation. The keypad uses an adjustable backlight illumination, designed for low-light working conditions.

The HC700-L is powered by an 1800 mAh 7.2V Lithium-Ion battery pack. The battery is fully recharged within four hours when the HC700-L is docked in a cradle.

A drained battery can be replaced without data loss from the HC700-L memory ("hot swap"). A built-in power source, independent of the battery pack, maintains the data in the HC700-L memory for at least 5 minutes until a fresh battery is placed.

The HC700-L may use a line of Motorola docking cradles for network communications and power charging.

The personal desktop cradle is designed for office use of the HC700-L. The eight and four slot charging/communication cradles provide multi-slot docking in large operations. The vehicle cradle is used for the mobile applications of the HC700-L, allowing charging while driving.

For detailed description, installation and operation of each cradle, refer to the specific user manual of each cradle.

Unpacking

The HC700-L basic package includes the following items:

- 1800 mAh 7.2V Lithium-Ion battery pack
- Stylus
- Hand-strap

- This Owner's Manual
- Safety and General Information leaflet, Motorola P.N., 6802978C77

Optional items include:

- Spare stylus (pack of 5)
- Tethered stylus
- Cigarette lighter power cable
- Vehicle DC cable
- Mini Secure Digital (SD) memory card
- Software Development Kit (SDK)

Carefully unpack each item from the shipping carton. Check all items for shipping damage, and check that you have received all items ordered.

Note: Retain the original carton packaging in the event that the HC700-L should need to be returned for service.

The HC700-L is shipped with a plastic film, protecting the screen. Before usage, remove the film and use a soft cloth to buff the screen. A clean screen ensures smooth gliding of the stylus over the surface.

Charging the Battery

The battery is charged when the HC700-L is docked in the cradle. When using a Personal Desktop Cradle, a stand-alone battery can be charged in the battery charging slot.



A fully charged battery provides 10 continuous hours of

typical usage or 24 hours in Standby mode.

New batteries are shipped partially charged.

Always use Motorola HC700-L original batteries and battery chargers.

The HC700-L warranty does not cover damage caused by using non-Motorola batteries and/or battery chargers.

The following sections describe the installation and charging of the battery of the HC700-L.

The battery or HC700-L may carry warning symbols, defined as follows:



Important safety information will follow.



Your battery or HC700-L should not be disposed of in a fire.

Battery Replacement

When the battery is drained, the HC700 automatically enters "Critical Low Battery" state and shuts down all functions (the screen turns off) to preserve the data in its memory.

The HC700-L allows you to replace batteries without losing information stored in its memory ("hot swap"). To avoid losing data stored in the memory, a fresh battery must be installed within five minutes after removing the drained battery.

To replace a battery perform the following steps:

- 1. Hold down the Power Button for at least four seconds until the HC700-L screen turns off.
- 2. Remove the HC700-L hand-strap (see Figure 4).
- 3. Press the battery snap on the battery (see Figure 4) and pull away the battery from the HC700-L.
- 4. Insert a fresh battery, bottom end first, into the battery compartment.
- 5. Carefully, press the battery top downward until it clicks and locks in place.
- 6. Press the Power Button the HC700-L is now ready for use.

First Time Battery Charge

Charge the battery before using the HC700-L for the first time until the status LED inside the Power Button shows steady green. While charging for the first time, the Status LED starts flashing orange and turns to steady read. When battery is fully charged, the LED shows steady green.

The HC700-L Cradle charges the battery most effectively when it is at room temperature [approx. 68°F (20°C)]. The rec-

ommended battery charging temperature range is 32°F to 95°F (0°C to 35°C).

Routine Battery Charge

A battery is recharged to 90% of its full capacity after approximately three and a half hours. The battery is fully charged after four hours. During the charge, the Status LED inside the Power Button shows steady red and turns green when charging is completed.

Important: The battery will not charge if the HC700-L is not properly docked in the cradle.

Battery Maintenance

The performance of the battery depends on the way the battery is treated. Therefore, to comply with Motorola Warranty for batteries and to assure high performance and a long life for the rechargeable battery, please read and follow the battery maintenance instructions described in the following sections.

Battery Storage

Do not store the battery in locations where the temperature exceeds 140°F (60°C) or falls below -4°F (-20°C).

Batteries that have never been charged before may be stored uncharged for up to three months in well-ventilated, cool, dark, and dry areas without significant loss of lifespan.

Batteries which have already been charged and then stored for more than two months should be recharged before use.

New batteries or batteries that have been stored for a long time may require a longer charging time.

Extending Battery Life

Battery performance depends on many factors, including the temperature at which you operate your handheld computer; the features and/or settings you select and use; peripherals

attached to the computer and other application usage patterns.



To prevent injuries or burns, do not allow metal objects to come in contact with or short-circuit the battery contacts.

The HC700-L cradles will charge the battery most effectively when it is at room temperature [approx. $68^{\circ}F$ (20° C)]. Recommended battery charging temperature range is $32^{\circ}F$ to $95^{\circ}F$ ($0^{\circ}C$ to $35^{\circ}C$).

Batteries are expendable parts and gradually wear down and require longer charging times. This is normal. If you charge your battery regularly and notice a decrease in usage time or an increase in charging time, then it is probably time to switch to a new battery.

To ensure maximum service life of the HC700-L, always replace the battery with a genuine Motorola replacement.

Battery Disposal

Batteries must be recycled or disposed of properly in accordance with local requirements. Recycling facilities may not exist in all areas. Please contact your local environmental agency for more information regarding proper disposal.

Using the HC700-L

Starting to Work

Place the battery in the HC700-L to boot-up and press the Power Button (see Figure 1) to turn on the HC700-L; the Motorola logo will show for about 30 seconds and Windows Mobile screen will appear. The Windows Mobile screen will ask the user to tap on the screen and will instruct to follow the Align Screen procedure (touch screen calibration).

Note: Some applications may work in so-called "kiosk mode", preventing the user from accessing Windows standard functions.

Turning On

Whenever the HC700-L screen is off, press the Power Button (see Figure 1) to turn on the HC700-L and resume operation.

Important: <u>do not</u> press the Power Button when the HC700-L is out of the cradle and the Status LED (inside the Power button) is red.

Turning Off

Turn off the HC700-L when not in use for long duration and when charging is not available.

To turn off the HC700-L perform the following:

While the HC700-L is turned on, hold down the Power Button for at least four seconds - the HC700-L will store the information of the last used program screen and will shift to off mode - no information will be lost.

Once turned on again, the HC700-L will return to the last program screen that was in use.

Suspend Mode

Use Suspend mode as often as possible during daily use to conserve battery power. For power saving, the HC700-L will automatically turn to Suspend after 1 minute (default). To configure the time duration before the HC700-L enters Suspend mode, go to: *Start Menu->Settings->System->Power->Advanced* (duration range is 0 to 5 minutes).

To manually shift to Suspend mode - while the HC700-L is turned on, momentarily press the Power Button (see Figure 1).

During Suspend mode the display turns off and the status LED inside the Power Button slowly flashes green. To resume operation, momentarily press the Power Button again.

In Suspend mode, the battery power is conserved by automatically turning off the display and the computer sections of the HC700-L. During Suspend mode, the Bluetooth radio continues to operate. When the HC700-L resumes operation, it returns to the program screen shown prior to entering Suspend mode.

The Status LED

The status LED, located inside the Power Button (see Figure 5), may show three colors to indicate the HC700-L power status.

The LED indications

are not identical and have different meaning when the HC700-L is used outside of the cradle and when docked in the cradle.

LED indications when HC700-L is used out of the cradle

Table 1: Status LED Indications When HC700-L is used out of the Cradle

LED Indication	Description
Slowly flashing green	HC700-L is in Suspend mode
Fast flashing green	HC700-L display is off
Steady red for 5 sec- onds	HC700-L is booting-up following battery replacement Important!: to avoid system failure, <u>do</u> not remove the battery during boot-up
Flashing yellow	Low battery voltage or battery tempera- ture or is out of range

LED Indications when HC700-L is docked in the cradle

Table 2: Status LED Indications When HC700-L is docked in the Cradle

LED Indication	Description
Steady red	Battery is charging
Steady green	Battery is fully charged
Flashing yellow	Battery temperature or voltage is out of range - battery charging has stopped. Charging will resume when temperature or voltage is back within range
Flashing red	Charging error/defective battery. Re- install the HC700-L in the cradle If the LED continues to flash red, replace the battery
Steady orange	HC700-L is communicating with host

The Application LED

The Application LED may be used for any kind of application notification. For example; the LED may show communication indication when the application establishes connection with a host computer or indicate an alert that needs to be handled. For more information, refer to your software application guide and the HC700 Software Development Kit (SDK).

Using the Keypad

The HC700-L keypad enables the user to enter both alphabetic and numeric data to the software application. However, since the keypad can only contain a limited number of keys, some special keys are assigned to perform special tasks that are usually found on full-size computer keyboards. These are produced using a combination of the existing keys on the HC700-L keypad.

Two sets of keys exist on the HC700-L:

- 1. Keys active when in Alphabetic mode, which are those seen on the overlay of the HC700-L keypad.
- 2. Keys active when in Shift or Function mode, which are those seen next to each key on the HC700-L keypad panel.

Press the <SHIFT> key to toggle between the Alphabetic and Numeric keypad modes. Figure 7 shows the HC700-L keypad and Table 3 describes the HC700-L keys assignment.

Key	Function
TAB	Use the <tab></tab> key when editing text.
ESC	Use the <esc></esc> key to exit from a menu or an application.

Turning the Screen Backlight On & Off

Hold down the <SHIFT> for two seconds - the screen backlight will turn on. To turn off - hold down for another two seconds.

When not in use, the backlight turns off automatically. To configure the screen illumination duration, go to: *Start Menu-Settings->System->Backlight*.

Keypad Backlight Adjustment

The keypad backlight can be adjusted by holding down the

<SHIFT> key and pressing the right or left bumps (

Turning the Keypad Backlight On & Off

Hold down the <SHIFT> key for four seconds - the keypad backlight will turn on.

To turn off - hold down the $\langle SHIFT \rangle$ key for another two seconds.

When not in use, the backlight turns off automatically. To configure the keypad illumination duration, go to: *Start Menu->Settings->System->Backlight*.

Calibrating the Touch Screen

To calibrate the touch screen - hold down the \langle SHIFT \rangle and \langle SP \rangle and \langle C \rangle keys and follow the calibrate application instructions to complete your touch screen calibration.

Scanning Barcodes and Capturing Images

The HC700-L houses a digital camera (imager) that captures pictures and scans the most commonly used 1D and 2D barcodes. The HC700-L supports 360° omni-directional capture for easy use in daily work. The imager captures digital images, such as signatures, text or pictures of any object or paper form. The images are stored in the HC700-L memory.

To capture an image:

- 1. Run the Bcr barcode reader application: *Start Menu->Programs->Sample Applications->Bcr.*
- 2. Aim and hold the HC700-L at 2 to 12 inches (5 to 30 cm) distance from the target.
- 3. Press one of the Scan keys and aim the green aiming bar towards the target to adjust your position. Note that when the HC700-L is held closer to the barcode the green aiming bar appears smaller and when held farther from the barcode it appears larger. Barcode symbols with dense symbol elements should be read closer to the HC700-L while large barcodes with larger symbol elements should be read at a larger distance (Depth-of-Field) from the HC700-L.

To capture a barcode, aim the green aiming bar at any angle across the barcode symbol, as shown in Figure 9

Note: When adjusting your position, you may move back and forth from the target to capture the entire object - a successful scan is indicated by a beeping sound.

Resetting the HC700-L

You may need to reset the HC700-L; for example, you may need to reset due to communication cut-off, or if the operating system or the application stops responding.

If the HC700-L stops responding, perform the following steps:

Step 1: Warm Reset

Important Note: When the HC700-L performs Warm Reset, all recorded information remains stored in memory.

Hold down the **<ESC>** and **<A>** and **<F>** keys (see Figure 10) for at least 5 seconds - the Motorola logo will show on the screen for about 30 sec-

onds and then Windows desktop or application screen will appear - the HC700-L functions again.

If the HC700-L still does not respond, perform "Step 2: Cold Reset":

Step 2: Cold Reset

Cold Reset restarts the HC700-L by erasing all stored records and entries.

Do Not perform Cold Reset unless Warm Reset fails to solve the problem.

Hold down the **Power Button** and **<S>** and **<X>** keys for at least 5 seconds (see Figure 11); the HC700-L will restart its operating system.

Mini SD Memory Card

Installing a Mini SD Card

Important: Turn the HC700-L power off before removing or installing the Mini SD (Secure Digital) card.

1. Turn off the HC700-L.

- 2. Remove the cover screw to access the Mini SD card slot (see Figure 12).
- 3. Insert the Mini SD card as shown in Figure 12.

Mini SD Card Handling Precautions

- Use only the supplied Mini SD card.
- Do not bend or apply force to the Mini SD card.
- Do not store the Mini SD card in locations subjected to high humidity or temperatures.

Service

The HC700-L does not contain user serviceable parts. However, the following sections provide maintenance guidelines.

Maintaining the HC700-L

In order to maintain the HC700-L in good working order:

- Do not scratch the screen. Use only Motorola supplied stylus.
- Never use a pen or pencil or any sharp object on the screen.
- Protect the HC700-L from temperature extremes. Do not leave the HC700-L on the dashboard of a car on a hot day, and keep the HC700-L away from hot places.
- Do not store or use the HC700-L in any location that is extremely dusty, damp or wet.

Cleaning

This section details the cleaning instructions for the battery contacts, screen and any other part of the HC700-L.



Before using any of the materials detailed below, refer to the safety instructions shown on the product's label or package.

Cleaning Materials

To clean the HC700-L, use Chemical Pure grade (C.P) "Isopropyl Alcohol (IPA)" also named "Iso Propanol".

You may use Isopropyl Alcohol (IPA) manufactured by Merck, Riedel-de Haen, or any other reputable chemical manufacturer.

It is recommended to use a soft lint free cloth such as Texwipe TX512, BlueWipe cleaning rag/cloth. It is also possible to use optic lens wiping paper such as "rice paper".

Cleaning Procedure

If the battery contacts, screen or surface of the HC700-L becomes dirty, use a soft lint cloth moistened with diluted Isopropyl Alcohol (IPA) solution to remove dirt. The Isopropyl Alcohol (IPA) can be diluted with water up to 20%.

ActiveSync (USB) Connectivity

The ActiveSync over USB enables the user to explore and manage the HC700-L from remote, transfer files (data images etc.) and surf the Internet via host PC.

First Time Connection

In order to enable USB communication with your host PC, Microsoft ActiveSync program must be installed on your PC.

The HC700-L is provided with the ActiveSync program installed. However, the program can be obtained from Microsoft web site. To learn more about most up-to-date version of the ActiveSync and its operation, refer to ActiveSync help.

Connect the USB cable between the HC700-L and PC. Your PC will identify the new connection and will request you to point to the HC700-L software driver (*wceusbsh.inf*) provided with this product.

Routine Connection

Just hook the USB cable from the HC700-L to your PC - the ActiveSync icon will become green and a Partnership window will show. Check the Guest Partnership and click Next to popup the ActiveSync program.
