



#### PSD 100kHz Plot on Channel 19





### PSD 100kHz Plot on Channel 39









Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.





### **High Band Edge Plot on Channel 39**









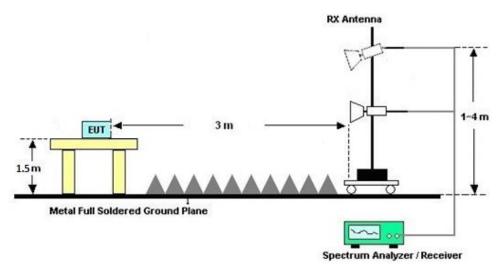
### For radiated emissions below 30MHz



### 3.7 Antenna Requirements




