I, as the applicant, understand and have taken notice of the following.

- (a) The initial standard period for short-term confidentiality is 45 days, counting from the date of issue of the Grant;
- (b) The initial standard period for short-term confidentiality may be extended 3 times (maximum) with another 45 days;
- (c) The applicant shall inform the TCB about the date on which the device will be actually marketed. Such a notification must be received by the TCB at least 7 calendar days before the date of actual marketing. The short-term confidentiality will then terminate on the date of the actual marketing of the device;
- (d) If the initial standard period for short-term confidentiality as under (a) must be extended by another 45 days, the applicant shall inform the TCB about such a request at least 7 calendar days before the expiration date of the initial standard period. Any subsequent extensions of 45 days may be requested up to a maximum of 2 times, where each request must be made to the TCB at least 7 calendar days before the expiration date of each extension;
- (e) If no request from the applicant is received by the TCB for extending the initial standard period of the short-term confidentiality as under (a), the short-term confidentiality will terminate automatically after 45 days, counting from the date of issue of the Grant. If no request from the applicant is received by the TCB regarding any subsequent extensions as under (b), the short-term confidentiality will terminate automatically on the last day on which such extensions are valid;
- (f) The short-term confidentiality, when extended 3 times as under (b), will terminate automatically after 180 days, counting from the date of issue of the Grant.
