#### 2.6 Transmit Power Control (TPC)




### 5 Test Procedure

#### 5.1 DFS Measurement System

A complete DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 10, 11 and 12. The traffic monitoring subsystem is specified to the type of unit under test (UUT).


#### Radiated Setup Configuration of DFS Measurement System

#### Wireless Traffic Loading Duty Cycle




## 5.2 Calibration of DFS Detection Threshold Level

The measured channel is 5500MHz and 5510MHz. The radar signal was the same as transmitted channels, and injected into the antenna of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The calibrated conducted detection threshold level is set to -64dBm. The tested level is lower than required level hence it provides margin to the limit.

The radar signal generate system is gererating waveform pattern of radar types. The amplitude of the radar signal generator system is adjusted to yield a level of – 64 dBm as measured on the spectrum analyzer.






#### Radar Signal 0 802.11n HT20

**Channel Closing Transmission Time & Channel Move Time** 





# **Channel Closing Transmission Time & Channel Move Time**












#### Waveform of EUT links up with Master

Plot of 30minutes period






