GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Porta Phone Company Inc*'s product, model number: *ComSTAR XTC Base(XTCB2015)* (*FCC ID: B4HXTCB2015*) or the "EUT" in this report was a *FULL DUPLEX WIRELESS COMMUNICATION SYSTEM*, was measured approximately: 29.1 cm (L) x23.4 cm (W) x 25.6 cm (H), input voltage: DC 3.7V battery.

* All measurement and test data in this report was gathered from production sample serial number: 20151201 (Assigned by BACL, Shenzhen). The EUT supplied by the applicant was received on 2015-12-01.

Objective

This test report was based on the Electromagnetic Interference (EMI) tests performed on the EUT. The EMI measurements were performed according to the measurement procedure described in ANSI C63.17 - 2013.

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart D, section 15.315, 15.317, 15.319 and 15.323 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.17 - 2013, American National Standard Methods of Measurement of the Electromagnetic and Operational Compatibility of Unlicensed Personal Communications Services (UPCS) Devices.

All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen).

The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.



The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances \leq 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] $\cdot [\sqrt{f_{\text{(GHz)}}}] \le 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- 1. $f_{(GHz)}$ is the RF channel transmit frequency in GHz.
- 2. Power and distance are rounded to the nearest mW and mm before calculation.
- 3. The result is rounded to one decimal place for comparison.
- 4. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test Exclusion.


Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, and it will not be taken into consideration for the test data recorded in the report



The radiated emission tests were performed in the 3 meters test site, using the setup accordance with the ANSI C63.4 - 2014. The specification used was the FCC 15§ 15.319(g).

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

EMI Test Receiver & Spectrum Analyzer Setup

The system was investigated from 30 MHz to 20 GHz.

During the radiated emission test, the EMI test receiver & Spectrum Analyzer Setup were set with the following configurations:

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz and peak and Average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss- Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the maximum limit. The equation for margin calculation is as follows:

Margin = Limit - Corrected Amplitude
