When a measurement is made, the result will be different from the true or theoretically correct value. The difference is the result of tolerances in the measurement system that cannot be completely eliminated. To the extent that technology allows us, it has been our aim to minimize this error. Measurement uncertainty is a statistical expression of measurement error qualified by a probability distribution.

A measurement uncertainty estimation has been performed for each test per our internal quality document WP 342. The estimation is used to compare the measured result with its "true" or theoret ically correct value. The expanded measurement uncertainty (K=2) for each test is listed below. Our measurement data meets or exceeds the measurement uncertainty requirements of the applicable specification; therefore, the test data can be compared directly to the specification limit to determine compliance. The cal culations for estimating measurement uncertainty are based upon ETSI TR 100 028 (or CISPR 16-4-1 as applicable), and are available upon request.

The antennas to be used with the EUT were tested. The EUT was configured for continuous modulated operation at its single transmit frequency. The field strength of the transmit frequency was maximized by rotating the EUT, adjusting the measurement antenna height and polarization, and manipulating the EUT in 3 orthogonal planes (per ANSI C63.10:2009).

TEST DESCRIPTION

The single, integral antenna to be used with the EUT was tested. The EUT was configured for un-modulated, CW operation at its single transmit frequency. The field strength of the transmit frequency was maximized by rotating the EUT, adjusting the measurement antenna height and polarization, and manipulating the ÉUT in 3 orthogonal planes (per ANSI C63.10:2009).

A preamp and high pass filter were used for this test in order to provide sufficient measurement sensitivity.

To derive average emission measurements, a duty cycle correction factor per 15.35(c) was utilized:

Duty Cycle = On time/100 milliseconds (or the period, whichever is less)

Where "On time" = N1L1 +N2L2 +....

Above 1GHz, a resolution bandwidth of 1MHz and a video bandwidth of 3MHz was used.


The field strength of the spurious emissions meet the limits as defined in 47 CFR 15.231(b). The spurious emissions also meet the provisions in 15.35 for averaging pulsed emissions and for limiting peak emissions.
