# COSPAS-SARSAT TYPE APPROVAL CERTIFICATE

**For a 406 Megahertz Distress Beacon  
for use with the Cospas-Sarsat Satellite System**

HEREAS, *ACR Electronics, Inc.*, of *Florida, USA*, the manufacturer of a 406 Megahertz Distress Beacon packaged as a *PLB*, and identified as Model *PLB-100* has submitted test data and had said beacon tested in *April 1999* at a facility accepted by Cospas-Sarsat at *EPG, Fort Huachuca, USA* to demonstrate that said beacon meets the applicable technical requirements for use with the Cospas-Sarsat Satellite System, as defined in documents C/S T.001 "Specification for Cospas-Sarsat 406 MHz Distress Beacons" and C/S T.007 "Cospas-Sarsat 406 MHz Distress Beacon Type Approval Standard"\*\*.

WHEREAS, the Cospas-Sarsat Council has determined, following a review of the test results, that the said beacon meets the Cospas-Sarsat Class *1* requirements and is rated for operating over the temperature range of *-40°C to +55°C*, with battery:

- Blue Star LS-2660*
- Lithium Sulphur Dioxide (LiSO<sub>2</sub>, 3 5/4C-cells)*

WHEREAS, said manufacturer has certified that all other units of the same type will meet said technical requirements in a similar manner to the unit subjected to test, which incorporated the following features:

- *121.5 MHz Auxiliary Radio Locating Device (50 mW, continuous)*
- *External navigation device (GPS)*
- *Self-test mode (one burst of 440 ms, formal flag bit = "1")*

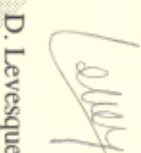
