






Fig.3 EUT Back side to flat phantom






Fig.4 EUT Top side to flat phantom






Fig.6 EUT Right side to flat phantom






Fig.7 EUT Left side to flat phantom








Fig.10 Notebook




Fig.11 Antenna position of EUT (front view)
