

Photograph of the tissue simulant fluid liquid depth (Head)












Fig.3 EUT Back side to flat phantom






Fig.6 EUT Right side to flat phantom






Fig.7 EUT Left side to flat phantom






Fig.8 EUT Bottom side (Laptop mode) to flat phantom






Fig.9 EUT Right side (Book mode) to flat phantom






Fig.10 EUT Left side (Book mode) to flat phantom






