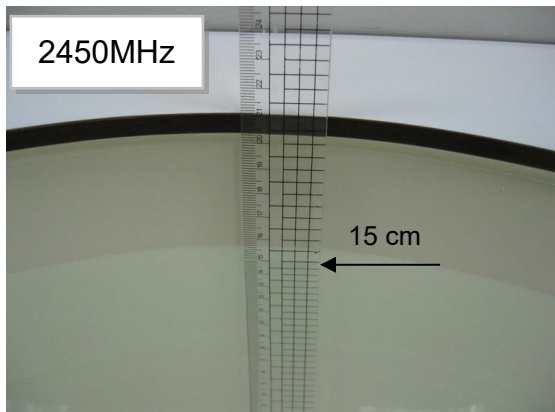

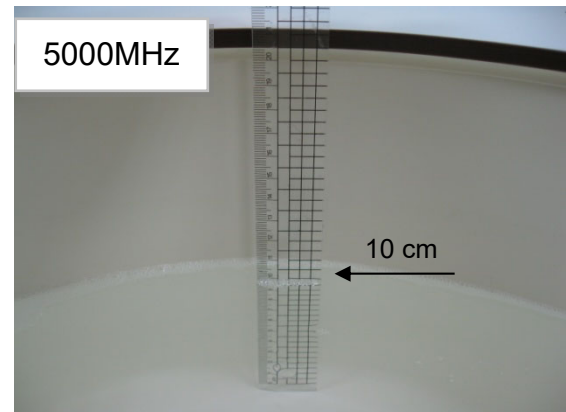

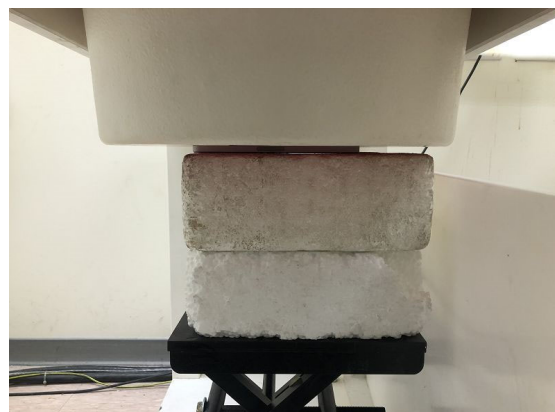
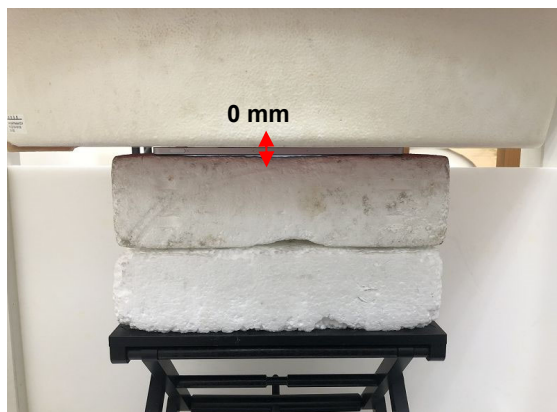


Fig.3 EUT Back side to flat phantom

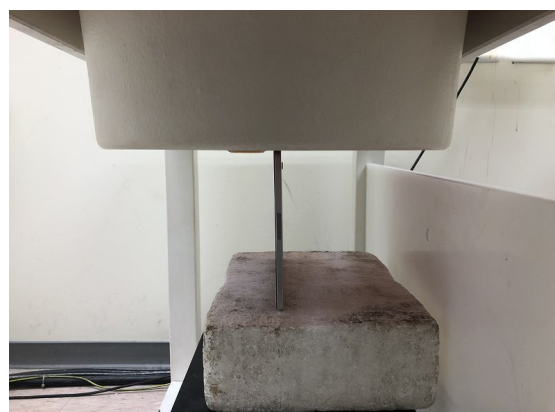
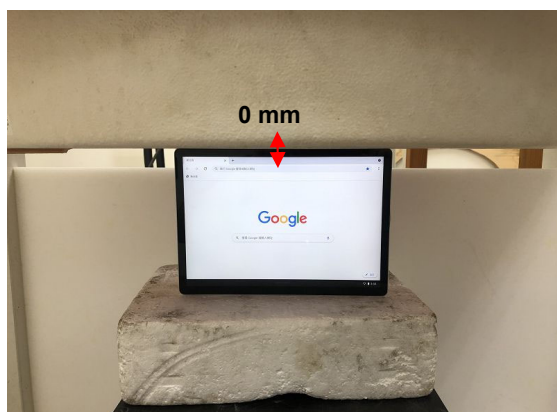


Fig.4 EUT Top side to flat phantom

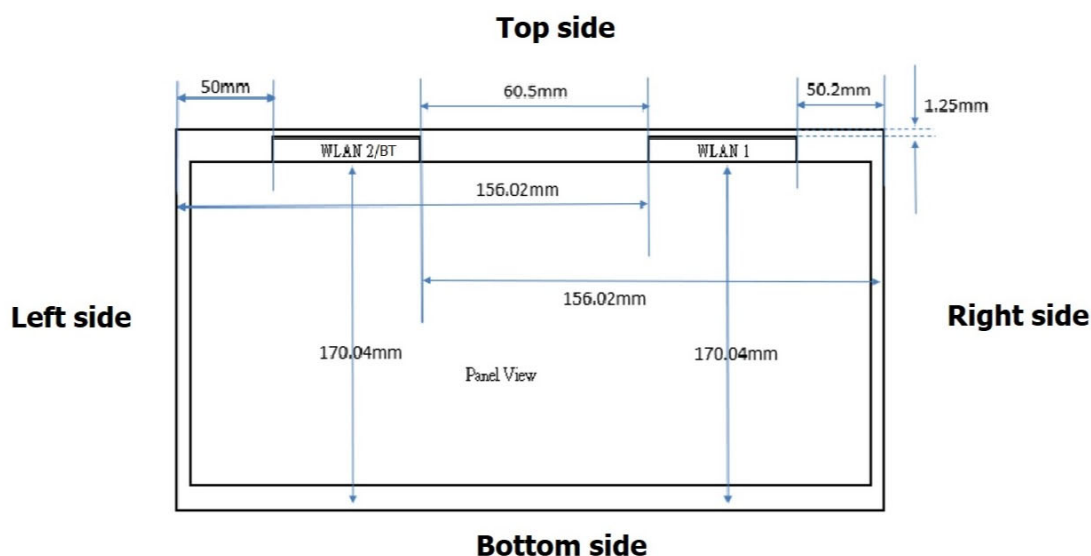


Fig.15 Antenna location of EUT (Tablet mode)

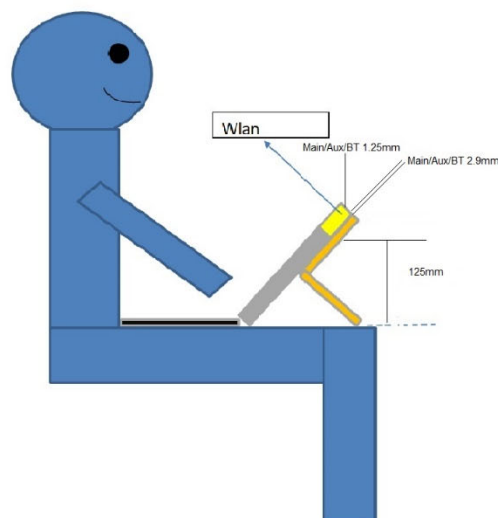
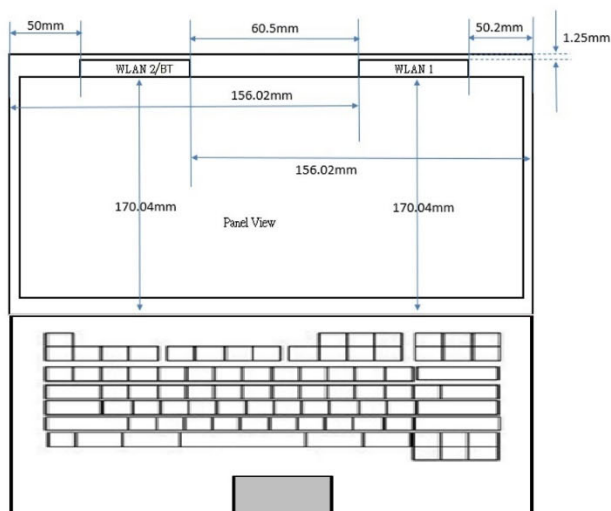


Fig.16 Antenna location of EUT (Notebook mode)
