Antenna port conducted and radiated test items listed below are performed according to KDB 971168 D01 Power Meas. License Digital Systems v03r01 with maximum output power.

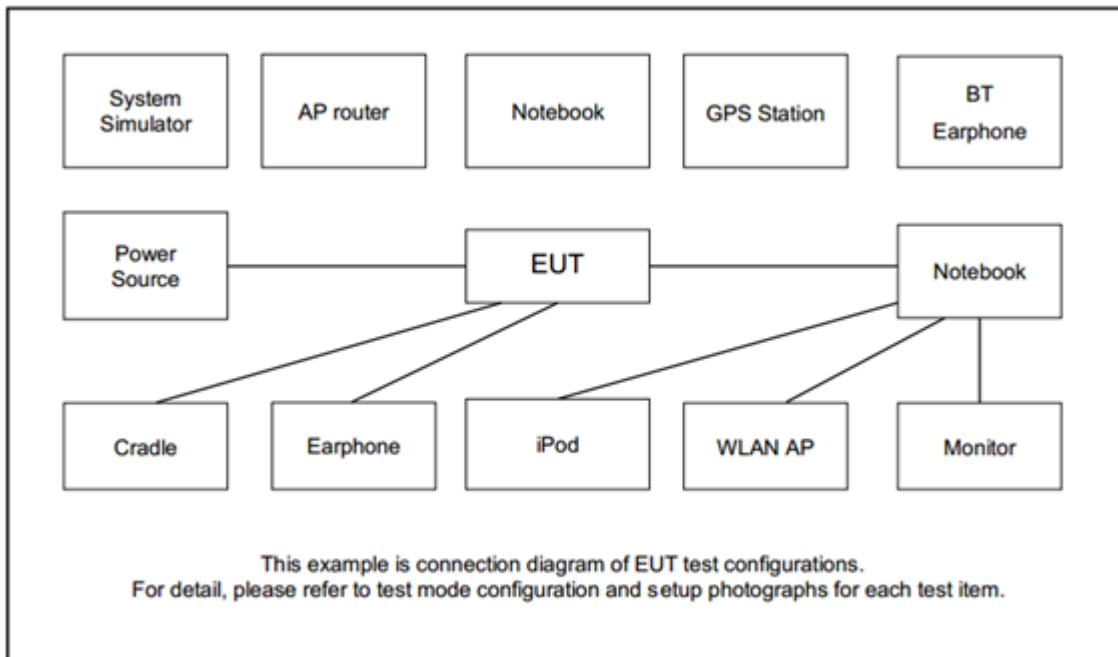
For radiated measurement, pre-scanned in Tablet Mode (three orthogonal panels, X, Y, Z) and Notebook Mode. The worst cases (Notebook Mode for Band 41 (HPUE); Notebook Mode with Accessory for 5G NR n2, 5G NR n5, 5G NR n7 and 5G NR n41 (HPUE) were recorded in this report.

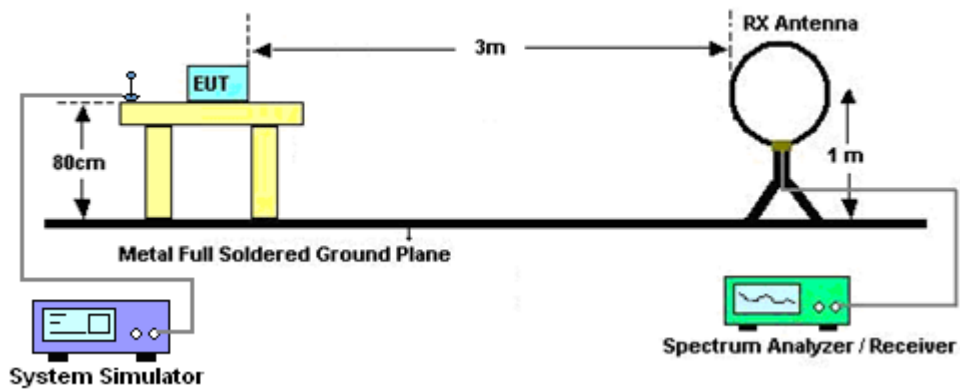

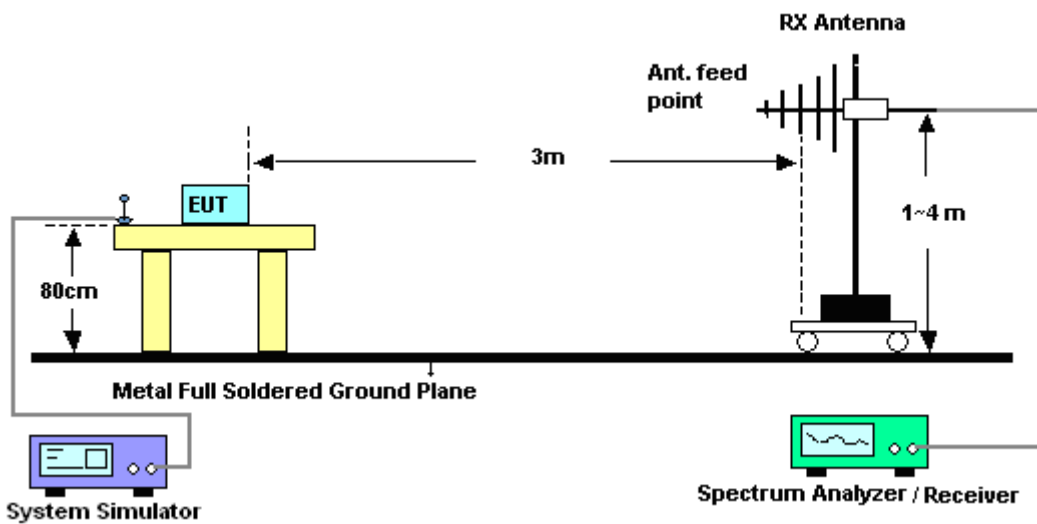

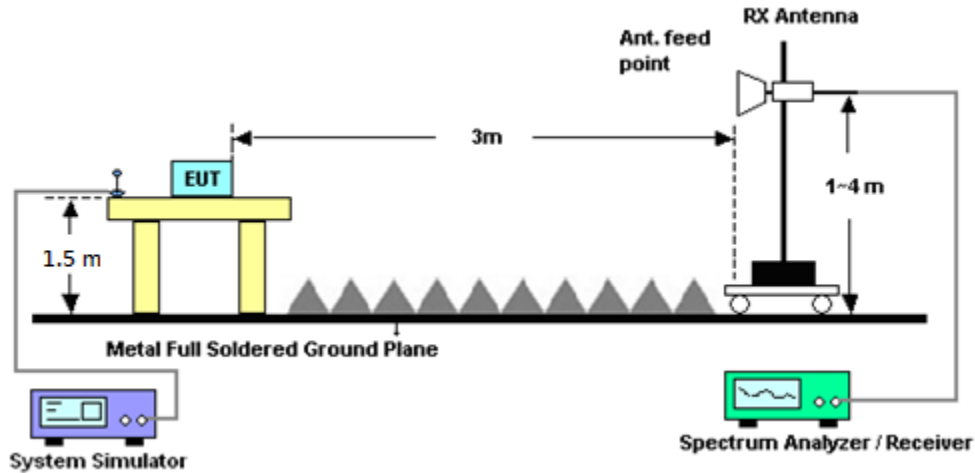
For radiated emissions below 30MHz

### 3.1.2 Test Result of Radiated Test

Please refer to Appendix A.

**Note:**

The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported.

There is a comparison data of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site v01r01, and the result came out very similar.



## 3.2 Radiated Spurious Emission Measurement

### 3.2.1 Description of Radiated Spurious Emission Measurement

The radiated spurious emission was measured by substitution method according to ANSI / TIA-603-E. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least  $43 + 10 \log (P)$  dB.

For LTE Band 41 and 5G NR n7, n41

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least  $55 + 10 \log (P)$  dB.

The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

### 3.2.2 Test Procedures

The testing follows FCC KDB 971168 D01 v03r01 Section 7 and ANSI / TIA-603-E Section 2.2.12.

1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
4. The height of the receiving antenna is varied between one meter and four meters to search the maximum spurious emission for both horizontal and vertical polarizations.
5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, taking the record of maximum spurious emission.
6. A horn antenna was substituted in place of the EUT and was driven by a signal generator.
7. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission.
8. Taking the record of output power at antenna port.
9. Repeat step 7 to step 8 for another polarization.
10. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

The limit line is derived from  $43 + 10\log(P)$ dB below the transmitter power P(Watts)

For LTE Band 7, 41 and 5G NR n7, n41

The limit line is derived from  $55 + 10\log(P)$ dB below the transmitter power P(Watts)

$EIRP \text{ (dBm)} = S.G. \text{ Power} - Tx \text{ Cable Loss} + Tx \text{ Antenna Gain}$

$ERP \text{ (dBm)} = EIRP - 2.15$
