




Photograph of the tissue simulant fluid liquid depth (Body)






















Fig.4 EUT Top side to flat phantom






Fig.5 EUT Bottom side to flat phantom






Fig.7 EUT Left side to flat phantom




Fig.10 Antenna location of EUT (tablet mode)
