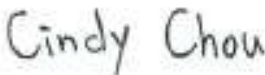
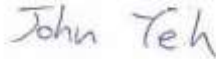

4 TEST SETUP DESCRIPTION

4.1 Measurement System

The conducted power measurement test setup is described in the following and illustrated in Figure 1

- A. The DUT is a RW350R-GL Cellular Modem installed inside HP model HSN-I62C Convertible PC.
- B. The control PC is used to configure the call box to send power control test sequences to the RW350R-GL
- C. Uplink signal power is monitored by the spectrum analyzer and recorded by the PC with a time resolution of 25 msec which is substantially less than the power adjustment interval (Avg_SAR_Check_Period) of 0.05 sec used for RW350R-GL.
- D. The values of Avg_SAR_Power are read from the RW350R-GL by the PC at each Avg_SAR_Check_Period
- E. In addition to power results, the time sequence of power control commands and power samples are also recorded by the PC to enable results to be correlated and plotted. Uplink signal from the RW350R-GL is fed through a 3 dB power splitter, which delivers an equal amount of signal to the spectrum analyser and the call box. The splitter has high isolation between the spectrum analyser and the call box. Due to different uplink/downlink frequencies and the zero span time-domain measurement used, interference of uplink and downlink signals are avoided.
- F. Path loss in the power measurement setup from the RW350R-GL main antenna port to either the call box or the spectrum analyser is taken into account

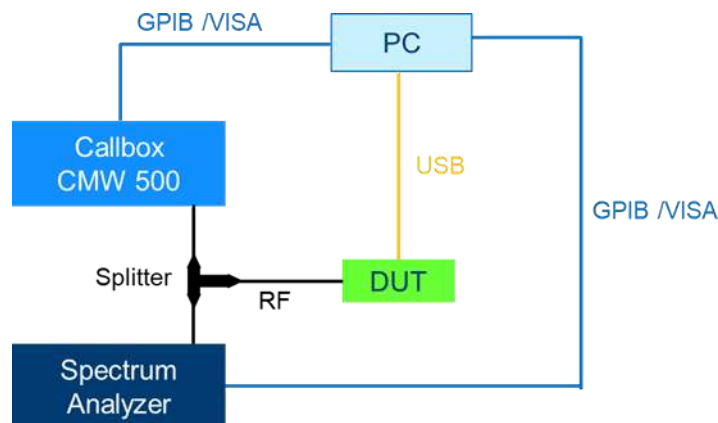


Figure 4-1 - Test Setup
