



#### Photograph of the tissue simulant fluid liquid depth (Body)

















### Photograph of the tissue simulant fluid liquid depth (Body)





### Body - distance between flat phantom and EUT is 0 mm






Fig.3 EUT Back side to flat phantom




Fig.5 EUT (TB mode) Bottom side to flat phantom







Fig.6 EUT Right side to flat phantom






Fig.7 EUT Left side to flat phantom






Fig.8 EUT (NB mode) Bottom side to flat phantom




Fig.12 Antenna location (front view of tablet mode)
