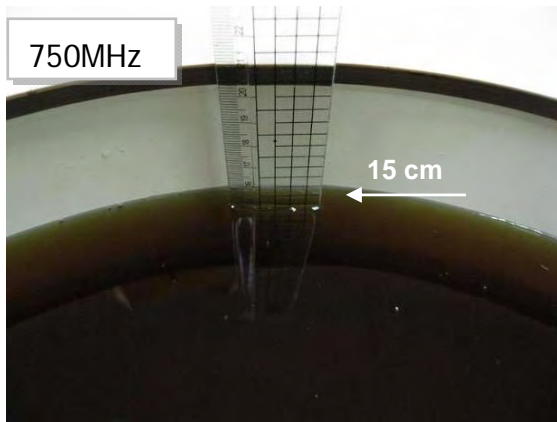

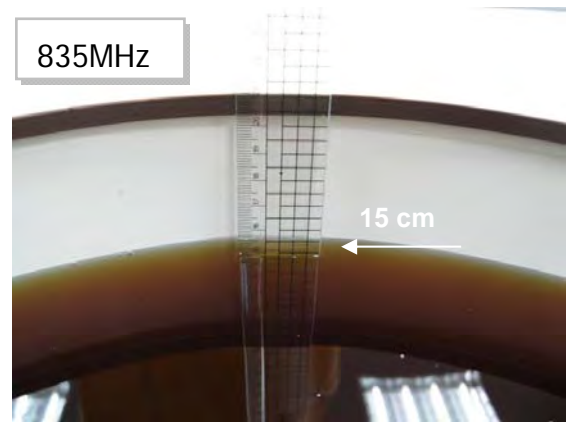

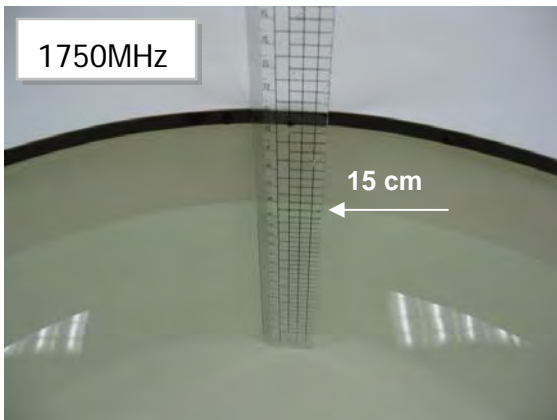

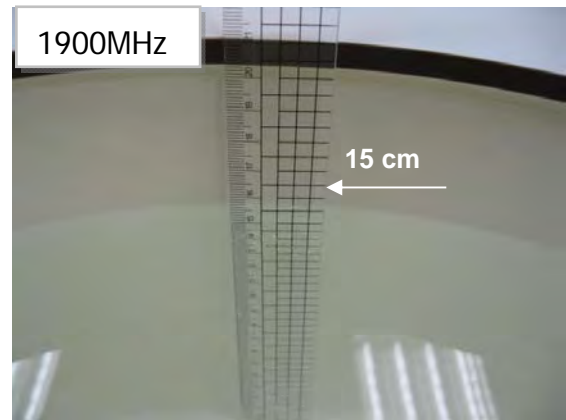

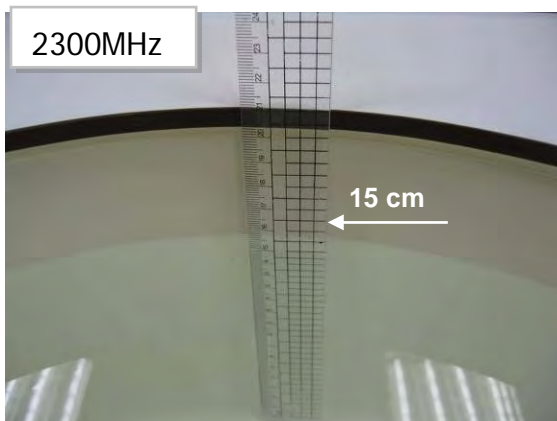

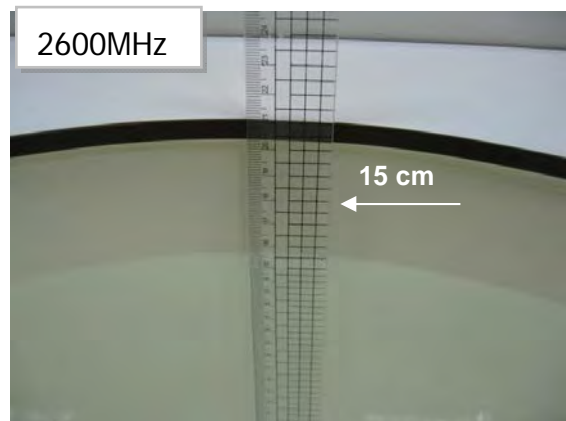

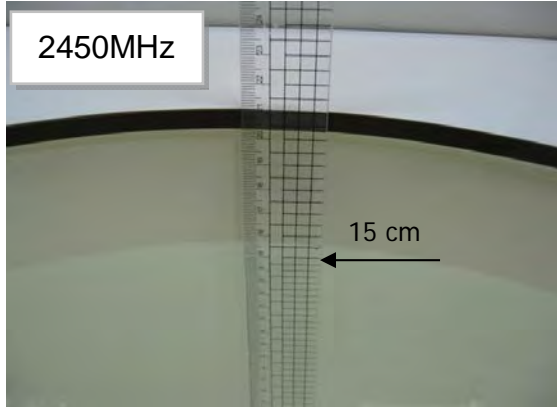

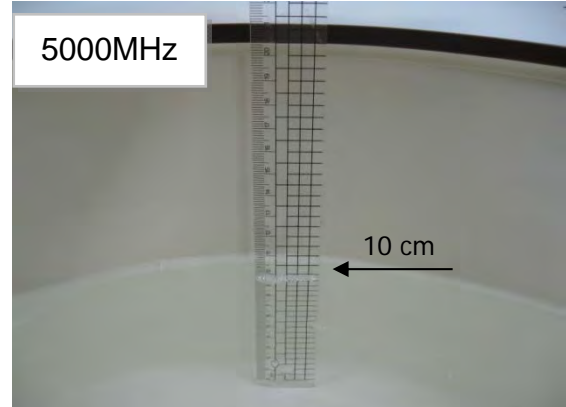

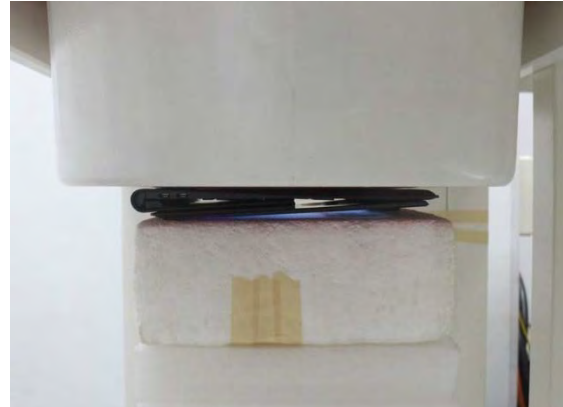
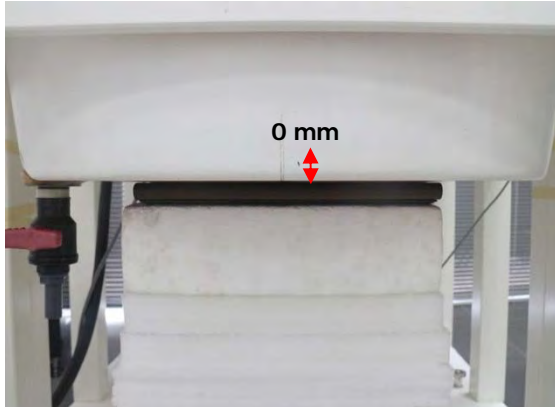


Fig.3 EUT Back side to flat phantom

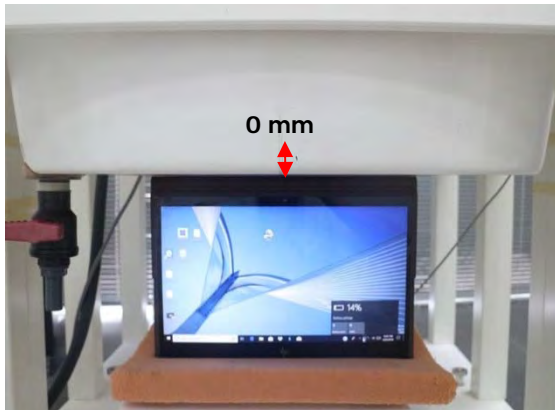


Fig.4 EUT Top side to flat phantom

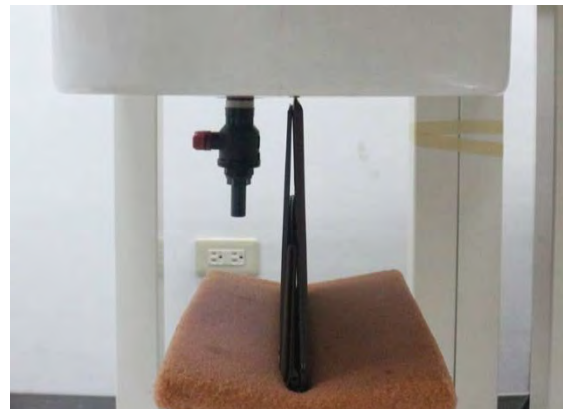
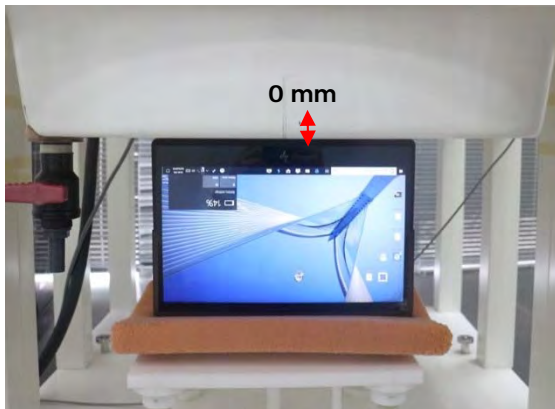


Fig.5 EUT (TB mode) Bottom side to flat phantom

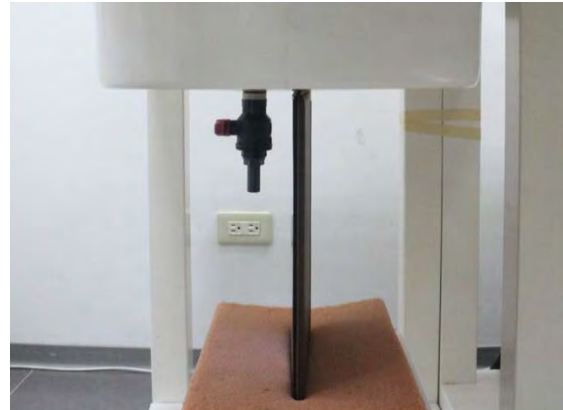
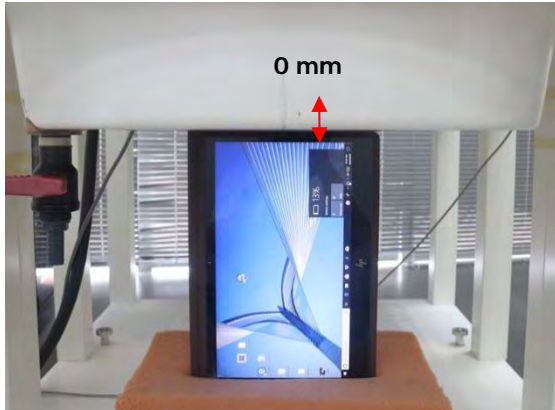


Fig.6 EUT Right side to flat phantom

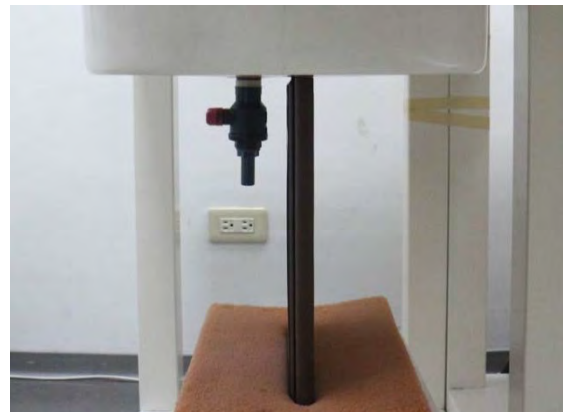
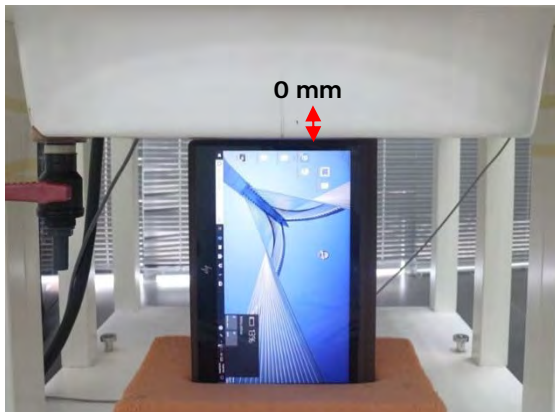


Fig.7 EUT Left side to flat phantom

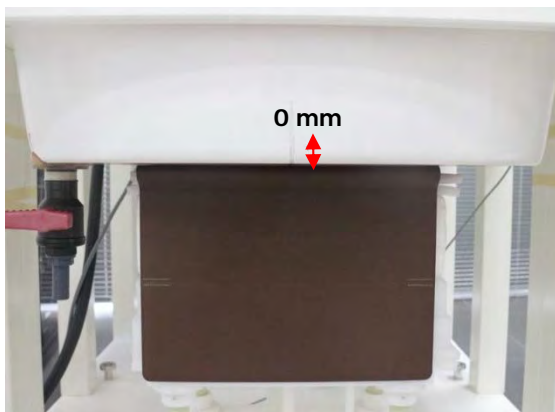


Fig.8 EUT (NB mode) Bottom side to flat phantom

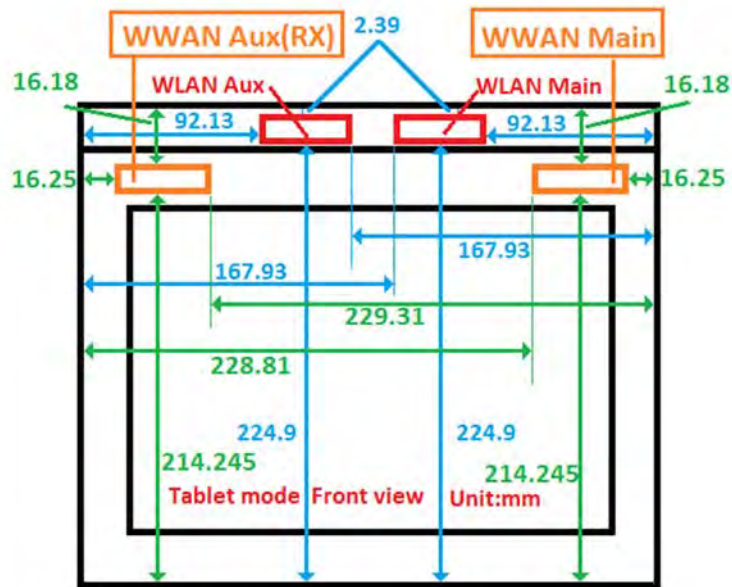


Fig.12 Antenna location (front view of tablet mode)
