Pd = power density in mW/cm², Pout = output power to antenna in mW, G = gain of antenna in linear scale;

Pi = 3.1416, R = distance between observation point and center of the radiator in cm

Consider the BT and wifi can transmitting simultaneously, the total transmitting MPE rate as below formula: MPE rate=Power density of BT/limit + Power density of wifi/limit <1
